**I believe that we have had correspondence regarding the food license application for 1920 W. North Avenue. I am not sure if this has been scheduled, so I am reiterating our opposition, below:**

The City of Milwaukee Code of Ordinances states the following in **68-4-11**:

**"An applicant for a new or renewal food dealer's license may be denied, or any license issued under this section may be suspended or revoked, by the Common Council for any of the following causes:**

- g-1. Disturbance of the peace
- g-3. Public drunkenness
- g-4. Drinking in public
- g-5. Harassment of passers-by

Etc.

Ald. Hines' office has received complaints from residents regarding all four of these categories for the food license application for **1920 W. North Avenue**. For these reasons, we request that a food license hearing be scheduled for this application.
