..Analysis

This resolution confirms the report of the Commissioner of Public Works, as modified by the Common Council Committee, on projects for which Public Hearings have been held. The resolution authorizes the levying of special assessments and directs the installation and construction of said public improvements. The City cost of these projects approved by this resolution is estimated to be \$84,200. The total estimated cost of these projects is \$84,200.

Whereas, The Common Council of the City of Milwaukee adopted preliminary resolutions, determining it necessary and in the public interest to construct and levy special assessments for the following improvements:

1st Aldermanic District

N. 37th St. – W. Hampton Ave. to W. Stark St. (ST211260111) Installing traffic calming speed hump(s). (Assessable Reconstruction Paving Fund -- \$2,715; Nonassessable Reconstruction Paving Fund -- \$4,785). The total estimated cost for this project including the requested amount is \$7,500. This project is anticipated to be completed during the 2026 construction season.

N. 46th St. – W. Hampton Ave. to W. Stark St. (ST211260105) Installing traffic calming speed hump(s). (Assessable Reconstruction Paving Fund -- \$2,910; Nonassessable Reconstruction Paving Fund -- \$4,590). The total estimated cost for this project including the requested amount is \$7,500. This project is anticipated to be completed during the 2026 construction season.

3rd Aldermanic District

E. Kane Pl. – N. Warren Ave. to N. Pulaski St. (ST211260106) Installing traffic calming speed hump(s). (Assessable Reconstruction Paving Fund -- \$3,475; Nonassessable Reconstruction Paving Fund -- \$10,525). The total estimated cost for this project including the requested amount is \$14,000. This project is anticipated to be completed during the 2026 construction season.

N. 81st St. – W. Capitol Dr. to W. Fiebrantz Ave. (ST211260116) Installing traffic calming speed hump(s). (Assessable Reconstruction Paving Fund -- \$3,165; Nonassessable Reconstruction Paving Fund -- \$4,335). The total estimated cost for this project including the requested amount is \$7,500. (Assessable Reconstruction Paving Fund -- \$1,250; Nonassessable Reconstruction Paving Fund -- \$7,750). The total estimated cost for this project including the requested amount is \$9,000. This project is anticipated to be completed during the 2026 construction season.

W. Maple St. – S. 9th to S. 10th St. (ST211260108) Installing traffic calming speed hump(s). (Assessable Reconstruction Paving Fund -- \$1,195; Nonassessable Reconstruction Paving Fund -- \$7,505). The total estimated cost for this project including the requested amount is \$8,700. This project is anticipated to be completed during the 2026 construction season.

S. 1st St. – W. Armour Ave. to W. Norman Ave (ST211260114) Installing traffic calming speed hump(s). (Assessable Reconstruction Paving Fund -- \$1,275; Nonassessable Reconstruction Paving Fund -- \$6,225). The total estimated cost for this project including the requested amount is \$7,500. This project is anticipated to be completed during the 2026 construction season.

14th Aldermanic District

S. 7th St. – W. Euclid Ave. to W. Oklahoma Ave. (ST211260110) Installing traffic calming speed hump(s). (Assessable Reconstruction Paving Fund -- \$2,950; Nonassessable Reconstruction Paving Fund -- \$4,550). The total estimated cost for this project including the requested amount is \$7,500. This project is anticipated to be completed during the 2026 construction season.

S. 7th St. – W. Ohio Ave. to W. Euclid Ave. (ST211260115) Installing traffic calming speed hump(s). (Assessable Reconstruction Paving Fund -- \$3,300; Nonassessable Reconstruction Paving Fund -- \$4,200). The total estimated cost for this project including the requested amount is \$7,500. This project is anticipated to be completed during the 2026 construction season.

Further Resolved, That the proper departments take such action as is required of them to assess the abutting or adjacent properties and collect such assessment in the manner directed by Section 115-42 of the Milwaukee Code of Ordinances; and, be it

Further Resolved, That the City Comptroller is authorized to transfer such funds which are available for this purpose to the appropriate capital Project/Grant accounts; and, be it

Further Resolved, That the projects do not involve any parcels of agricultural land which are eligible for deferred special assessments under the provisions of Section 14.30 of the Milwaukee City Charter; and, be it

Further Resolved, That the Department of Public Works is authorized to use the funding as specified in the above description of work; and, be it

Further Resolved, That projects N. 37th St. (ST211260111), N. 46th St. (ST211260105), E. Kane Pl. ST211260106), N. 81st St. (ST211260116), N. 57th St. (ST211260112), S. 9th St. (ST211260109), W. Maple St. (ST211260108), S. 1st St. (ST211260114), S. 7th St. (ST211260110), S. 7th St. (ST211260115) will be billed after January 1, 2028, but not before 12 months after the project contract has been completed.
