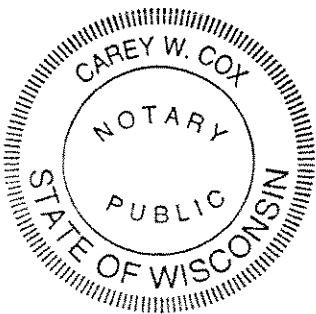

**051570...**Ordinance relating to the change in zoning from a General Planned Development to a Detailed Planned Development known as Kane Commons, Phase 2, on land located on the North Side of East Kane Place and West of North Cambridge Avenue, in the 3rd Aldermanic District.

**051702...**A substitute ordinance relating to penalties for certain violations of ordinances in areas designated for cruising enforcement.

**060017...**Substitute ordinance to further amend the 2006 rates of pay of offices and positions in the City Service under control of the Common Council.

**060035...**Ordinance relating to the Fifth Amendment to the General Planned Development (GPD) known as Milwaukee Metro Center, on land located South of West Good Hope Road between West Fond du Lac Avenue and U.S. Highway 41 and 45, in the 5th Aldermanic District.
