


Dear Alderman D'Amato:

Pursuant to Common Council FN 030083, we are writing to report the payment of fees and costs from the Special Purpose Account. A payment of \$29,000 has been made to the law firm of Perry, Shapiro, Quindel, Sak, Charlton, Sumara & Lerner, consisting of \$3,000 for expert witness fees and \$26,000 in attorney fees.

The payment is in consideration of resolving legal objections and claims raised by the League of Martin in connection with the background investigation process, that was part of the on-going validation of selection procedures for entry level police officers and police aides in U.S.D.C. Case No. 74 C 480.
