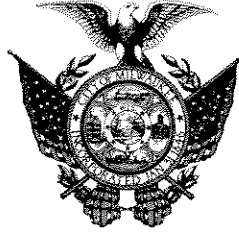


Dear Commissioner Foldy:

There have been increasing nuisance and alleged criminal activities in the area associated with the food vendor operations currently in the immediate vicinity of the aforementioned address. These activities and others, including but not limited to, loitering, have had an adverse impact on the quality of life for area residents. The potential for this quality of life to be further compromised by the granting of a "Food Dealer" license to 1801 W. Galena prior to a U&L hearing is substantial.


