On Saturday November 09, 2019 I was assigned to work the Wisconsin WINS Youth Tobacco Initiative, which checks area vendors for age compliance tobacco purchases. Assisting in this assignment was Tamesha A ROBERSON (b/f, 04/21/2002). ROBERSON is 17 years old and is not of legal age to purchase tobacco.

At approximately 9:55am ROBERSON entered the Tenley Auto Center at 9208 W. Capitol Dr. She was able to purchase a Black and Mild cigar from the cashier for \$1.00. ROBERSON stated the clerk did not ask for an ID. I entered the store and the described cashier was identified as Tranea JOHNNIE (b/f, 09/02/1996). JOHNNIE stated she didn't realize ROBERSON was so young. I spoke with the agent, Steven TENLEY who was on scene, I advised him he would be receiving a citation for Sale of Cigarette to Minor/Underage.

This report is written by Police Officer Zachary CVETAN, assigned to Late Power Shift at District 7.

On Saturday, June 6th, 2020, Squad 7469 (P.O. Steven MENGE and I) was dispatched at approximately 10:40 PM to the address of 9208 W Capitol Dr., a BP gas station, which is located in the City and County of Milwaukee, Wisconsin to investigate an armed robbery complaint.

I was operating a fully marked Milwaukee Police squad. This vehicle is equipped with emergency lights and sirens. I was also wearing a full Milwaukee Police uniform with a badge affixed to the outer most layers. I was affixed with a recording and functioning body camera.

We arrived on scene and made contact with the victim/caller, identified as Elizabeth J SPREWELL (b/f, 06/18/2002) who stated she was robbed by an ex-boyfriend. SPREWELL stated she agreed to meet with a friend at the BP gas station to exchange some house keys. SPREWELL stated she parked in front of one of the gas pumps and observed her friend pull into the BP gas station. SPREWELL stated in the vehicle with her friend was the suspect, Kayshawn A WONDERLY (b/m, 01/30/2002), who she didn't know was coming.

SPREWELL stated WONDERLY approached the driver's side window, reached in and tried to pull the keys from the ignition. SPREWELL stated an argument ensued before WONDERLY walked back to his vehicle. SPREWELL stated WONDERLY reached into his car and retrieved a black in color unknown type of firearm and re approached her car. SPREWELL stated she rolled up the window to prevent WONDERLY from reaching into the passenger compartment again. SPREWELL stated WONDERLY used the butt of the firearm to break out the driver side window. SPREWELL stated WONDERLY reached in and grabbed the keys from her hand before getting into his vehicle and fleeing the scene.

ADDITIONAL INFORMATION:

On Wednesday, June 17th 2020 I conducted follow up at 9208 W Capitol Dr., the BP Gas Station, in attempt to retrieve surveillance video of the incident. It was at the time I made the notification to Steven R TENLEY (w/m, 01/11/1956) regarding the armed robbery (See supplemental regarding Cad #201692432.)

This case was filed and sent down to District Attorney's office for review. At the time of writing this report no charges have been filed.

This concludes my report.



The above application has been made by the above named applicant(s). This requires approval from the Licenses Committee and the Common Council of the City of Milwaukee. The hearing before the Licenses Committee will take place virtually on 1/5/2021 at 9:20 AM. This is a public hearing. Those wishing to view the proceeding are able to do so via the City Channel – Channel 25 on Spectrum Cable – or on the Internet at http://city.milwaukee.gov/citychannel. Those wishing to provide oral testimony will be asked to do so by phone or internet and are asked to contact the staff assistant, Molly Kuether-Steele at (414) 286-2775 or molly.kuether-steele@milwaukee.gov for necessary information. Please make such requests no later than one business day prior to the start of the meeting. You are not required to attend the hearing, but please see the information below if you would like to provide testimony. Once the Licenses Committee makes its recommendation, this recommendation is forwarded to the full Common Council for approval at its next regularly scheduled hearing.

Important details for those wishing to provide information for the Licenses Committee to consider when making its recommendation:

- 1. The license application is scheduled to be heard at the above time. Due to other hearings running longer than scheduled, you may have to wait some time to provide your testimony.
- 2. You must testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)
- No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are willing to testify).
- Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.
- 5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)

- 6. You may then provide testimony.
- a. Include only information relating to the above license application.
- b. Include only information you have personally witnessed or seen.
- c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.
- d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.
- 7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.
- 8. Business Competition is not a valid basis for denial or non-renewal of a license.

Please Note: If you have submitted an objection to the above application your objection cannot be considered by the committee unless you personally testify at the hearing.
