**JURISDICTIONAL TRANSFER AGREEMENT**

**BETWEEN**

**THE WISCONSIN DEPARTMENT OF TRANSPORTATION**

**AND**

**MILWAUKEE COUNTY**

**AND**

**CITY OF MILWAUKEE**

This agreement, made and entered into by and between the Wisconsin Department of Transportation, hereinafter called the State, and Milwaukee County, hereinafter called the County, and the City of Milwaukee, hereinafter called the City, provides for the transfer of the jurisdictional responsibility for the segment of roadway known as the Park East Freeway (STH 145) between North 6<sup>th</sup> Street and North Jefferson Street.

**Whereas**, the "Letter of Agreement on the Allocation of ICE Dollars and on Milwaukee Transportation Projects" (see

of government, thereby facilitating such alterations in jurisdictional highway systems.

**Now Therefore**, the parties hereto do mutually agree to transfer the jurisdictional responsibility for the highway described below under the conditions described below.

**ROUTE DESCRIPTION FOR STH SEGMENT:**

Beginning at a point on the officially laid out, marked and traveled State Trunk Highway System designated Highway 145 at the westerly limits of its intersection with North 6<sup>th</sup> Street; then, proceeding easterly, a distance of approximately 0.70 miles, to its intersection with North Jefferson Street, lying in Sections 20 and 21, Township 7 North, Range 22 East, City of Milwaukee, Milwaukee County.

**CONDITIONS OF TRANSFER**

- I. The County, in cooperation with the City and the State, will be the lead agency in the environmental and public processes that will precede any actual removal of the facility.

VII. The highways and streets covered by this jurisdictional transfer agreement are subject to specific "project agreements" that detail the funding and federal/state requirements.

VIII. The desire and importance of completing these projects is understood. Accordingly, all parties to this agreement will place high priority on completing this work by the Spring of 2004.

### **RESPONSIBILITIES**

#### **I. The State shall:**

- A. Prepare engineering plans, specifications, and estimates for the removal of the elevated freeway east of North 6<sup>th</sup> Street and designing the reconnection to the local street

for public transportation right of way to the City.

**II. The County shall:**

- A. Assist the State in accomplishing IC
- B. Convey its interest in the property shown on exhibit 'B' that is to be retained for public transportation facility right of way to the State.

**III. The City shall:**

- A. Prepare engineering plans, specifications and estimates for the replacement facilities to the local street system and river crossing.
- B. Construct replacement facilities to the local street system and river crossing.
- C. Work with the State in accomplishing item IA of Responsibilities above.
- D. Accept jurisdiction of rights of way that are dedicated
