Per MCO 85-4-4, unless otherwise specified in the code, probative evidence concerning non-renewal, suspension or revocation may include evidence of the following: failure of the applicant to meet municipal qualifications, pending charges against or the conviction of any felony, misdemeanor, municipal offense or other offense, the circumstances of which substantially relate to the circumstances of the particular licensed or permitted activity, by the applicant or by any employee or other agent of the applicant. If the activities of the applicant involve a licensed premises, whether the premises tends to facilitate a public or private nuisance or has been the source of congregations of persons which have resulted in any of the following: disturbance of the peace; illegal drug activity; public drunkenness; drinking in public; harassment of passers-by; gambling; prostitution; sale of stolen goods; public urination; theft; assaults; battery; acts of vandalism including graffiti, excessive littering, loitering, illegal parking, loud noise at times when the licensed premise is open for business; traffic violations; curfew violations; lewd conduct; display of materials harmful to minors, pursuant to s. 106-9.6; or any other factor which reasonably relates to the public health, safety and welfare, or failure to comply with the approved plan of operation. This report is written by Police Officer Penny Monreal, assigned to the License Investigation Unit, Days.

The Milwaukee Police Department's investigation regarding this application revealed the following:

1. On 04/04/25 at 7:13a.m., Milwaukee Police were dispatched to a Sexual Assault. Investigation revealed the incident did not take place at the location. The business was cooperative.
2. On 05/14/25 at 8:21a.m., Milwaukee Police were dispatched to a Battery, which later was determined to be a Theft at 2431 S. Chase Ave. Investigation revealed a suspect has been stealing from the location and selling the stolen items to another subject. The suspect took officers to the location of 2326 S. 12<sup>th</sup> St. It was determined this is the residence of the Agent for the business located at 1207 W. Lincoln Ave. Initially the Agent denied buying stolen items, however, later admitted to it, stating they are often vagrants and if the sale is denied the subjects become aggressive. The Agent further complained about slow police response times, forcing them to buy the stolen merchandise. The Agent was advised further participation in this criminal activity would result in charges.

On Friday, April 4th, 2025, I was dispatched to the address of 1207 W Lincoln Ave (El Ya Llegaras), which is located in the City and the County of Milwaukee, for a sexual assault investigation.

After speaking with the victim, identified as Emma GONZALEZ-GODOS (F/W 4-18-1978), it was determined the incident **DID NOT OCCUR AT THE LICENSED PREMISE**. See P.O. KIBLER's report regarding.

This report is written by PO Matthew DIENER, assigned to District 2, day shift, squad 2166. On Wednesday, May 14, 2025, at about 8:21am, squad 2120 (HEDER), was dispatched to Petro Mart at 2431 S Chase Av for a Battery complaint. Upon arrival he spoke with the cashier/staff member of the Petro Mart, Ehah MOHANY (w/m, 11-8-90), who stated that on 5/13/25 a thief, later identified as Steven LUCKETT-COBB (b/m, 9-25-88), entered the store and stole about \$100 of air freshers and ran out.

MOHANY stated that COBB attempted to enter the store again, when they grabbed him, and detained him until the police arrived. MOHANY stated that he is willing to not press charges if COBB shows the officers where he is selling the stolen items. COBB then drives with the officers to the address of 2326 S 12th St, and tells HEDER that most of the local Lincoln Av vagrants sell their stolen items there. COBB stated that if the back door of 2326 S 12th St is open, he knows he can knock on the screen door, and he's able to sell his stolen items. COBB said if the door is closed, he will have to return later.

I checked the property records for 2326 S 12th St and found the listed owner as Ignacio G MADRIGAL-VILLAGOMEZ (5-30-78), and that he is also the owner and licensee of Ya Llegaras Restaurant, located at 1207 W Lincoln Av. Officer HEDER and I then responded to 1207 W Lincoln Av to speak with VILLAGOMEZ. We located VILLAGOMEZ, who agreed to speak with us at District 2 with a Spanish interpreter. Once back at District 2 we spoke with VILLAGOMEZ, with PO MUNIZ translating.

We explained to VILLAGOMEZ the circumstances of the thief identifying his home as a safe place to sell stolen items in exchange for money. VILLAGOMEZ initially denied this happening, and said that he does not engage in buying stolen items off the street. VILLAGOMEZ then said "I'll come clean and be honest with you". He stated that there are a lot of vagrants and addicts along Lincoln Av, and that they will often come to his store to sell stolen items. He stated that he if says "no", they become aggressive with him and "force" him to buy the stolen merchandise. VILLAGOMEZ then attempted to deflect the topic his criminal acts onto blaming police for "slow response" times, and if it wasn't because those "slow response times" he wouldn't be "forced" to buy the stolen merchandise.

I advised him that his actions are contributing to criminality in the neighborhood and directly affecting other businesses. I advised him that it is illegal to purchase stolen items and that it could affect his license. I told VILLAGOMEZ it's no excuse to be purchasing these stolen items. I advised VILLAGOMEZ that he continues to engage in this practice he could be subject to criminal charges. I provided him with

Please make such requests no later than one business day prior to the start of the meeting. You are not required to attend the hearing, but please see the information below if you would like to provide testimony. Once the Licenses Committee makes its recommendation, this recommendation is forwarded to the full Common Council for approval at its next regularly scheduled hearing.

## **Important details for those wishing to provide information for the Licenses Committee to consider when making its recommendation:**

1. The license application is scheduled to be heard at the above time. Due to other hearings running longer than scheduled, you may have to wait some time to provide your testimony.
2. You must appear in person and testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)
3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are present at the committee hearing and willing to testify).
4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.
5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)
6. You may then provide testimony.
  - a. Include only information relating to the above license application.
  - b. Include only information you have personally witnessed or seen.
  - c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.
  - d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.
7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.
8. Business Competition is not a valid basis for denial or non-renewal of a license.  
**Please Note: If you have submitted an objection to the above application your objection cannot be considered by the committee unless you personally testify at the hearing.**

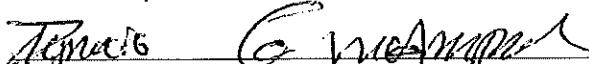
