SUBJECT: Updated Information on State and Local Fiscal Recovery Funds Under ARPA

On March 11, 2021, President Biden signed into law the American Rescue Plan Act (ARPA) of 2021. ARPA included the creation of both the State Fiscal Recovery Fund (SFRF) and the Local Fiscal Recovery Fund (LFRF), which will distribute funds directly to state and local governments. This memorandum provides updated information on the level of funds received by the state of Wisconsin and by local units of government in Wisconsin, as well as updated information of the planned uses of the SFRF monies. Original estimates of state and local ARPA funding were included in a March 23, 2021, memorandum from this office.

### **Amounts Received From the Fiscal Recovery Funds**

*State Fiscal Recovery Fund.* ARPA allocated a total of \$219.8 billion to the SFRF, to be divided among states, territories, and tribal governments. Of this amount, \$24.5 billion is allocated to tribal governments (\$20.0 billion) and territories (\$4.5 billion). The remaining \$195.3 billion was divided among the 50 states and the District of Columbia, with \$25.5 billion equally divided (\$500 million each) among the 50 states and the District of Columbia and \$754.9 million allocated as an additional payment to the District of Columbia. The remaining \$169.0 billion was divided among the 50 states and the District of Columbia

"...in an amount which bears the same proportion to such remainder as the average estimated number of seasonally-adjusted unemployed individuals (as measured by the Bureau of Labor Statistics Local Area Unemployment Statistics program) in the State or District of Columbia over the 3-month period ending with December 2020 bears to the average estimated number of seasonally adjusted unemployed individuals in all of the 50 States and the District of Columbia over the same period."

To implement this provision, the U.S. Treasury Department used Local Area Unemployment Statistics (LAUS) data from the Bureau of Labor Statistics (BLS). Treasury was also required to make pro rata adjustments to the final allocations, pursuant to the requirement in ARPA that no state

or the District of Columbia would receive less from the SFRF than it did from the Coronavirus Relief Fund established under the CARES Act. Based on the LAUS data, Wisconsin will receive approximately \$2,033.2 million in SFRF funding based on its share of seasonally-adjusted unemployed individuals. Along with the \$500 million equal share payment, the state will receive a total of \$2,533.2 million from the SFRF. Wisconsin's total SFRF allocation declined compared to earlier estimates due to the state's seasonally adjusted unemployed individuals making up a smaller share of the national total of those individuals compared to earlier estimates.

In order to receive its SFRF allocation, the state was required to submit a certification to the Department of Treasury that the funds were required and that the state would use the funds in accordance with the provisions of the Act. Treasury has indicated that it will provide payments from the SFRF in two equal payments to all states, unless the state's unemployment rate is greater than 2.0% above its pre-pandemic level at the time of the certification. Wisconsin therefore received half of its SFRF allocation in May, 2021, and will receive the remainder in 2022. If Treasury determines that any funds are subject to recoupment in 2022, due to improper use of the funds, the state's 2022 payment will be reduced by the amount that is subject to recoupment.

*Local Fiscal Recovery Fund.* ARPA allocated a total of \$130.2 billion for the LFRF to make payments to local units of government. The allocation of these funds varies according to the type of local government receiving the funds. In total, local governments in Wisconsin will receive approximately \$2,322.8 million from the LFRF. Similar to the treatment of the state's allocation, local governments will receive half of their LFRF allocations in 2021 and the remaining half in 2022.

Counties. \$65.1 billion is to be paid directly to counties across all states, according to the proportion of each county's population to the total population of all counties. Counties in Wisconsin will receive a combined total of \$1,130.9 million from the LFRF (Attachment 1). The Department of Treasury is responsible for distributing payments to counties. In order to receive funds, counties must submit a certification to Treasury that the funds are required and that the county would use the funds in accordance with the provisions of the Act. Treasury is required to distribute funds within 60 days of receiving this certification.

Metropolitan Cities. \$45.6 billion is to be distributed to metropolitan cities, as defined by the U.S. Department of Housing and Urban Development (HUD) for the purposes of administering the Community Development Block Grant (CDBG) program. LFRF monies will be distributed by applying the CDBG entitlement formula, after substituting "metropolitan areas" with "metropolitan cities" under that formula. The formula takes into account factors such as population growth, poverty, housing overcrowding, and the age of housing. Wisconsin has 20 cities and one village which have been designated as "metropolitan cities" for the purposes of the LFRF. These municipalities will receive a total of \$780.3 million from the LFRF (Attachment 2). Similar to the treatment for counties, the Department of Treasury is also responsible for distributing payments to metropolitan cities. Metropolitan cities were also required to submit a certification to Treasury that the funds were required and would be used in accordance with the provisions of the Act. Treasury is required to distribute funds within 60 days of receiving this certification.

Non-entitlement Units of Government. \$19.5 billion is to be distributed to non-entitlement

units of local government (NEUs), as defined by HUD for the purposes of administering the CDBG program. Payments to NEUs are based on population, and are capped at 75% of the government's most recently enacted budget as of January 27, 2020. Wisconsin NEUs will receive a total of approximately \$411.6 million from the LFRF (Attachment 3). The Wisconsin Department of Revenue (DOR) is responsible for distributing LFRF payments to NEUs, and was required to do so within 30 days of receiving funds for this purpose from the Treasury Department. Treasury indicates that it initiated a transfer of these funds on May 28, 2021.

On July 13, 2021, DOR indicated that all but 23 of the 1,830 NEUs in Wisconsin had submitted the required information and received the first half of their LFRF allocation. DOR further indicated that it is continuing to work with the remaining NEUs to ensure that they receive the funds to which they are entitled. The Department of Treasury has granted DOR a 30-day extension of the deadline for the distribution of funds to these municipalities, and may grant an additional 30-day extension if necessary. Any LFRF monies that are not distributed to municipalities within 120 days of receipt of the funds must be returned to the Treasury. NEUs may choose to either decline their LFRF allocation or transfer it to the state. If an NEU declines its LFRF allocation, or if the allocation is reduced in order to comply with the 75% budget cap, Treasury indicates that DOR may redistribute the remaining amounts among other NEUs, so long as the 75% budget cap is not exceeded.

The following table compares the original estimates of SFRF and LFRF monies to be received by the state with the updated amounts. In addition, an updated amount that each unit of local government is expected to receive in LFRF monies is provided in the attachment to this memorandum.

**Planned Uses of the SFRF Allocation**

The U.S. Department of Treasury released updated guidance on the allowable uses of funds received from the SFRF on May 10, 2021. Subsequently, the Governor's office began announcing a series of initiatives that would be funded from the SFRF monies received by the state. As of July 15, 2021, approximately \$892.6 million of the state's SFRF payment has been allocated, including funds

used to supplant an earlier allocation of federal Coronavirus Relief Fund (CRF) monies. The following table lists the intended uses of these funds.

*WI Tomorrow Small Business Recovery Grant Program.* \$420.0 million has been allocated to provide grants to eligible small businesses in Wisconsin. DOR indicates that it expects the program will support up to 84,000 businesses with gross annual revenue between \$10,000 and \$7,000,000, including those that started in 2020. In order to qualify, at least 75% of the business' value of real and tangible personal property owned or rented and used by the business must be located in Wisconsin. Further, at least 75% of the amount of the business' labor costs must be incurred by individuals performing services for the business in Wisconsin. The following industries are ineligible for this program: crop production; animal production or aquaculture; lessors of real estate; and nonprofit organizations. The application period opened on May 24, 2021, and closed on June 7, 2021. DOR expects to provide \$5,000 to each eligible applicant. Payments began to be distributed on June 30, 2021, and DOR indicates that payments will continue to be distributed into August. Grant monies may be used for business operating costs, including but not limited to wages and salaries, rent, mortgages, and inventory, and/or for health and safety improvements.

*Broadband Expansion Grants.* The Public Service Commission (PSC) has opened a grant round for allocation of \$100,000,000 in SFRF funding for broadband expansion grants, with applications due July 27, 2021. In order to qualify for funding, projects must serve households that

lack access to a wireline connection that reliably delivers at least 25 megabits per second (Mbps) download speed and 3 Mbps upload speed ("25/3"). Completed projects must provide service of at least 100/100, or if symmetrical service is not practicable, a project may provide service of 100/20 if it is scalable to 100/100 in the future. Under PSC's grant criteria and federal requirements, funding will be allocated based on the following priority criteria: (a) offered matching funds; (b) use of optical fiber infrastructure; (c) construction of last-mile connections; (d) projects owned, operated, or affiliated with local governments, nonprofits, or cooperatives; (e) implementation of affordability options; (f) construction in areas lacking plans to build service by December 31, 2024; (g) service to areas with the least access and highest need; (h) support of households facing negative economic impacts from COVID-19; and (i) operational, technical, planning, and financial capacity to implement a project.

*Tourism and Entertainment Industries Support.* \$142.6 million has been allocated to provide supports to the tourism and entertainment industry. Of this amount, \$75.0 million will be distributed as lodging grants. DOR has identified eligible lodging facilities, based on its records, and has indicated that eligible applicants will be contacted beginning on July 12, 2021. The deadline for applicants to respond to DOR's initial contact is July 28, 2021, and DOR will begin to distribute grants in August. The amount of the grants will be based on a percentage of decreased sales from 2019 to 2020, with the maximum allowable grant set at \$2.0 million. Lodging providers that also receive a grant through the Wisconsin tomorrow small business recovery grant program will have their lodging grant reduced by \$5,000.

In addition, \$15.0 million will be distributed to destination marketing organizations, \$12.0 million will be distributed to live event small businesses, \$11.3 million will be distributed to movie theaters, \$10.0 million will be distributed to live entertainment venues, \$8.0 million will be distributed to summer camps, \$7.5 million has been allocated to increase marketing support for the state's tourism industry, \$2.8 million will be distributed to minor league sports teams, and \$1.0 will be provided to the Wisconsin Historical Society, to assist in reopening historical sites.

*Workforce Development.* A total of \$130.0 million has been allocated for workforce development grants. \$100.0 million of this amount will be used to provide workforce innovation grants, which will provide grants of up to \$10.0 million to at least 10 local and regional collaborations which develop proposals for post-pandemic workforce solutions. The program will seek to fund initiatives to help connect businesses and workers. Funds received from these grants may be used to meet local workforce needs resulting from or exacerbated by the pandemic, such as childcare, transit, worker attraction and retention, or housing. Additionally, funds may be used to support initiatives such as training, planning, marketing, or developing pilot programs that may be applied in other communities.

A further \$20.0 million will be used for the worker advancement initiative, which will offer subsidized employment and skills training with local employers to individuals whose previous employment has not come back post-pandemic, as well as other workers looking to transition to new employment. The Department of Workforce Development will administer this program through local workforce development boards in partnership with community-based organizations.

Finally, \$10.0 million will be used to create a worker connection program to help individuals prepare for and enter jobs in high-growth employment sectors by pairing them with career coaches, who will provide information and support needed to overcome barriers that prevent full labor force participation. The program will also offer individuals local training opportunities designed to meet employer needs. Two regions of the state will be selected for the program.

*Reallocation of CRF Monies.* In his message of the 2021-23 budget (2021 Act 58), the Governor announced that he would invest "more than \$100 million in federal funds into our kids and our public schools." According to the administration, \$100.0 million of the state's SFRF allocation has been transferred to cover costs previously covered by the CRF allocation received by the state in April, 2020. This allocation is being made to free up an equivalent amount of CRF funding in order to make \$100.0 million in CRF funding available for school districts in the state. However, the actual CRF allocations that will now be funded with SFRF monies are not known at this time. In addition, the administration has not yet indicated how these funds will be distributed to school districts.

Treasury guidance indicates that CRF monies may be transferred to school districts, and that school districts may use these funds to cover costs associated with either providing distance learning or re-opening in-person facilities. Treasury indicates that as an administrative convenience, expenses of up to \$500 per pupil will be presumed to be eligible expenditures. As a result, school districts will not be required to document the specific uses of funds up to that amount. On a statewide basis, \$500 per pupil would total an estimated \$410.0 million in 2021-22.
