There is a possibility that your application may be denied for one or more of the following reasons: The recommendation of the committee regarding the application shall be based on evidence presented at the hearing. Per MCO 85-4-4, unless otherwise specified in the code, probative evidence concerning non-renewal, suspension or revocation may include evidence of the following: failure of the applicant to meet municipal qualifications, pending charges against or the conviction of any felony, misdemeanor, municipal offense or other offense, the circumstances of which substantially relate to the circumstances of the particular licensed or permitted activity, by the applicant or by any employee or other agent of the applicant. If the activities of the applicant involve a licensed premises, whether the premises tends to facilitate a public or private nuisance or has been the source of congregations of persons which have resulted in any of the following: disturbance of the peace; illegal drug activity; public drunkenness; drinking in public; harassment of passers-by; gambling; prostitution; sale of stolen goods; public urination; theft; assaults; battery; acts of vandalism including graffiti, excessive littering, loitering, illegal parking, loud noise at times when the licensed premise is open for business; traffic violations; curfew violations; lewd conduct; display of materials harmful to minors, pursuant to s. 106-9.6; or any other factor which reasonably relates to the public health, safety and welfare, or failure to comply with the approved plan of operation. It is the intention of the Common Council to suspend or non-renew the licenses if objectors provide testimony related to the factors enumerated in MCO 85-4-4 that the Common Council finds to be true by a preponderance of the evidence and/or police reports are found to be true by a preponderance of the evidence. The police reports and other attached documents relating to objections to the license are a part of this notice and expressly incorporated in this notice. The licensee should be prepared to address these matters at the hearing.

Proof of warrant satisfaction or payment of fines must be submitted at the hearing on the above date and time. Failure to comply with this requirement may result in a delay of the granting/denial of your application.

Failure to appear at this meeting may result in the denial of your license. Individual applicants must appear only in person or by an attorney. Corporate or Limited Liability applicants must appear only by the agent designated on the application or by an attorney. Partnership applicants must appear by a partner listed on the application or by an attorney. If you wish to do so and at your own expense, you may be accompanied by an attorney of your choosing to represent you at this hearing.

You will be given an opportunity to speak on behalf of the application and to respond and challenge any charges or reasons given for the denial. No petitions can be accepted by the committee, unless the people who signed the petition are present at the committee hearing and willing to testify. You may present witnesses under oath and you may also confront and cross-examine opposing witnesses under oath. If you have difficulty with the English language, you should bring an interpreter with you, at your expense, so that you can answer questions and participate in your hearing.

You may examine the application file at this office during regular business hours prior to the hearing date. Inquiries regarding this matter may be directed to the person whose signature appears below.

The Milwaukee Police Department's investigation regarding this application revealed the following:

1. On 03/22/23 at 9:00p.m., Milwaukee Police were on patrol, when they observed several vehicles in the parking lot of 3500 N. Port. The officers entered the business and observed subjects inside the store completing purchases. The officer made note the last transaction was conducted at 9:01p.m. The officer spoke to the clerk and advised them the last customer needs to be out of the store before 9:00p.m. The clerk was cooperative and receptive to the officers.
2. On 07/05/23 at 1:24p.m., Milwaukee Police were dispatched to a Trouble with Subject at 3500 N. Port Washington Rd. The employee/caller stated a subject was loitering and causing a disturbance inside the business, however, left prior to police arrival. The employee was cooperative with the police.
3. On 07/19/23 at 2:52p.m., Milwaukee Police conducted a License Premise Check along with an agent from the Department of Revenue Alcohol and Tobacco, at 3500 N. Port Washington Rd. The agent arrived on scene and was cooperative with the investigation. Both the interior and exterior of the location were clean and no violations were found.

The following items are related to the business at 3500 N Port Washington

4. On 11/30/24 at 12:48p.m., Milwaukee Police were dispatched to a Shooting at 330 W. Keefe Ave. Officers were advised the shooting occurred in the area of 3500 N Port Washington. Investigation revealed the victim left the store and was headed east when the shooting occurred. Several casings were recovered southeast of the business. Officers spoke to the employees who stated they did not hear or see any gunfire. The employees allowed officers to view video surveillance.
5. On 01/25/25 at 7:54p.m., Milwaukee Police conducted a License Premise Check. No violations were found.
6. On 02/03/25 at 7:30p.m., Milwaukee Police were dispatched to a Reckless Endangering Safety Call. Investigation revealed a suspect pointed a firearm at the cashier after the cashier requested the suspect put an item back. The business was cooperative with the investigation and allowed officers to view video surveillance of the incident.
7. On 02/16/25 at 5:17p.m., Milwaukee Police were dispatched to a Trouble with Subject. The business was the caller and wanted a subject causing a disturbance to leave, to which they complied on officer's request.

This report is written by PO Matthew ROSEN, assigned to District #5, Early Power Shift, Squad 5261 (Traffic Car)..

On Wednesday, November 27, 2024 at approximately 11:49 AM, PO Brian HOLMES and I were dispatched to a Shooting Complaint at 330 W. Keefe Ave., which is located in the City and County of Milwaukee, WI.

Upon our arrival, our original information on the incident was that the Shooting occurred in the area of 3500 N. Port Washington Rd. (Corner Liquor 1). PO HOLMES and I briefly spoke to clientele and the a store worker. They all stated that they did not hear any gunfire or have knowledge of anyone getting shot. PO HOLMES and I checked the area in and around the store for evidence of the incident but we were unable to locate any. Updated information was broadcasted that the Shooting occurred further east of the store but that the victim of the incident was coming from the store. Officers located several fired cartridge casings southeast of the store and also directly south of the store on the sidewalk on the opposite side of W. Keefe Ave.

I reviewed video surveillance footage. The footage showed several smaller statured M/B individuals (juveniles) running westbound on the southern sidewalk of W. Keefe Ave. at approximately 12:47 PM on 11/27/2024. The individuals can be seen looking back east and continuing to run west across the intersection of W. Keefe Ave./N. Port Washington Rd. We also observed the victim in the store and purchase items at approximately 12:44 PM, leaving the store and headed eastbound on the northern sidewalk of W. Keefe Ave. The video was recovered and inventoried/uploaded to AXON by a MPD Forensic Investigator. The store clerk was extremely patient and cooperative with officers during our investigation. He was not super familiar with the surveillance system but he contacted a store representative that gave him the information that we needed to access the footage.

While on scene, I observed the licenses posted and they were up to date. During my investigation for the Shooting Complaint, I did not observe any violations in the licensed premise.

I asked SINGH if this location was open 7 days a week and SINGH stated yes. I asked SINGH what the hours of operation are:

- *Tuesday: 8:00 AM - 9:00 PM*

I also were able to verify the hours of operation through the City of Milwaukee License Search website.

I asked SINGH if there is security employed at this location and SINGH stated no.

I asked SINGH how many employees work at this location and SINGH stated 2 employees. I asked SINGH if there were surveillance cameras on this location and SINGH stated yes. I did observe a computer monitor with surveillance cameras behind the employee counter, that were recording live. I asked SINGH

that if the police needed to review surveillance footage regarding an incident of some sort outside of this location, if anyone had access to view the surveillance footage or just one specific person. SINGH stated that surveillance footage is able to be reviewed at any time that this location is open for business.

SINGH stated that this location primarily serves alcoholic beverages and a hand full of snacks. I informed SINGH that I would be checking various food items placed out for sale to make sure no items were expired. I was able to locate one box of SPONCH, which are marshmallow cookies with the flavor of coconut and strawberry, that were expired. I advised SINGH that all items looked good as far as expiration dates, except for the box of SPONCH. I informed SINGH to just make sure that food items are being checked for expiration dates.

As I was checking for expired food items, I noticed that this location was extremely clean and organized.

During my interaction with SINGH, he was very cooperative and extremely welcoming. I informed SINGH that if his brother, who is the agent of this location, had any questions, he could contact me at District 5. I provided SINGH with a Community Contact Card.

Footage depicts an unknown subject who appeared as black male wearing a blue jean jacket with a green hoodie, blue jeans, black and white shoes, with a black open face mask on. Footage also shows the same unknown subject brandish a black handgun and point the firearm towards the direction of the checkout desk. While the unknown subject points the firearm towards the checkout desk, an unknown female subject makes him lower the firearm and leave the store. J. SINGH stated that S. SINGH told the unknown subject to place an item back on the shelf, which was what prompted incident. J. SINGH and S. SINGH could not provide further information regarding the incident. J. SINGH and S. SINGH where issued a community contact card and PV-17.

J. SINGH uploaded the security footage to evidence.com.

Squad 5426 (P.O. CARRILLO), arrived scene and took seven digital photographs of the scene and location.
