This report is written by Police Officer Xavier Benitez, assigned to the License Investigation Unit, Days.

The Milwaukee Police Department's investigation regarding this application revealed the following:

- On 08/19/23 at 6:00pm, officers were dispatched to 12355 W. Park PI, for a welfare check. Officers spoke with the manager who stated that a guest at the hotel, had to leave because he breached the agreement of stay. The guest had too many occupants staying in his hotel room. Officers spoke with the subject who left the hotel with no further issues.
- 2. On 11/06/23 at 7:58pm, officers were dispatched to 12355 W. Park PI, for an entry to auto. Officers spoke with the business who stated that a guest's vehicle was damaged during an attempted auto theft. The incident was captured on video. The business was cooperative with the investigation.
- 3. On 11/18/23, officers were dispatched to 12355 W. Park PI, for a battery complaint. Officers spoke with the caller who stated that he was struck by an unknown subject while breaking up a fight. Investigation revealed that the offender was no longer on scene.
- 4. On 11/24/23 at 9:16pm, officers were dispatched to 12355 W. Park Pl, for an abduction complaint. Officers spoke with the caller who stated that his ex-girlfriend took there 7 year old child in common without permission, and made statements to harm herself and the child. The investigation revealed that there is an ongoing custody proceeding for primary custody of the

child, and the statements could not be substantiated. The business was cooperative with the investigation.

- 5. On 12/26/23, officers were dispatched to 12355 W. Park PI, for a battery/dv complaint. Officers spoke to the caller who stated that her ex-boyfriend, child in common spat at her. Subsequently the child father was taken in custody for a Disorderly Conduct related offense. Video did not captured the incident, due to it taking place in a hotel room.
- 6. On 01/03/24 at 11:24am, officers were dispatched to 12355 W. Park PI, for a subject with gun. Officers spoke with the caller who stated that the father of her child wanted money from her. The suspect then struck her while making threats to shoot her. The suspect fled before police arrival. The business provided video of the suspect fleeing.
- 7. On 01/14/23 at 12:03am, officers were dispatched to 12355 W. Park PI, for a trouble with subject. Officers spoke to the caller who stated that the subjects on the floor above his, make him feel that he may be harmed. The caller admitted that he did not see or have interactions with the subjects, in question. Officers did make contact with the subjects above, who stated that the area has been quite, and they arrived the night before. Officers spoke with the management who stated that they believe the caller may have some mental issues because this the second time police were called for the same reason.
- 8. On 01/24/24 at 6:34am, officers were dispatched to 12355 W. Park Pl, for a battery complaint. Officers spoke to the caller who stated that she and ex-boyfriend got in argument in her hotel room. The suspect became upset about content on her phone and struck her on the face. The suspect then fled the area in his vehicle. The business was cooperative with the investigation.
- On 02/28/24 at 11:18pm, officers were dispatched to 12355 W. Park PI, for a trouble with subject. Officers spoke with the employee who stated that, a subject who is not a guest is refusing to leave. Officers did make contact with the subject, but outcome of the interaction was not reported.
- 10. On 04/10/24 at 8:45am, officers were dispatched to 12355 W. Park PI, for service of police. Officers spoke with the caller who stated that she has put a complaint on officers and nothing is being done. The caller would not specify further or meet officers at the lobby regarding her complaint. The business attempted to have the caller come down but she refused. The business stated that they may have evict the guest due to multiple calls for police and failure to cooperate, after the initial call.

This report is written by PO Benjamin MARSHMAN, assigned to DISTRICT 4, early SHIFT, as squad 4220.

On 08/19/2023 at 6 pm, as squad 4220 with PO SAENPHONPHEE, we got dispatched to the address of 12355 W Park PL (Woodspring's Suites) for a welfare check. The CAD stated that a subject in room 126 had to many people in his room and was needed to be removed from the hotel.

When we got to the scene the caller who was at the front desk was waiting for us and then let us into the hotel. Later on, in the call 4215 SGT GRANDSARD came to the scene.

I spoke to the caller, Christana M SMITH (B/F 04/17/1993), who stated that a subject identified as Albert SHANKLIN (B/M 07/28/1990) rent a room for 7 days to stay in with two kids. SMITH stated that after he pay for the room 6 more kids came into the hotel and went in the room of which he was staying at. SMITH stated that this was a breach of the argument that SHANKIN singed which stated that he was only going to have two kids stay with him. SMITH stated that the first shift manager talks to SHANKIN about this and then SMITH stated that the General manager (CHRIS) got called and spoke to SHANKIN about this. SMITH stated that original GM CHRIS told SHANKLIN that he could stay but then CHRIS called back and told SMITH that SHANKLIN could only stay if SHANKLIN got another room and had only 4 people per room. SMITH stated that police were called there early informed SHANKLN that those were his option and that if he did not do that, the money would be refunded, and he would have to leave the Hotel.

We then spoke to Albert SHANKLIN (B/M 07/28/1990) who stated that he talked to CHRIS the general manager who told him that he could stay if the kids did not cause any problems. SHANKLIN stated that he was in a bad situation and did not have anywhere else to go. SHANKLIN stated that he needed the money back so he could get another place.

I then asked SMITH who was the manager that was on scene for CHRIS the GM phone number to make contact with him and she stated that she did not have it. The business was *cooperative* with the investigation but could not provide me with information to contact the GM CHRIS and she did not know any other information regarding CHIRS.

SHANKLIN did leave the hotel with no other issues.

While on scene, I did not observe the licenses posted. During my investigation for Welfare Check I did not observe any violations in the licensed premise.

On Monday, November 6th, 2023, at 7:58pm, Squad 4431 responded to the Woodspring Suites Hotel located at 12355 West Park Place for a report of an "Entry to Auto". This call is related to Milwaukee Police Department CAD # 23-310-1343 and originated at 7:09pm, with both the victim and hotel manager calling the police.

During this investigation, unknown subjects had arrived at the northwest side of the hotel's parking lot and attempted to take victim's vehicle, a 2021 gray in color Kia Sportage 4 door, with Wisconsin registration plates 890-VMY. The victim/owner of this vehicle is a Carol Ann Carr- Brice b/f 02-02-1951 who is currently staying in Room #229 for approximately 2 months. The on-duty manager for the hotel that also called police on behalf of the victim was a Damian L Morton b/m 07-10-1975. Unknown subjects had intentionally damaged the victim's front passenger window and entered victim's locked vehicle before intentionally damaging the victim's vehicle's steering column in an attempt to take and drive the victim's vehicle without consent. It appeared the suspect(s) had been startled by other citizens at the hotel and fled the scene.

During this investigation, this incident was captured on the hotels exterior video camera system. A review of the camera footage from camera labeled "SW Corner EXT" which is an elevated exterior video camera located at the northwest corner of the hotel and faces the west parking lot facing south/southwest. This camera footage is in color and the camera system appears to have correct date and military time on all camera views. A review of the camera depicts suspect(s) arriving at the west parking lot at approximately 7:07pm.

The suspect(s) arrive at the west parking lot in two vehicles a dark colored smaller Kia SUV with no registration plates and a dark in color, possible Kia 4door sedan. The suspect(s) exit only the SUV and damage and enter the victim's vehicle and both vehicles leave the location in tandem. No subjects are observed exiting the dark in color possible Kia 4door sedan however both vehicles are observed on video leaving the location at a high rate of speed after the victim's vehicle alarm was activated. The sedan appears to have Wisconsin registration plates however they are not readable on the video camera. This

incident occurred at approximately 7:07pm on 11-06-2023.

This incident is related to Milwaukee Police Department Incident Report #23-310-0171. See PO Pashkewitz's original report regarding this incident. A PV-17 form, MPD Crime Victim Resources form with officer's contact information and related incident report number was left with both the victim and Morton along with contact cards. Officers arranged for the video footage to be emailed to Squad 4431 when the hotel's manager arrives the following day.

This dispatched assignment occurred at a licensed premise and although the business was not directly involved due to District Four protocol, supervised by Sgt. Paul Graczyk, a License Premise Report will be filed to document this incident.

CAD 23-310-1725, INCIDENT REPORT NUMBER 23-311-0017

On Tuesday, November 7th, 2023, at 1:41am, Squad 4431 volunteered to respond to a "Vehicle Theft" at the Woodspring Suites Hotel located at 12355 West Park Place. This call is related to Milwaukee Police Department Incident Report 23-311-0017, both the victim and manager on duty again called the police related to this call. Squad 4431 volunteered to respond to this assignment as we were previously at the location for an attempted vehicle theft and believed to be possibly related.

On arrival, officers made contact with the on-duty manager, Dawson J Umbs w/m 10-25-1998. Umbs had in his possession the PV-17 form with PO Pashkewitz and my information from the previous encounter at the hotel. Umbs advised officers that occupants of the hotel from Room #108 had their vehicle stolen and it occurred earlier the previous day during the same time frame as the aforementioned incident.

A review of the hotel's video camera system, in particular camera view labeled NE Corner EXT, which faces the east hotel parking lot facing southeast, partially captures this incident. In the video a dark in color smaller Kia SUV arrives at the hotel's parking lot in the east parking lot. The vehicle backs into a parking space next to the victim's vehicle and the driver exits this vehicle and approaches the victim's vehicle. This suspect appears to be a male wearing a light gray hooded sweatshirt with the hood up and black pants and appears to be the same suspect that was responsible for Incident Report Number 23-310 -0171. There is a disruption in the video and the video skips forward and the male wearing the light gray hooded sweatshirt is observed inside the victim's vehicle. A second male subject observed wearing a black hooded sweatshirt is observed driving the victim's vehicle from the parking lot towards the west parking lot. This incident occurs around 7:05pm which is just before the attempted vehicle theft that occurred in the west parking lot at approximately 7:07pm.

The stolen vehicle is a 2015 blue in color Kia Optima 4door, with Wisconsin registration plates AJV-1432. The victim/registered owner Kristin N Steinle w/f 04-12-1983. Steinle is staying in Room #108. Steinle stated she had left the hotel and returned at approximately 7:00pm on 11-06-2023. Steinle noticed her vehicle missing at approximately 11:00pm and informed the hotel staff. It was at this time it was revealed that the two above incidents were related.

The suspects had damaged the vehicle's rear passenger window to enter the locked vehicle and ultimately take and drive the vehicle away. No keys were taken during the vehicle theft.

- US Currency \$250.00 (in \$20.00 and \$5.00 bills)

- miscellaneous women's clothing in the trunk of the vehicle with a value of approximately \$1000.00

- miscellaneous jewelry inside the vehicle including a silver and turquoise ring and other jewelry; no value given

This report is being written by Police Officer Collin ENK, assigned to District 4 Late Power shift, assigned to squad 4467 with P.O. Khalid MAJEED.

On Friday, November 24th, 2023, at approximately 9:16 pm, Officers responded to 12355 W Park Pl for an "Abduction" call for service, which is located in the City and County of Milwaukee.

Upon arrival I was met by the caller Khiry J GATES (M/B 09/05/1989) who stated that his ex-girlfriend, who he identified as Danielle M VALOE (F/B 02/29/1976), had come to the hotel that he is currently staying at and abducted the child that they have in common. GATES identified his son as Dekyrios J GATES (M/B 11/06/2016). GATES stated that Dekyrios has been in his custody for the past 8 months and he and VALOE are currently going through a custody case for primary custody of Dekyrios. GATES stated that he has been allowing VALOE to visit at the hotel for the past week. GATES then stated that he left the hotel at approximately 7:00 pm and when he returned to the hotel VALOE and Dekyrios were gone, and the room was ransacked.

GATES then stated that he received a phone call from VALOE who stated "You don't take my PTSD seriously, I might as well end my life our kid's life".

I reviewed the camera footage at the hotel and observed VALOE and Dekyrios leaving the location. I observed Dekyrios and VALOE to appear calm, it did not appear that Dekyrios was distraught or refusing to leave with VALOE. VALOE was also in the company of an unknown black male, last seen wearing a green sweatshirt, tan pants, green shoes and a yellow baseball hat. VALOE, Dekyrios and the unknown male exited the hotel and got into a burgundy Toyota Scion, bearing WI plate number ATP-8324.

I observed VALOE to be wearing a black sweater, gray shirt, black leggings, white shoes and a tan bonnet.

I observed Dekyrios to be wearing a black sweatshirt, gray sweatpants, black shoes and his hair in a ponytall.

Officers later spoke to VALOE via phone who stated that "He is lying, you should know that he should be charged for that. Me and my son are safe, stop calling my line".

I was also advised that VALOE also stated "Fuck him, he can see his kid at the next custody hearing".

SGT. William KINGSTON responded to this call. I was advised that after providing Lt. JACKS of CIB who stated that this would not be a missing critical investigation and to enter a standard missing person report for VALOE.

MORTON was very cooperative during the investigation and allowed me to review the camera footage.

Upon arrival I observed the dispatch location a Woodspring Suites hotel. I observed room #317 with a broken window and broken glass on the floor near the window. I observed the victim with a open wound on her lip and 4 children in the room.

Upon arrival I spoke to the caller/victim Lashunda R. MCNEAL (B/F 11/18/89) who stated that Shawn L. OVERTON (B/M 1/21/97) kept her from leaving MCNEAL's hotel room against her own will by threatened to shoot her with a gun. (MCNEAL stated that she never actually saw MCNEAL with a firearm but MCNEAL stated OVERTON is known to own and carry a handgun). MCNEAL stated that OVERTON's reason for keeping her from leaving was because OVERTON wanted MCNEAL to give him money. MCNEAL stated that OVERTON is the father of her child.

MCNEAL stated that OVERTON then strangled her with his hands causing MCNEAL to not be able to breath, MCNEAL stated that OVERTON also punched her with a fisted hand one time, causing her to have a swollen lip and open wound on her mouth.

OVERTON fled from officers when we attempted to make contact at the above listed address. OVERTON broke the window out (an estimated value of 1200\$) in room #317 and jumped out of the window.

There was no video surveillance of the initial incident, but there is hotel security cameras around the exterior of the building, and hotel video captured OVERTON fleeing from the Milwaukee Police Department. I did not review video footage but was notified by hotel staff of the video surveillance.

While on scene, I observed the licenses posted and they were up to date.

JOHNSON from District 1 and nothing was being done. EVANS had called 10 times in the last month, and refused to give her room number or meet us in the lobby. She stated that she didn't trust anyone and refused to speak to me anymore. She hung up and refused to answer any further. *No other witnesses*/

I spoke to licensed premise manager, CARREON, who called EVANS and attempted to have her meet us in the lobby. EVANS was profane and disrespectful yelling at her, refusing to cooperate. CARREON was attempting to help but EVANS was rude. CARREON stated that they may be in the process of evicting EVANS for the multiple calls and refusing to cooperate.

I didn't reviewed video surveillance footage.

While on scene, I didn't observe or look for the licenses posted and they were up to date.
