	Where materials REPLACEMENT is necessary: Woodwork (trim boards, mouldings, windows, siding) will be replaced with solid, knot free pine, fir, cedar jor white oak. All new moulding profiles will be custom matched and milled from aforementioned wood species. 3rd floor gable south face: Soffit & Facia:
	Repair, scrape, prime, paint corbels, soffit, fascia, rake moulding and dental moulding. Window openings and mouldings: \ - Repair, scrape, prime, paint ornamental columns and all adjacent wooden architectural elements. Repair wood, replace glass, reglaze, reinstall, prime and paint 6 original double hung window sashes, i Siding/shingles: Tear off all existing cedar shingles.
	Do any necessary repairs to existing sheathing. <i>j</i> - Install vapor barrier Mill, prime, paint, install new cedar shingles. The shape and pattern of the new shingles will exactly imatch that of the existing original shingles.

The use of a decay-resistant wood for is required for porch areas

All work must be done in a craftsman-like manner. Staff must approve any changes or additions to this certificate before work begins. Work that is not completed in accordance with this certificate may be subject to correction orders or citations.
