We have received your claim in the amount of \$500.00, relating to damage sustained to your vehicle when it allegedly collided with a pothole while traveling along eastbound West North Avenue at North 38th Street on February 7, 2008.

Our investigation reveals the Infrastructure Services Division (ISD) reviewed their records and the records of the DPW Call Center regarding this incident.
