

**AMENDMENT TO
CHARTER SCHOOL CONTRACT
BETWEEN
THE CITY OF MILWAUKEE
AND
YW COMMUNITY EDUCATION CENTER, INC.**

WHEREAS, The City of Milwaukee, acting by its Common Council ("City") and YW Community Education Center, Inc. ("Charter School") entered into a 5-year Charter School Contract on April 19, 1999; and

WHEREAS, The Charter School Contract provides that Charter School shall serve children in Kindergarten through grade four during the 1999-2000 school year and add a grade level served each succeeding year so that by the final school year of the Contract, 2003-2004, Charter School would serve children in Kindergarten through grade eight; and

WHEREAS, The Charter School Review Committee ("CSRC") on May 17, 2001 voted to recommend that the Charter School Contract be amended to limit the grade levels served by Charter School to Kindergarten through grade five; and

WHEREAS, The Common Council on _____ approved the recommendation of the CSRC and directed the appropriate city officials to execute an amendment to the Charter School Contract between City and Charter School to incorporate the recommendation of the CSRC; and

THEREFORE, The 5-year Charter School Contract between the City and Charter School that was entered into on April 19, 1999 is hereby amended as follows:

Notwithstanding any other language contained in this Contract, Charter School shall serve pupils in Kindergarten and grade four during the 1999-2000 school year and Kindergarten through grade five during the 2000-2001, 2001-2002, 2002-2003, and 2003-2004 school years.
