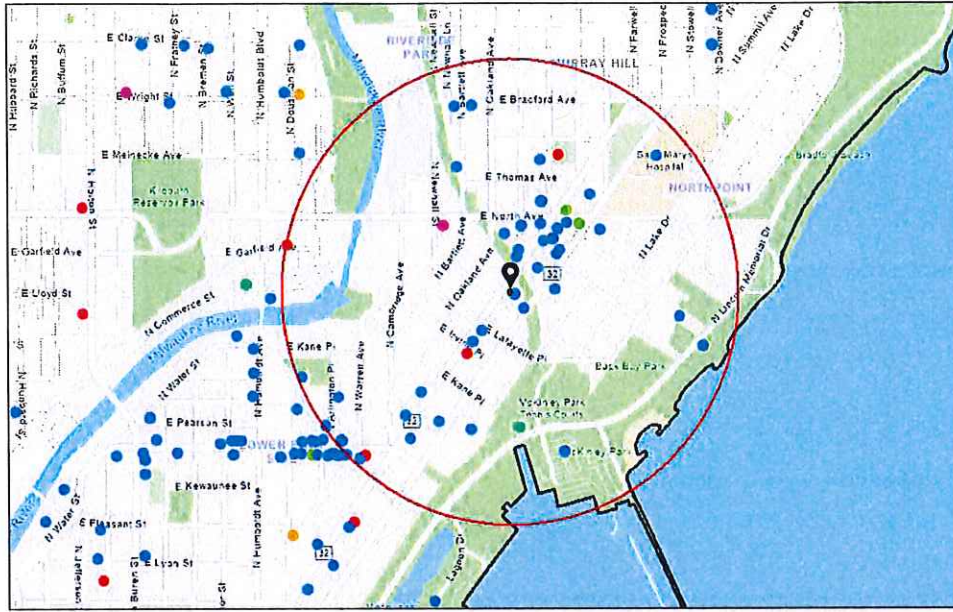


# City of Milwaukee Concentration Map
