To Whom It May Concern,

I am submitting this letter to formally file a claim under Wisconsin Statute § 893.80(1), which governs claims against governmental bodies for damages caused by negligence. This claim concerns damages and injuries resulting from an incident on December 6, 2024, at approximately 10:00 PM at 18th and Vienna Avenue in Milwaukee, Wisconsin.

While driving my 2017 Ram 1500 truck, I encountered a large, unmarked hole in the road concealed by water. This hole, approximately three feet deep, caused severe damage to my vehicle's bumper and affected its overall performance. Since the incident, my vehicle has been driving improperly, requiring repairs and inspection. Additionally, the impact caused injuries to my back, for which I sought medical attention at Ascension Hospital immediately after the incident.

Under Wisconsin law, municipalities have a duty to maintain public roadways in a reasonably safe condition (Wis. Stat. § 81.15). The City of Milwaukee breached this duty by failing to identify, repair, or warn of the hazardous condition. At the time of the incident, there were no cones, signs, or warnings to alert drivers to the danger, and the city's negligence directly caused damage to my property and harm to my health.

The incident was witnessed by several individuals, including Milwaukee Police Officers Keonzay, Becerra, and Rivera (Squad 5260), who were present at the scene and can confirm the absence of any visible safety measures.

Additionally, this incident has impacted my ability to operate my business, "Big or Smalls, We Handle It All," as I rely on my truck for transporting goods and providing services. Without a functioning vehicle, I am unable to generate income to support myself, further compounding the damages caused by the city's negligence.

This incident has also significantly affected my full-time job with **Running Rebels**, a community organization dedicated to keeping youth out of trouble by mentoring and helping them find employment. My damaged vehicle has left me unable to transport these young people to job interviews and other critical activities, further hindering my ability to fulfill my professional responsibilities and impacting the youth we serve.

DAMAGES AND CLAIMED AMOUNT

Under Wis. Stat. § 893.80(1d)(b), I am requesting compensation for the following:

- Vehicle Damage:** Repair estimates for my 2017 Ram 1500 truck (attached).
- Medical Expenses:** Costs incurred for emergency treatment at Ascension Hospital (attached).
- Lost Income:** Compensation for the financial losses due to the inability to operate my business and transport youth in my role with Running Rebels.
- Pain and Suffering:** Compensation for the physical and emotional hardship caused by this incident.

Based on the damages described, I am requesting a total compensation of **\$15,000**.

DOCUMENTS INCLUDED

To support this claim, I am providing the following:

- Photos of the damage to my vehicle and the road conditions at the time of the incident.
- Repair estimates for my 2017 Ram 1500 truck.
- Medical records and bills from Ascension Hospital.
- Witness information, including the attending officers.

STATUTORY NOTICE

This claim is submitted in compliance with the notice requirements under Wisconsin Statute § 893.80(1)(a). I reserve all rights under Wisconsin law to pursue further legal action if this claim is denied or unresolved within the statutory timeline.




