Investigation revealed an unknown patron who was armed with a semi-automatic gun, was let into the gas station and struck the clerk twice in head with the gun. The suspect then went through the clerk's pockets removing his wallet, which contained \$120 dollars. The suspect then proceeded to the register and tried to open it but was unsuccessful. - 14.On 07/13/23 at 11:35a.m., Milwaukee Police were dispatched to a Trouble with Subject at 425 E. Capitol Dr. On arrival the caller was no longer on scene, however, officers spoke to an employee who stated they juveniles they were having trouble with were gone. The employee was cooperative with the investigation.
- 15. On 09/05/23 at 10:53a.m., Milwaukee Police were dispatched to a Reckless Use of a Weapon at 425 E. Capitol Dr. Investigation revealed 3 subjects were inside the store, when the employee accused them of stealing. This report was written by P.O. Terry BELL assigned to District Five Early Power shift, Squad 5290.

On Tuesday, September 5, 2023, at 10:53 AM, I was dispatched to 425 E Capitol Drive for a Reckless Use complaint.

Upon arrival, I observed the salesfloor of the business which appeared to be in functional condition. There were customers in line to purchase gas and items.

I spoke with the caller, Kaur GURMIT (F/A, 12-02-63) who stated that one of the employees whose name was "Aman", observed three subjects enter the business at 6:20AM in the morning. GURMIT stated that "Aman" accused the subjects of shoplifting. GURMIT stated that the remaining two subjects then grabbed items from the salesfloor racks and left the business without paying for the items. GURMIT stated that "Aman" began to give chase to the thieves who fled from the location. GURMIT stated that "Aman's" shift ended at 8:00AM. GURMIT stated that "Aman" stated that he walked towards his home when he was confronted by five subject on E Capitol Dr in front of the McDonald's restaurant at 420 E Capitol Dr. GURMIT stated that "Aman" stated that two of the subjects were two of the three subjects that he confronted earlier about shoplifting, who then fled the business. GURMIT stated that "Aman" stated that one of the subjects pointed a gun at him while the other brandished a firearm in his waistband. GURMIT stated that one of the subjects threatened "Aman" telling him that "You can't tell on us for stealing." GURMIT stated that "Aman" stated that he plead with the assailants, apologizing for his actions. GURMIT stated that "Aman" then called her, who then she called for police services.

I spoke to the licensed premise owner, Swaran S MULTANI (M/W, 07-16-56) who shared the same story as GURMIT.

I reviewed a recording of the surveillance footage from the phone of GURMIT. The video depicted three subjects (S) entering the business at 6:25am. S1: a B/M, in his teens, dressed in a black hooded sweatshirt, light blue jeans, and black slides; S2: a B/F, in her teens, dressed in a white halter top, black spandex shorts, and white slides; and S3: a B/M, dressed in a black doo-rag, navy t-shirt, light blue jeans, and black slides. The employee identified by GURMIT as "Aman" accuses the subjects of shoplifting from behind the security glass of the cash register room. S2 and S3 appeared "stunned" as "Aman" made his accusations. S1 pokes his head back into the business door. S2 and S3 then began to start removing items from the salesfloor shelves and exit the business without paying for the merchandise. "Aman" then exits the cashier room in pursuit of the subjects.

While on scene, I observed the licenses which were posted on the north wall above the window. From these I was able to obtain the name of the agent, MULTANI.

GURMIT and MULTANI were cooperative with my investigation. The investigation is pending due to the unavailability of "Aman". I informed both GURMIT and MULTANI that I would return once "Aman" began his shift at 6:00 pm, September 5, 2023.

End of report.

I reviewed video surveillance footage. The footage showed ADD SUMMARY OF EVENTS DEPICTED ON THE VIDEO, INCLUDE TIME STAMPS. The video was recovered and inventoried/uploaded to AXON. INCLUDE A STATEMENT IF SOMEONE ON SCENE WAS ABLE TO GIVE IMMEDIATE ACCESS AND IF THE PERSON WORKING WAS ABLE TO ASSIST WITH THE CAMERAS. IF THE VIDEO SHOWS SOMETHING THAT CONFLICTS WITH THE LICENSED PREMISE OWNER/EMPLOYEE STATEMENTS ASK FOR CLARIFICATION ON THEIR STATEMENTS, ATTEMPT TO DETERMINE IF THEY PURPOSELY LIED. IF THE BUSINESS DOES NOT HAVE CAMERAS NOTE IN REPORT. IF THE BUSINESS HAS CAMERAS THAT ARE NOT WORKING NOTE IN REPORT AND OBTAIN A REASON WHY THEY ARE NOT WORKING AND WHEN THEY ARE EXPECTED TO BE OPERATIONAL. IF THE BUSINESS REFUSES TO PROVIDE VIDEO ATTEMPT TO OBTAIN A REASON WHY.

BUSINESSES DO NOT HAVE TO PROVIDE US WITH SURVEILLANCE FOOTAGE AND A WARRANT MUST BE OBTAINED IF THEY DENY ACCESS IF THESE EXTRA STEPS HAVE TO OCCUR ADD INTO THE REPORT.

While on scene, I observed the licenses posted and they were up to date. (IF NOT POSTED OR EXPIRED NOTE IN REPORT) During my investigation for CALL TYPE I did not observe any violations in the licensed premise. IF VIOLATIONS ARE OBSERVED EXPLAIN WHAT THEY WERE AND IF ANY ENFORCEMENT ACTION WAS TAKEN.

On Saturday October 14, 22023, at approximately 6:17pm, my partner PO Domenico RIZZO and I were dispatch to 425 E. Capitol Dr. for a Property Damage complaint.

Upon our I observed store customers in the lot of the gas station and a broken glass window on the building. I also observed broken glass on the ground under the broken window and broken black material.

I spoke to the caller/ owner, Swaran S. MULTANI (W/M, 07/15/1956 414-305-0326). They stated they have a problem with the same kid coming in taking items without paying. MULTANI stated on 10/14/2023, the subject entered the store and began smoking. MULTANI stated he and his employees asked the subject to exit the store and smoke in which the subject refused. MULTANI stated after leaving the store, the subject threw a "brick" hitting the glass and shattering the outer window. MULTANI stated he observed the male subject flee south from the location towards Walmart.

The business was cooperative with the investigation. The business had 0 security officers on scene. The other witnesses on scene did not speak English to obtain a statement from them.

My partner reviewed video surveillance footage. The footage showed a black male wearing a Navy and Royal Blue zip up hooded sweatshirt, Gray sweatpants, white shoes, short afro, medium brown complexion, and no facial hair. This male subject was seen exiting the building and exchanging words with someone inside the store. The male was then seen picking up a rock and throwing it at the window of the business. The male was then seen again picking up the same rock and throwing it at the same window again. The male was then seen leaving the location heading south from the location towards Walmart. The video was recovered was not able to be recovered at the time of the investigation. PO HOLSEN responded to our location and took photos of the location and damages.

While on scene, I observed the licenses posted and they were up to date. During my investigation for a property damage. I did not observe any violations in the licensed premise.

This report is written by Police Officer Corstan D. COURT, assigned to the License Investigation Unit, Days.

The Milwaukee Police Department's investigation regarding this application revealed the following:

1. On 02/15/2021 at 12:31pm officers were dispatched to a Theft of gun at Palmer Food Market, 200 E. Center St. the investigation revealed two subject entered the store. One subject distracted the clerk and the second subject went behind the counter and took a pistol from the shelf. The officers were able to recover video of the incident.

2. On 03/07/2021 officers conducted a license premise check at 200 E. Chambers St. The officers spoke with the manager, who signed a standing No Loitering complaint form. The officer provided the manager with a No Loitering sign to display outside.

3. On 05/18/2021 at 1:14pm officers, along with Wisconsin Department of Revenue agents, conducted a license premise check at Chambers East Food Market, 200 E. Chambers St. The officers spoke with the clerk about invoices for tobacco and liquor. The clerk did not know where they were located but contacted the owner by phone. The owner stated the invoices were at his accountants. The Wisconsin Department of Revenue agent advised the owner to come to the business with the invoices. The clerk did not have a Class D operator's license.

Wisconsin Department of Revenue agents removed six boxes of tobacco. The owner signed a standing no loitering complaint and was given a No Loitering sign.

- 4. On 05/31/2021 at 5:49pm, officers investigated a shooting at N. Palmer St. and E. Chambers St. During the investigation, the officers went to East Chambers Foods to check for video. The manger was cooperative and provided video of the incident to the officers.
- 5. On 09/19/2021 at 4:44pm, officers were dispatched to a Shooting at 200 E. Chambers St. The officers spoke with the clerks who stated they did not hear a shooting. The officers then located a bullet hole in the front door that went through an interior wall and a cooler door. The officers asked the clerks why they stated they lied and they stated they did not lie because they did not hear the gunshots.
- 6. On 04/10/22, officers responded to a shooting on E. Chambers St., and W. Palmer St. The shooting was unrelated to the business at 200 E. Chambers., however, the employees were cooperative and allowed officers to view video surveillance of the incident.
- 7. On 11/29/22 at 9:50am., officers conducted follow-up at 200 E. Chambers. This was in regards to an Aldermanic complaint of subjects engaging in health and safety violations inside the establishment. Officers were able to view a Facebook video depicting several subjects inside the establishment smoking, drinking, dancing, throwing up gang signs and pointing a firearm at the camera. The video further depicts what appeared to be an employee entering the video and also throwing up a gang sign. During the video customers can be seen entering the business, many of whom appeared to be juveniles. Upon officers arriving at the establishment several individuals were observed loitering both outside and inside the store. Upon entering the store officers could smell a strong smell of burnt marijuana and a subject was observed smoking a Black and Mild cigar inside the store. Officers further observed one of the male subjects that was in the video displaying a firearm, in the locked employee area with the employee on duty. Upon seeing the officers, the male subject exited the locked employee area and left the store. Officers introduced themselves to the employee and requested his identification, however, the employee stated he did not have one, but provided officers with his name. Officers advised the employee they believed him to be the owner of the building, and the subject in the video throwing up gang signs, however, the employee denied being the owner of the building or the agent. The video and the possible repercussions of that specific behavior was discussed with the employee, who never admitted or denied to incident. Further inspection of the establishment revealed clear plastic bags of chicken for sale with no labeling or expiration date, and vacuum sealed bags of cheese, which had expiration dates of April 2022. Officers observed spring loaded mouse traps in the grocery area of the store. As officers completed the License Premise check, they observed several individuals entering the store smoking. On 11/30/22, officers conducted follow up and requested to see the video surveillance from the day the Facebook video was posted. The surveillance video depicted the same activities that officers observed on the Facebook video and the employee seen in the video was the same employee officers interviewed on 11/29/22. While on scene, a young individual entered the store; approached the counter area, and the employee was observed shaking their head as if to say no. The subject then walked away, browsed a little then left the store without making a purchase. Several other subjects were observed wandering around the store, but did not appear to be shopping. It was later determined through investigation the employee the officers initially interviewed was in fact the owner of the building and the employee in the video. The employee could not answer why they were untruthful to the police when initially

questioned. The employee was cited for Resisting/Obstructing and Smoking Prohibited. Upon in person service of the citations to the employee, a large rat was observed running in the grocery area. Officers made a referral to the Milwaukee Health Department for the observed violations.

Officers interviewed the manager who stated since the last inspection they have been more vigilant about calling the police regarding people loitering or using drugs. Officers did locate 3 calls for police placed by the manager. The interior appeared to be clean with no odor of cigarette or marijuana smoke.




