Asphalt pavement resurfacing, replace curb and gutter, sidewalk and driveway approaches where necessary, and sodding.

W. Townsend St. – N. 84th St. to N. 86th St. (ST211060149):

Asphalt pavement resurfacing, replace curb and gutter, sidewalk and driveway approaches where necessary, and sodding.

6th Aldermanic District

W. Walnut St. (South Roadway) – N. 6th St. to N. 10th St. (ST211060158):

Asphalt pavement resurfacing, replace curb and gutter, sidewalk and driveway approaches where necessary, and sodding.

8th Aldermanic District

S. 25th St. - W. National Ave. to W. Pierce St. (ST211060138):

Concrete pavement reconstruction, replace all curb and gutter, replace sidewalk and driveway approaches where necessary, and sodding.

Asphalt pavement resurfacing, replace curb and gutter, sidewalk and driveway approaches where necessary, and sodding.

Asphalt pavement resurfacing, replace curb and gutter, sidewalk and driveway approaches where necessary, and sodding.
