This is the second time this file has been heard by the Judiciary and Legislation Committee. At the June 10, 2019 hearing of the Judiciary and Legislation Committee, this office recommended that Ms. Batchelor visit the Milwaukee Municipal Court to inquire about the possibility of reopening her cases. Additionally, on July 7, 2019, this office sent her a letter with information on how to reopen her cases or pay off the Milwaukee Municipal Court debts, if she chose to do so. To date, there is no information in the court files indicating that Ms. Batchelor has taken any action to reopen her cases.

This office has had the opportunity to review whether the applicant has any outstanding debts with the Milwaukee Municipal Court.

Milwaukee Municipal Court records indicate that Ms. Batchelor has two outstanding building code violation judgments related to the subject property. They are as follows:
