Dear Licensing Committee-

My name is Mindy Nolan and I am writing in support of the liquor license renewal for the Miramar Theater on Oakland Avenue. I am a local criminal defense attorney and homeowner in the Brewer's Hill/Riverwest neighborhood. I have been patronizing the Miramar for the past 10 years.

I have heard there have been some issues at the venue related to fights and possible gunshots after an event. These issues cannot be blamed on the venue. Our entire city, and country for that matter, is under siege. Hardworking business owners like Aaron Ohlsson should not be punished by getting their doors shuttered for a nation wide epidemic of violence. I know that Mr. Ohlsson has been proactively working with the Milwaukee Police Department and a private security company to ensure a safe environment for patrons and the community. People need an outlet where they can still have fun and enjoy live music. Closing businesses is not the solution to the problem. The solution lies somewhere within neighborhoods, households, and communities in instilling a sense of support and values.

My office is located across the street from the Brownstone Lounge in the Chase Bank building. On the night of the tragic shooting I was working late and missed the violent act when I was pulling out of the parking garage by about 10 minutes. My reaction wasn't to cast blame upon the owner and support the business shutting down. Rather, to wonder why are so many people resorting to senseless acts of violence and what can I do to be part of the solution? I was happy to see that Brownstone reopened. And, I will be happy to see the City of Milwaukee support Mr. Ohlsson in his endeavor to continue a decades old independent music venue on Milwaukee's Eastside.

On a more personal note, my fiancé and I are getting married on September 3rd after ten years. We would go to the Miramar often early on in our relationship. We had rented the space for one of our wedding events and hope that will be able to happen.

The Miramar Theater is a Milwaukee institution. Just like Shank Hall and Cactus Club. The theater has hosted acts that have gone on to be nationally and internationally known. Mr. Ohlsson has built relationships with artists and managers to get some of those acts to come back and perform at his small venue. It's what makes it special, and special for Milwaukee.

I ask that the committee renew Mr. Ohlsson's license at the Miramar Theater.



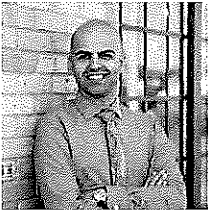
