

On the second visit, I left a list of my tenants that I felt could possibly be involved with crack cocaine and offered an entrance key to my building for easy access. It was after the second visit that I had the phone contact with you.

A great deal of time has passed since we spoke. Some of the tenants that concerned me have moved on, while others remain. In addition, a very new tenant appears to be dealing right out of the building. I am concerned for the safety of my tenants and also in protecting my business interests. I don't know if you have the place under observation, or, if anything has been done since we talked. I know there are probably more serious situations that are priorities, but I feel this situation needs some of your attention.
