

Third, another such business/tavern is not amenable to the neighborhood and family atmosphere of condominiums in the neighborhood. Please also consider the number of churches and school in the immediate neighborhood (including Grace Downtown and Village Church).

This location has been newly renovated. All of the City inspections have not been done at the time of the CPTED, so occupancy capacity has not established. There are 32 cameras in total installed at the business with the hard drive locked in an office that only management has access to. All employees have attended and are certified with Servsafe. The N. Water street entrance will be used for pick orders only, and the entrance located in the patio area on E. Highland Ave. will be used by customers looking to dine in. The patio area will only be used as waiting area.

Prepackaged beverages and beer will be sold at the business, but there will not be alcohol offered for Blended/ mix drinks. The agent and manager were offered the option to have the District One Community officers come in and present safety and best practice tips for employees.
