

### **Departmental Budget Appropriation Category**






Requested Budget


\$318,967 (6.7%) more than Proposed Budget

-\$154,342

Decrease in Salaries/Wages and Fringe Benefits for the department, down 5.2% from the amount allocated in 2022.







### Staffing Vacancies - 9 total

- Accounting Specialist (3)-one likely filled soon
- Auditor-Lead

Vacant positions that will be eliminated in 2023:

- Accounting Program Assistant II
- Senior IT Auditor
- Auditor

### Vacant (unfunded):

- Executive Administrative Assistant II
- Financial Systems Analyst
- Auditor (same position that will be cut in 2023)

### **Contracted Firms to Perform IT-Related Audits**

In 2023, the Comptroller's Office will contract with audit firms to perform IT-related audits, which is expected to save the department \$63,000 annually.

### **Increasing Workloads**

In 2023, the department will see a greater workload due to new Governmental Accounting Standards Board accounting standards, increased grant administration and audits, and the growing complexity of the bond market.






#### Revenue

Comptroller's 2023 projected revenues:

• Charges for Services \$510,000

Projected revenues of \$510,000 are \$50,000 lower than 2022 estimated revenues and \$46,248 higher than 2021 actual revenues.

#### **Grants & Aids**

Total grants and aids for the department are \$750,184 for 2023:

CDBG – Accounting & Auditing \$493,534

HOME – Accounting & Auditing \$160,379

ARPA – Accounting & Auditing \$96,271

CDBG grant funding is down by \$7,556 but HOME grant funding is up by \$85,446 from 2022. The ARPA grant is a new source in 2023.


Wages Supplement Fund for 2023, which is used to cover employee wage increases. Total amount is down by \$1,580,000 from 2022, and intended to cover a 2% general City employee wage increase in 2023.

## \$3 million

Public Debt Amortization Fund withdrawal in 2023, which is \$2 million less than the \$5 million withdrawn in 2022.
