Resolution recognizing Jack Gaboury for his 50 years of service to the City of Milwaukee.

WHEREAS,

JACK GABOURY

has faithfully served the City of Milwaukee for 50 years, dedicating his entire professional career to the advancement and excellence of the City Records Center, and henceforth is being honored for his steadfast commitment and service; and

WHEREAS, *Jack Gaboury began his career in public service in 1975 through the CETA program, serving as a Clerk in both the Comptroller's Office and Municipal Equipment Division, and on February 6, 1976, was assigned to an emergency vacancy in the City Records Center as a Library Aide, later being officially appointed as a Microfilm Technician; and*

WHEREAS, *Jack Gaboury played a critical role in the development and implementation of the City's Centralized Imaging System in the late 1990s, and has overseen massive records initiatives, including the digitization of oversized architectural plans and the conversion of approximately 2,000 microfilm rolls of historical building permits into indexed digital records; and*

WHEREAS, *Jack's influence spans every facet of records lifecycle management—from physical storage and retrieval to certified imaging, scanning, indexing, and proper destruction, with countless records having passed through his expert hands multiple times across decades of evolving technology; and*

WHEREAS, *Jack has shown exceptional commitment by also serving for more than a decade as a Chief Inspector at polling locations, embodying the spirit of civic duty and responsibility; and*

WHEREAS, *Jack's work ethic, integrity, and mentorship have earned him the respect and admiration of colleagues and the community alike, culminating in the presentation of the Legacy Award from ARMA Milwaukee in recognition of his lifelong dedication to records management and the City of Milwaukee; and*

WHEREAS, *Over the course of his distinguished 50-year career, Jack has become a trusted problem-solver, a respected professional, and a symbol of steadfast public service—leaving an indelible mark on the City of Milwaukee's Records Center; now, therefore, be it*

RESOLVED, *That the Common Council of the City of Milwaukee hereby recognizes Jack Gaboury for his five decades of exceptional service, leadership, and contributions to the City and its citizens; and, be it*
