#### 2. Review and approval of the minutes of the December 4th meeting.

#### 3. Discussion and possible vote on amended the Questionnaire completed by businesses.

#### 5. Discussion and possible vote on Kitchen 11-Eleven at 6800 W Brown Deer Rd.

Ms. Cancer Brown present on this item. She was a manager at Rocky Rococo's for 8 years (and worked there 15 years) as well as a couple of bars and lounges cooking. She will hire 3-4 cooks and, if she gets a liquor license, a few bartenders, security and servers. She will be open 8 am to midnight. This is in a strip mall. Security will be present from 9 pm to midnight. Ms. Upshaw moved, seconded by Ramandeep Kaur, for approval. There were no objections.

# 6. Discussion and possible vote on Simon Says Early Learning Center LLC at 5001 W. Mill Rd.

Ms. Desiree Simon present on this item. She recently bought the building to expand her childcare; the building was previously a childcare operation. She will be expanding her home childcare into commercial. Currently it's just her as the sole provider, but she will be hiring staff once she is in the bigger facility and she does have future employees ready to assist.

*Mr.* Erdmann asked her plans for the building itself, which has basically been abandoned for a year. She has hired contractors for snow removal and grass cutting. She will also be painting the building. He also asked about security on the dead-end street as there are concerns ranging from dumping to drag racing on that street section. The daycare will operate 5 am to midnight. She will have ADT security and also have staff present to monitor drop-off and pick-ups *Mr.* Erdmann moved to approve, seconded by *Mr.* Sandhawalia. There were no objections.

#### 7. Discussion and possible vote on Pure Lounge & Restaurant at 8531 W. Brown Deer Rd.

This application was withdrawn yesterday.
