There is a possibility that your application may be denied for one or more of the following reasons: The recommendation of the committee regarding the application shall be based on evidence presented at the hearing. Per MCO 85-4-4, unless otherwise specified in the code, probative evidence concerning non-renewal, suspension or revocation may include evidence of the following: failure of the applicant to meet municipal qualifications, pending charges against or the conviction of any felony, misdemeanor, municipal offense or other offense, the circumstances of which substantially relate to the circumstances of the particular licensed or permitted activity, by the applicant or by any employee or other agent of the applicant. If the activities of the applicant involve a licensed premises, whether the premises tends to facilitate a public or private nuisance or has been the source of congregations of persons which have resulted in any of the following: disturbance of the peace; illegal drug activity; public drunkenness; drinking in public; harassment of passers-by; gambling; prostitution; sale of stolen goods; public urination; theft; assaults; battery; acts of vandalism including graffiti, excessive littering, loitering, illegal parking, loud noise at times when the licensed premise is open for business; traffic violations; curfew violations; lewd conduct; display of materials harmful to minors, pursuant to s. 106-9.6; or any other factor which reasonably relates to the public health, safety and welfare, or failure to comply with the approved plan of operation. It is the intention of the Common Council to suspend or non-renew the licenses if objectors provide testimony related to the factors enumerated in MCO 85-4-4 that the Common Council finds to be true by a preponderance of the evidence and/or police reports are found to be true by a preponderance of the evidence. The police reports and other attached documents relating to objections to the license are a part of this notice and expressly incorporated in this notice. The licensee should be prepared to address these matters at the hearing.

Proof of warrant satisfaction or payment of fines must be submitted at the hearing on the above date and time. Failure to comply with this requirement may result in a delay of the granting/denial of your application.

Failure to appear at this meeting may result in the denial of your license. Individual applicants must appear only in person or by an attorney. Corporate or Limited Liability applicants must appear only by the agent designated on the application or by an attorney. Partnership applicants must appear by a partner listed on the application or by an attorney. If you wish to do so and at your own expense, you may be accompanied by an attorney of your choosing to represent you at this hearing. You will be given an opportunity to speak on behalf of the application and to respond and challenge any charges or reasons given for the denial. No petitions can be accepted by the committee, unless the people who signed the petition are present at the committee hearing and willing to testify. You may present witnesses under oath and you may also confront and cross-examine opposing witnesses under oath. This report is written by Police Officer Monreal, assigned to the License Investigation Unit, Days.

The Milwaukee Police Department's investigation regarding this application revealed the following:

1. On 09/13/2020 at 1:44am officers were dispatched to a Shotspotter call at 2307 N. 40th St. Responding officers observed a large crowd in front of Premier Sports Lounge, 4001 W. North Av, and located 3 vehicles parked in front that were struck by gunfire. The officers spoke with Deandre HARRIS who stated he was the owner of the business. HARRIS stated the business was closed and the officers could not enter. He did allow them inside but refused to show them the surveillance video.

2. On 10/12/20 at 11:30am, A call in meeting was held at the Third District Police Station with the applicant of 4001 W. North Avenue and members of the Milwaukee Police Department. During the meeting it was discussed how there was no cooperation between her employees and police, who wanted to obtain video surveillance, during a shots fired investigation. The applicant said the reports were incorrect and that all contacts would be documented. She also said that in the future she has no problem allowing police to view her cameras.
3. On 11/05/20 at 5:00pm, A person walked into the Third District Police Station to report a false imprisonment/armed robbery complaint which began at 4001 W. North Avenue. Investigation revealed that on 11/01/20 at 1:00am a subject was drinking at the tavern and later being in a vehicle with three females. The females drove the subject throughout the city punching, stabbing, pistol whipping, and making her withdrawal money from an ATM. The subject was able to escape, flag down Milwaukee Police and received medical treatment.

4. On 03/07/21 at 1:09am, Milwaukee Police, along with the health department, conducted a license premise check at 4001 W. North Avenue. Upon arrival, officers and the health department workers attempted to open the front door but it was locked and a female answered the door by barely opening it not allowing anyone to see inside. The health department employee stated why they were there and the female closed the door and locked it without letting anyone inside. Officers then heard a female get on a microphone and tell patrons inside to "put on their masks" and the owner to talk with police. The front door was then unlocked and the applicant was reluctant to let officers and the health department inside. After the applicant allowed police and the health department inside, they saw a lot of people inside the establishment and most were not wearing masks and social distancing. Officers also observed what appeared to be more people inside the location then capacity allows (80 persons). After leaving the location the health department officials said that they would be issuing citations totaling around \$12,000.00.

5. On 05/27/21 at 1:09am, Milwaukee Police observed a large fight in front of 4001 W. North Avenue. Approximately 20 people were actively fighting, including tavern staff, which required 15 squads to disperse the crowd. After the crowd was dispersed, officers conducted a license premise check and found that most of the staff was uncooperative and argumentative regarding their investigation. The manager could not provide officers with any license information and there were no licenses posted. Investigation into the fight revealed that the manager had struck a female inside the establishment and the fight spilled out into the street. While talking outside with the victim/witness, multiple staff exited the business and began to fight with the victim a second time and the manager battered the victim a second time. The manager was arrested.

6. On 09/11/21 at 8:24pm, Milwaukee Police conducted a license premise check at 4001 W. North Avenue. Staff voiced an issue with the police department taking their security equipment on a different issue and requested that police keep driving around the area during tavern hours to keep vehicles secure and safe.

7. On 11/02/21 at 11:42pm, Milwaukee Police conducted a license premise check at 4001 W. North Avenue. When walking up to the tavern, officers observed approximately 70 vehicles surrounding a 1 block radius of the establishment and patrons were parking in a vacant field northeast of the tavern. The security guard/DJ refused to answer questions regarding the capacity and initially ignored officers when told to turn down the music and instruct patrons to exit the front door for a capacity check. The applicant approached officers and was reluctant to let officer in the establishment and said she was not over capacity because her capacity is 180 patrons (LIRA has the tavern capacity at 80 patrons). The manager of the tavern attempted to close the front door on officers and was uncooperative with the investigation. Officers, using a hand-held counter, counted 86 total persons inside the establishment (this does not include the patrons who were seen by officers exiting through a back hallway). Officers interviewed a patron who stated the tavern was allowing people in the upstairs private residence and back patio. The applicant was issued a citation.

8. On 11/09/21 at 2:15pm, Milwaukee Police, along with an Assistant District Attorney, held a meeting with the building owner of 4001 W. North Avenue. The meeting was in regards to the tavern, located on the first floor of the building, was allowing patrons into the apartment above the establishment. The owner stated that his wife is the applicant of the tavern and that they do not allow patrons upstairs which is a vacant apartment.
9. On 11/10/21 at 10:24pm, Milwaukee Police conducted a license premise check at 4001 W. North Avenue. When officers approached the front door, the security guard physically stop the door from opening and told officers that they could not enter. The security guard did eventually let officers in but was argumentative on why the police were there. The owner of the building was given a citation for the incident in Item #7 and when officers were retrieving his information, he told officers that he lives above the establishment. It should be noted that he told officers and an Assistant District Attorney in Item #8 that the upstairs is vacant.
10. On 11/14/21 at 3:48am, Milwaukee Police received a 911 call stating that a subject was shot at 4001 W. North Avenue but was currently at a different location. Investigation revealed that the subject was shot outside after leaving the tavern. During the investigation, the applicant and owner were uncooperative and argumentative with police and it is unknown if any argument or altercation stemmed from inside the tavern.
11. On 12/29/21 at 12:28am, Milwaukee Police conducted a license premise check at 4001 W. North Avenue. During the check, officers observed two females being escorted out by security who were yelling about something that happen inside the tavern. Security told police that the argument started inside the tavern and asked police to have the females removed from the property. Both females walked away from the property when asked by police.
12. On 06/17/22 at 12:55am, Milwaukee police were dispatched to 4001 W. North Avenue for a battery complaint. Investigation revealed that one of the security guards' uncle punched her in the face because she was kicking him out of the tavern for arguing with his girlfriend. The battery occurred outside and the uncle was issued a citation. Officers interviewed the owner who said the altercation had nothing to do with the tavern and was upset police were inside the establishment. He showed officers his current licenses, which were inside a drawer behind the bar and had expired licenses displayed behind the bar. The owner was told to display his updated licenses.
13. On 07/01/22 at 1:35am, Milwaukee Police conducted a license premise check at 4001 W. North Avenue. Officers interviewed the owner and asked if they could see where he keeps all his alcohol and the boxes they came in. The owner said all the alcohol he purchased is on the shelf and he buys by the bottle from Badger Distributing.
14. On 10/08/22 at 2:00am, Milwaukee Police, while on patrol, observed a male lying in the street, bleeding from the head, in the 4000 block of W. North Avenue. A large crowd leaving the tavern at 4001 W. North Avenue were stating that the male was assaulted due to an incident that happen inside the tavern. The staff of the tavern locked the doors and refused to speak to officers regarding the incident.
15. On 10/09/22 at 12:59am, Milwaukee Police conducted a capacity check at 4001 W. North Avenue. Security was uncooperative with police and they had to find the owner in order to get cooperation from the employees. Police counted 75 patrons and employees which is in compliance with their capacity of 80.

16. On 11/06/22 at 1:04a.m., Milwaukee Police were dispatched to a Trouble with Subject at 4001 W. North Av. Investigation revealed an intoxicated subject was causing a disturbance inside the bar, and was advised they had to leave. The patron became upset over the \$10.00 cover charge and wanted their money back. The security guard gave the patron \$20.00 to leave.

17. On 07/08/23 at 2:30a.m., Milwaukee Police were advised to monitor bar close at 4001 W. North Av., due to a large number of people exiting and loitering. Upon the officer's arrival at approximately 2:40a.m., they observed vehicles blocking lanes of traffic, as well as groups of people standing in the street. The officers activated their squad lights to clear the roadways. Officers continued to monitor the bar and could see a large projection screen still playing a sports game and subjects outside the front door smoking. At approximately 2:50p.m., the officers observed at least 5 individuals exit the bar. Officers advised dispatch they would be conducting a License Premise Check. The officers observed two individuals seated at the bar, two behind the bar, one of which was holding a liquor bottle, and another in the main bar area. The officers were advised that all the remaining subjects were employees, and the projection screen was still on, because it did not have sound. The officers also observed an individual smoking hookah, and were advised by employees they would allow the individual to continue smoking, because the subject paid for it. The officers informed all of the subjects who stated they were employees, they would need their information for the tavern report, to which officers were met with anger, yelling, and a complete lack of cooperation. The agent eventually stepped in and advised the employees to give the officers their information. Once the officers advised the agent the reason for the License Premise Check, a subject who claimed to be the owner told the officers they could not conduct a License Premise Check since it was after bar close, and they could conduct it after 4a.m., when everyone was gone. The agent stated they were not operating after bar close as it was only 2:50a.m., and they were in the process of closing. The officers did not observe any security guards, nor did they review video surveillance.

18. On 12/01/23 at 10:41p.m., Milwaukee Police conducted a License Premise Check at 4001 W. North Ave. No violations were found and the business was cooperative.

19. On 05/16/24 at 1:17a.m., Milwaukee Police conducted a License Premise Check at 4001 W. North Ave. No violations were found and the business was cooperative.

20. On 06/13/24 at 12:22a.m., Milwaukee Police conducted a License Premise Check at 4001 W. North Ave. No violations were found and the business was cooperative.

21. On 06/24/24 at 12:23a.m., Milwaukee Police were dispatched to a Noise Nuisance at 4001 W. North Ave. On arrival the business was closed, however, the initial call came in at 06/23/24 at 10:14p.m. Officers spoke to the caller who stated an event took place on the patio earlier, however, the loud music ended when the establishment closed.

22. On 08/07/24 at 10:22p.m., Milwaukee Police were dispatched to a Noise Complaint at 4001 W. North Ave. On arrival the officer did not hear any loud music emanating from the patio or the establishment. The officer remained in the area for a while, however, no loud music was observed. (2 reports)

23. On 08/22/24 at 2:34a.m., Milwaukee Police were dispatched to a Shooting at 4001 W. North Ave. Investigation revealed there was a verbal altercation between security and multiple patrons, when one patron retrieved their firearm and fired multiple shots, causing the death of one security guard, and injuring another, as well as two patrons. The security officers were unarmed, however, after the shooting, one security guard went to their vehicle and retrieved their firearm. The security guard was arrested for Possession of THC (55.84g). All employees were cooperative with the investigation, with the exception of a bartender. The manager was advised of this and the negative impact it could have on the business. The manager was cooperative and allowed officers to view video surveillance of the incident.
24. On 09/09/24 at 10:45p.m., Milwaukee Police were dispatched to a Noise Nuisance at 4001 W. North Ave. On arrival officers observed security guards and customers outside, however, the music or conversation was not too loud. The officers circled the area and found the noise to be at a bare minimum. The officer was unable to contact the caller. (2 reports)
25. On 09/19/24 at 12:51am., Milwaukee Police conducted a License Premise Check at 4001 W. North Ave. No violations were found and the business was cooperative.
26. On 11/01/24 at 1:10a.m., Milwaukee Police conducted a License Premise Check at 4001 W. North Ave. Officers observed an unarmed security officer, wandering patrons upon entry. No violations were found and the business was cooperative.
27. On 11/03/24 at 1:53a.m., Milwaukee Police were on patron in the area of 4001 W. North Ave., when they observed a large number of vehicles parked around the area and on grass. Due to this being the only open business open in the area, the officers conducted a capacity check of the business. The manager stated they did not know the allowed capacity but knew they were over by a lot. The business capacity is 80, however, utilizing a clicker a total of 113 patrons, excluding employees were on the premise. The manager provided the officer with a license for the address of 4005 W. North Ave., with a capacity of 198, however, it was not in the agent's name. The officer found the wall that divides the two address no longer exists. The officer did not issue a citation for the over capacity violation, pending further investigation. The only other violation observed was Hookah product being sold without a tobacco license. The business was initially uncooperative, however, eventually cooperated with the exception of a few employees.

SCENE DESCRIPTION/INITIAL OBERVATIONS:

4001 W North Ave - is Tavern with the main entrance located on the northeast corner of the building exiting onto W North Ave and N 40th St. There is an additional exit that is located on the east side of the building. Upon entry there is an open area with the bar located to the west of the main entry. Far east is an additional lounging area. To the south of the bar is a hall that leads to the rear of the building that exits to an outdoor area set up with tables and chairs enclosed with a privacy fence. The kitchen of the establishment is located west of the bar counter with an exit door to the far south of the kitchen. The incident took place outside of the establishment on N 40th St, east of the property on the sidewalk. The establishment has multiple cameras around the property, and one was located on the east of the building.

Upon arrival, I observed a victim, later identified as David C. ANDERSON (b/m 7/26/1986), who was an employee of PREMIER as a security officer. ANDERSON was located on the ground a few feet from the main entry to the establishment. ANDERSON's injuries were severe, and he

Upon entry, I observed an additional victim, who was later identified as Christopher I. WALKER (b/m 7/21/1995, who is also employed by PREMIER as a security officer. WALKER was located inside the bar, sitting in the lounge area to the east of the bar area. WALKER suffered from a single gunshot wound to the chest and was conveyed to St. Joseph's Hospital for medical attention. Detective reports revealed, the video at the bar showed that WALKER was in possession of a firearm after the shots were fired. WALKER was confronted about this, and he then admitted that after the shots were fired, he went to his vehicle and retrieved his firearm. He then went into the bar with the gun and put it on the bar. He stated he did not know where his gun was at this time. WALKER was also arrested for possession of THC (55.84g)

Two additional victims were located at St. Joseph's Hospital. They were only patrons at the establishment. These victims were identified as:

- Michelle A. WATSON (b/f 5/2/1994), located in ER Room 26, suffering from a gunshot wound, through and through, to the right forearm which broke bone.
- Brittany M. DEZEK (b/f 6/5/1987), located in ER Room 6, suffering from a gunshot wound to the right forearm and a gunshot wound to the left thigh.

I spoke to a witness/ bartender, who verbally identified herself as Latoya T. RAGLAND (b/f 8/11/1982). RAGLAND stated she is a bartender for Premier Sports Lounge and was working at the time of the incident. RAGLAND stated she knows ANDERSON and WALKER due to being employed for the same company. RAGLAND stated she was outside at the time of the incident and witnessed a verbal altercation between the security officers and multiple patrons refusing to leave after they were escorted out due to bar close. RAGLAND stated she remembers a male and female subject specifically due to their violent remarks. RAGLAND stated she remembers the female subject state something along the lines of "grab the gun" before the incident occurred. RAGLAND stated she did not see the firearm but heard approximately 3 to 4 shots go off and seen the flash of the gun going off. RAGLAND stated she remembers the male subject with the firearm. RAGLAND stated she observed ANDERSON fall to the ground and ran inside.

RAGLAND gave the subjects description as follows:

- Black, Male, approximately 20-30 years old, approximately 5'07"-5'09" tall, light complexion, thin build, short haircut, light beard, wearing a pink tee with a white "M" on it, and white and pink shorts armed with a handgun.

- Black, Female, approximately 20-30 years old, approximately 5'07", heavy build, wearing a black wig with blonde streak cut in a short bob, glasses, wearing a black top and blue jeans.

RAGLAND gave a suspect vehicle of a white dodge caravan or minivan which was parked on N 40th St.

Once all Squads were on scene at approximately 1:04am (Daylight Savings, fall back, time has changed at this time), Squad 3312 parked on W North Ave facing eastbound in front of the location. 3368 blocked southbound traffic on N 40th St. 3451 blocked eastbound traffic from N 41st St and W North Ave. 3352 blocked eastbound traffic from N 40th St and W North Ave. 3321 was staged in the alley on the south side of the establishment tasked to watch the rear and east door of the location.

All Squads activated their Axon Body Worn Cameras as we approached the main door, which is located on the north-east side of the establishment exiting onto W North Ave. We observed a few subjects standing outside the front door. While on scene, we observed the licenses posted behind the bar and up to date.

During the investigation we did observe violations in the licensed premise. The violations noted were:

1. Licensed Establishment – Exceeding Occupy Limit (ORD: 85-23-4-a)
2. Establishment is serving hookah product that contains nicotine without a tobacco license. (ORD: 84-43-2)

HARRIS was advised to correct these violations, and a follow-up will be conducted to ensure the Tavern is operating up to code.

Video surveillance footage was not requested due to the investigation not being a major incident; however, HARRIS has been cooperative in obtaining surveillance video in the past.
