Per MCO 85-4-4, unless otherwise specified in the code, probative evidence concerning non-renewal, suspension or revocation may include evidence of the following: failure of the applicant to meet municipal qualifications, pending charges against or the conviction of any felony, misdemeanor, municipal offense or other offense, the circumstances of which substantially relate to the circumstances of the particular licensed or permitted activity, by the applicant or by any employee or other agent of the applicant. If the activities of the applicant involve a licensed premises, whether the premises tends to facilitate a public or private nuisance or has been the source of congregations of persons which have resulted in any of the following: disturbance of the peace; illegal drug activity; public drunkenness; drinking in public; harassment of passers-by; gambling; prostitution; sale of stolen goods; public urination; theft; assaults; battery; acts of vandalism including graffiti, excessive littering, loitering, illegal parking, loud noise at times when the licensed premise is open for business; traffic violations; curfew violations; lewd conduct; display of materials harmful to minors, pursuant to s. 106-9.6; or any other factor which reasonably relates to the public health, safety and welfare, or failure to comply with the approved plan of operation. No petitions can be accepted by the committee, unless the people who signed the petition are present at the committee hearing and willing to testify. You may present witnesses under oath and you may also confront and cross-examine opposing witnesses under oath. If you have difficulty with the English language, you should bring an interpreter with you, at your expense, so that you can answer questions and participate in your hearing.

This call was later determined to be a disorderly conduct. Upon arrival I spoke with the caller/employee identified as Anttanye V HAYES (b/f 1-27-1998 #4146981397). HAYES stated she got into an argument with a customer regarding a food order. HAYES stated the customer brushed by her on her way out and she felt that the customer did this intentionally to cause a disturbance. The location has video that was accessible by one manager who was not on scene.

License Premise owner not available. The employees were cooperative. No security at the location.

While on scene, I observed the licenses posted and they were up to date. During my investigation for CALL TYPE 1632 I did not observe any violations in the licensed premise

Per the district community partnership unit this location is not designated a nuisance premise.

This report was written by Police Officer Ahnoki DOXTATOR, District 6, Early Shift assigned to Squad 6220.

On Tuesday October 17, 2023, PO Raymond PORCHIA and I responded to 3161 S 76th St., which is located in the City and County of Milwaukee, for a Subject with Gun assignment. We arrived on scene at 5:11pm in full uniform with activated Axon 3 body worn cameras and in a marked squad.

#### UPON ARRIVAL AND WITNESS INTERVIEW

Upon arrival I was met by Nancy RIVERA who stated she was parked in front of the location, waiting for her food. RIVERA stated she observed two Black males, maybe teenagers arguing outside of the store in front of her vehicle. RIVERA stated one male was wearing a tan jacket or hoodie and jeans. RIVERA stated this male pulled out a gold handgun and started waving at the other subject. RIVERA stated she then moved her vehicle to a different location of the parking lot in fear of getting shot. RIVERA stated she then observed the subject with the handgun run northbound on S 76th St toward W Oklahoma Av.

#### MANAGER DANIEL M MIRANDA

Restaurant Manager Daniel M MIRANDA (W/M DOB 02/23/1993) spoke with PO PORCHIA. MIRANDA witnessed the event and supplied Police with the identity of both the subject and victim, employees. MIRANDA stated there was no video of the incident.

Suspect - Jalen M PRIMER (12/25/2003) Victim - Jamari O JONES (B/M DOB 03/14/2006)

We then checked the area for both the victim and subject and did not locate either person.

On October 17, 2023, at 8:11 pm PO PORCHIA and I were dispatched to Children's Hospital for a Battery assignment (CAD 232901265) that occurred at the Little Caeser's. We arrived on scene at 8:34pm in full uniform with activated Axon 3 body worn cameras and in a marked squad car.

On scene we met Dr Kyle KINDERMAN who stated JONES received a laceration just behind his left ear and was receiving stitches. Later it was told to Police by the Dr that JONES received 20 stitches.

STATEMENT OF JAMARI O JONES

JONES stated PRIMER and he were working at Little Ceasars Pizza when JONES and PRIMER engaged in an argument. JONES state PRIMER was taking the pizzas out of the pan incorrectly and JONES wanted to show PRIMER how to correctly remove the pizzas. JONES stated PRIMER got angry and defensive and told JONES that he was doing it right and he was going to beat JONES up. JONES stated the two continued to argue and PRIMER started making "pop pop" noises meaning he was going to shoot JONES. JONES stated PRIMER made threats to "Pop" JONES after work.

JONES stated he and PRIMER both got out of work at 5:00 pm. JONES stated after work while outside of the building JONES threw his hands up toward PRIMER re-engaging the argument.

JONES stated PRIMER then became beligerent with JONES, and JONES returned the conduct. PRIMER then retrieved a tan colored "GLOCK" possibly with an extended magazine from his waistband. PRIMER began to tell JONES that he is going to "Pop" JONES. JONES stated he attempted to retreat into the store, but PRIMER followed JONES into the store. PRIMER then is standing in the doorway waving and pointing the firearm at JONES. PRIMER then strikes JONES in the head with the firearm causing pain and injury.

JONES runs from the area because he was fearful of getting shot. PRIMER fled the area also. JONES then has his guardian Patricia BOND-JONES (B/F DOB 10/06/1953) who is his great aunt took him to Children's Hospital. JONES was admitted to Children's Hospital at 6:12 pm.

PO PORCHIA took photos of JONES while at Children's Hospital.

PER LT BENNETT SCD stated the case is ours to handle.

PO PORCHIA and I along with Squad 6250 PO Bradley JOHNSON and PO Daniel DREWEK went to PRIMER's listed address which is also the address MIRANDA supplied of 3915 S 76th St. #3. Benita KEITH (B/F DOB 06/01/1965) answered the door and stated PRIMER is her son. KEITH stated PRIMER was not home but at his friend's house. KEITH stated she does not know where or who the friend is or lives. The apartment was checked with KIETH's permission and PRIMER was not located.

Temporary Felony/Suspect Alert want was submitted.



Those wishing to provide oral testimony via internet are asked to contact the staff assistant, Yadira Melendez at (414) 286-2775 or stasst5@milwaukee.gov for necessary information. Please make such requests no later than one business day prior to the start of the meeting. You are not required to attend the hearing, but please see the information below if you would like to provide testimony. Once the Licenses Committee makes its recommendation, this recommendation is forwarded to the full Common Council for approval at its next regularly scheduled hearing.

# Important details for those wishing to provide information for the Licenses Committee to consider when making its recommendation:

- 1. The license application is scheduled to be heard at the above time. Due to other hearings running longer than scheduled, you may have to wait some time to provide your testimony.
- 2. You must appear in person and testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)
- 3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are present at the committee hearing and willing to testify).
- 4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.
- 5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)

- 6. You may then provide testimony.
- a. Include only information relating to the above license application.
- b. Include only information you have personally witnessed or seen.
- c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.
- d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.
- 7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.
- 8. Business Competition is not a valid basis for denial or non-renewal of a license.

Please Note: If you have submitted an objection to the above application your objection cannot be considered by the committee unless you personally testify at the hearing.
