- 3. On 04/29/07 at 10:41pm, officers were dispatched to 4209 W. Silver Spring Dr. for an armed robbery complaint. Officers spoke with an employee of the store who stated a patron was robbed of his wallet while in the parking lot of the business. Investigation revealed after the victim left the store and attempted to enter his vehicle, he was approached by the suspect that forcibly removed his wallet from his pants pocket.
- 4. On 09/06/08 at 12:05am, officers investigated an Armed Robbery that occurred at 4209 W. Silver Spring Dr. The victim stated to the officers that he and two friends went to the Marathon gas station for some snacks. On 03/29/2017 Milwaukee police, while on routine patrol, were flagged down by citizens who reported a male had just been shot while inside a vehicle at the gas station at 4209 West Silver Spring Drive. Officers discovered a red minivan parked at the gas pump with holes in the windows and a male inside the vehicle with multiple gunshot wounds. This male subsequently expired. Milwaukee police incident report #170880130 filed.

11. On 01/16/20 at 2:29am, Milwaukee Police were dispatched to 4209 W. Silver Spring Drive for a shots fired complaint. Investigation revealed that a vehicle pulled up to the pumps and the occupant got out and went into the establishment. While inside, another vehicle enters the parking lot and does a U-turn, driving slowly past the entrance to the store. The occupant of the first vehicle then exits the store, pulls out a firearm from his coat pocket, and shoots seven times at the second vehicle as it was driving on W. Silver Spring Drive. The incident was captured on distorted video surveillance and the employee of the filling station said he observed the incident but did not call police.

- 12. On 08/09/20 at 10:51am, Milwaukee police were dispatched to 4209 W. Silver Spring Dr. for property damage complaint. Officers spoke with the clerk who stated that he refused services to a group of ten younger males. Subjects from the group attempted to purchase tobacco products and refused to show identification to verify age. When the group left the store some subject from the group threw an object at the window damaging the window. Subjects from the group also made threats to come back and rob the store. Officers checked the area but did not locate the subjects. The clerk stated that he would provide police a video copy of the incident.
- 13. On 08/31/20 at 9:46pm, Milwaukee police were dispatched to 4209 W. Silver Spring Dr. for an armed robbery complaint. Officers spoke with employees who stated that an unknown subject attempted to take merchandise without paying for the items. The clerk attempted to stop the suspect who then pulled out a hand gun and pointed it at the clerk. The clerk locked the entrance door and both employees went to the enclosed register area. The suspect attempted to get into the register room by pounding on the door. The suspect stated that he would shoot

the employees if they did not open the front door. The suspect damaged the front door and fled the area on foot. Officers obtained video of the incident and the gas station employees were cooperative with the investigation.

14. On 10/25/20 at 2:00am, Milwaukee police were dispatched to 4209 W. Silver Spring Dr. for a shooting complaint. Officers spoke with the clerk who stated that he heard 4 shots being fired and a bullet stray damaged the gas station window. The clerk stated after the shots were fired he observed a gold 4dr vehicle leave the scene. Officers were updated through police dispatch that a shooting victim in a gold vehicle arrived at Froedtert Hospital. Officers spoke with the victim who stated that she was at the gas station located at 4209 W. Silver Spring Dr., to fight another female. While in the gold vehicle at the location, a gray 4dr vehicle arrived with four male subjects. Gun shots were fired from the suspect vehicle, into the gold vehicle. The victim stated that she left the area and then noticed she had a gunshot wound to the leg area. The victim was driven in the gold 4dr vehicle to the hospital for medical treatment.

- 15. On 10/30/22 at 5:558am, Milwaukee Police were dispatched to a battery complaint at 4209 W. Silver Spring Dr. Officers spoke with the store clerk who stated that he was grabbed by his head and neck by an unknown suspect. The store clerk stated that two subjects entered the store and the female subject was concealing items under her shirt. The clerk left the cash register area and told the subject he would have allowed her have some items if they asked. The male suspect then grabbed the store clerk by the neck/head, because of the comment made. The subjects then left the store, the clerk was just wanted charges issued regarding the battery. The store clerk provided video of the subjects to the officers, and would email them the video clip.
- 16. On 05/15/23 at 11:00p.m., Milwaukee Police were dispatched to a Property Damage at 4209 W. Silver Spring Dr. Investigation revealed unknown subjects threw a rock at a window, causing damage. The employees were cooperative with the investigation.
- 17.On 05/19/23 at 11:23p.m., Milwaukee Police were dispatched to a Property Damage at 4209 W. Silver Spring Dr. Investigation revealed unknown subjects attempted to break a window by throwing rocks. There was no video surveillance as the caller believes the suspects moved the camera to point at the ground. The employees were cooperative with the investigation.

- 25. On 11/13/23 at 7:28p.m., Milwaukee Police were dispatched to an Armed Robbery at 4209 W. Silver Spring Dr. Investigation revealed a patron was exiting the business when they were approached by two suspects armed with a handgun demanding keys to the victim's vehicle. The suspects then fled the scene with the victim's vehicle. The business was cooperative with the investigation and allowed officers to view video surveillance of the incident.
- 26. On 04/06/24 at 9:02p.m., Milwaukee Police were dispatched to a Trouble with Subject at 4209 W. Silver Spring Dr. On arrival officers observed a large group of juveniles causing a disturbance, however, this was unrelated to the call for service. ultimately taken over by CIB after we secured the scene.

Upon arrival I met with the victim, identified as Emma J. COFFEE (B/F DOB 2-9-1965) who stated she was at the BP gas station getting gas when two unknown back males approached her. COFFEE stated suspect one is a heavy build black male approximately 5'9" and 240lbs wearing a black coat, black sweatpants with white strips on the sides pulled a gun on COFFEE and stated for her to hand over her keys, money and debit card. COFFEE stated suspect two who is a slim build black male approximately 5'7" 150lbs wearing a black nike baseball hat, black sweatshirt, blue jeans and blue shoes. Took COFFEE's vehicle which is a 2022 Volkswagen Tiguan SUV silver in color with WI plate ANX-2338 which headed southbound on N. 42nd Ave.

Upon speaking with staff at the location, they were accommodating and helpful and assisted me in acquiring video footage of the incident.

From Detective Stolowski supplemental report:

Camera 4 captures the suspect vehicles a Mazda and Hyundai pull onto the lot at 6:49 am. The driver of the Mazda, who has been referred to as Suspect #2 in initial report, was observed to exit the vehicle and attempt to pump gas into the Mazda. Suspect #2 was observed to be a light brown complexion, male, facial hair beard and mustache; wearing a blue baseball hat with a large white Nike logo in the center of hat, dark hooded sweatshirt, lighter denim jeans and light blue sneakers with darker strips. Suspect #2 appears to be having difficulty getting the gas pump to work and can been seen inserting credit cards into the gas pump a pump 2 and pump 1. Suspect #2 does go inside the store to talks with the clerk inquiring as to why the pump wasn't working. The driver of the Hyundai, referred to as Suspect #3 in initial report, exits and goes to pump 2 to assist. Suspect #3 is observed to be a black male, long dread locks pulled back and secured near nap of neck, medium build; wearing a red hooded sweatshirt, dark pants and red sneakers. Camera 4 captures the victims vehicle pull onto the lot at 6:55 am as she drives entering from the east and pulls around to park at pump 5. The victim exits her vehicle and walks into the store. When the victim returns to this camera view she walks to the rear passenger side along with pump and starts pumping gas. The passenger of the Mazda who had not previously exited the vehicle now exits and is observed with what appears to be a gun in the left hand. As this passenger suspect exits the gun is placed into a pocket in the center of the hooded sweatshirt. This passenger suspect has been referred to as Suspect #1 in initial report. Suspect #1 is observed wearing a black hooded sweatshirt with white design on the back, black pants with white strips down each leg. Suspect #1 walks around the pumps and towards the victim from the north side and Suspect #2 walks towards the victim walking around the south side of the pumps. Suspect #3 remains in the Hyundai during this and appears to have the vehicle in drive because the vehicle is creeping forward during portions of the robbery. Suspects #1 & #2 approach the victim at time stamp 7:00:28. The Suspect #1 and #2 are seen with the victim at the driver door for some time which is consistent with the victim's report of the suspects had a difficult time figuring out how to operate her vehicle. All three vehicles, Hyundai, Victim's Volkswagen and Mazda all flee the gas station and driver south bound on N. 42nd St out of this camera angle.

I reviewed video footage of the incident and provided KEMKA with a link to evidence.com to upload the video. The video depicted 3 suspects described as follows:

- Suspect 1 B/M, 16-23 years old, 5'08", 150lbs, wearing a black hoody, purple pants w/ a vellow vertical stripe, white shoes.
- Suspect 2 B/M, 16-23 years old, 5'10", 160lbs, wearing a purple hoody w/ black lives matter on the front, black Addidas pants w/ 3 vertical stripes, white shoes.

On Monday November 13th, 2023, at approximately 7:28 PM, Sergeant Robert WENGER instructed me to respond to the address of 4209 W Silver Spring Dr (BP Gas Station), located in the City and County of Milwaukee, to investigate an armed robbery carjacking complaint.

#### **Synopsis**

On 11/13/2023 at approximately 6:26 PM an armed robbery incident occurred at the address of 4209 W Silver Spring Dr (BP Gas Station), located in the City and County of Milwaukee. During the incident the victim, Clifton MCKNUCKLES Jr (B/M, 03/07/1987) reported to the Milwaukee Police Department that his vehicle, that he parked his vehicle, a black 2017 Dodge Durango, WI plate # AKU5748. VIN # 1C4RDJDG2HC926113 at the gas station, MCKNUCKLES stated he entered the gas station to purchase items and exited a couple of minutes later. MCKNUCKLES stated as he was walking back to his Durango, suspect # 1 and suspect # 2, who were standing along the east wall of the gas station, approached him. MCKNUCKLES stated suspect # 1 was armed with a grayish green semi-automatic handgun which was pointed in his direction. MCKNUCKLES stated suspect # 1 demanded keys to his Durango from him multiple times, which suspect # 1 removed from MCKNUCKLES' hand. MCKNUCKLES stated suspect # 1 entered the front driver seat and suspect # 2 entered the rear driver seat. MCKNUCKLES stated the Durango fled south bound on N 42nd St.

The address of 4209 W Silver Spring is equipped with video surveillance which confirmed MCKNUCKLES' statements. The surveillance cameras depict suspect # 1 and # 2 along with three additional suspects (five total) enter the gas station together. The five suspects then exit the gas station and stand on the northwest corner of N 42nd St and W Silver Spring Dr. After MCKNUCKLES arrived on scene, suspect # 1 and # 2 split from the group and stand by the east wall of the gas station until they commit the robbery. Meanwhile suspect #3, #4, and #5 walk southbound on N 42nd St, the same direction the Durango drove after committing the robbery a minute later.

On 11/13/2023 at approximately 9:06 PM, Squad 765 (Police Officer Mark DILLMAN and Police Officer Nicholas ROMEO), who were fully uniformed Milwaukee Police Officers and operating a

marked Milwaukee Police Department squad car, initiated a vehicle pursuit of the Dodge Durango. The pursuit began at the address of N Teutonia and W Cornell St, which is located in the City and County of Milwaukee. During the vehicle pursuit, the Durango drove at speeds in excess of 90 miles per hour, drove through construction and into oncoming traffic, and disregarded numerous traffic signals. The pursuit ended when the Durango came to a stop after 8.04 miles at 9:21 PM at the address of 8247 W Bender Av, which is located in the City and County of Milwaukee. A total of six occupants were in the Dodge Durango, five who exited and fled on foot. Several subjects were arrested.

I, PO Brett Stegerwald did speak with Satwinder Singh (a/m,10/14/80), who was the working clerk at the gas station, who stated he physically did not witness this incident.

He did allow me to check video.
