Dear Mr. Bolds:


We have received your claim in the amount of \$1,007.44, relating to damage sustained to your vehicle on or about March 16, 2005 wherein you allege it was due to a City Fire truck/hose, at 2634 North 46<sup>th</sup> Street.

Our investigation reveals the Milwaukee Fire Department (MFD) reviewed their records and found they responded to an incident at 2654 North 46<sup>th</sup> Street on March 17, 2005. This appeared to be the only incident they responded to for the approximate date and location in question. The MFD personnel on scene recall seeing a previously and recently damaged vehicle on the street prior to them performing any maneuvers with their vehicle. Since you provided no specific evidence the MFD caused your loss, the City cannot accept liability and we are denying your claim.

If you wish to appeal this decision, you may do so by sending a letter within 21 days of the date of this letter to the Milwaukee City Clerk, 200 East Wells Street, Room 205, Milwaukee, Wisconsin 53202, requesting a hearing.
