There is a possibility that your application may be denied for one or more of the following reasons: The recommendation of the committee regarding the application shall be based on evidence presented at the hearing. Per MCO 85-4-4, unless otherwise specified in the code, probative evidence concerning non-renewal, suspension or revocation may include evidence of the following: failure of the applicant to meet municipal qualifications, pending charges against or the conviction of any felony, misdemeanor, municipal offense or other offense, the circumstances of which substantially relate to the circumstances of the particular licensed or permitted activity, by the applicant or by any employee or other agent of the applicant. If the activities of the applicant involve a licensed premises, whether the premises tends to facilitate a public or private nuisance or has been the source of congregations of persons which have resulted in any of the following: disturbance of the peace; illegal drug activity; public drunkenness; drinking in public; harassment of passers-by; gambling; prostitution; sale of stolen goods; public urination; theft; assaults; battery; acts of vandalism including graffiti, excessive littering, loitering, illegal parking, loud noise at times when the licensed premise is open for business; traffic violations; curfew violations; lewd conduct; display of materials harmful to minors, pursuant to s. 106-9.6; or any other factor which reasonably relates to the public health, safety and welfare, or failure to comply with the approved plan of operation. It is the intention of the Common Council to suspend or non-renew the licenses if objectors provide testimony related to the factors enumerated in MCO 85-4-4 that the Common Council finds to be true by a preponderance of the evidence and/or police reports are found to be true by a preponderance of the evidence. The police reports and other attached documents relating to objections to the license are a part of this notice and expressly incorporated in this notice. The licensee should be prepared to address these matters at the hearing.

Proof of warrant satisfaction or payment of fines must be submitted at the hearing on the above date and time. Failure to comply with this requirement may result in a delay of the granting/denial of your application.

Failure to appear at this meeting may result in the denial of your license. Individual applicants must appear only in person or by an attorney. Corporate or Limited Liability applicants must appear only by the agent designated on the application or by an attorney. Partnership applicants must appear by a partner listed on the application or by an attorney. If you wish to do so and at your own expense, you may be accompanied by an attorney of your choosing to represent you at this hearing. You will be given an opportunity to speak on behalf of the application and to respond and challenge any charges or reasons given for the denial. No petitions can be accepted by the committee, unless the people who signed the petition are present at the committee hearing and willing to testify. You may present witnesses under oath and you may also confront and cross-examine opposing witnesses under oath. 2. On 09/19/23 at 8:51p.m., Milwaukee Police were dispatched to a Hold Up Alarm at 2029 N. Holton. Investigation revealed a subject was asked to leave and began to cause a disturbance, eventually trying to lock the door. The employee feared they were going to be robbed and pushed the alarm button. The subject was gone on police arrival. The two employees on scene stated they are not regular employees of the business but family members of the owner. One employee was hesitant to provide their information, however, eventually complied.
  3. On 06/05/24 at 3:47p.m., Milwaukee Police were dispatched to a Battery at 2029 N. Holton St. Investigation revealed subjects were arguing in the checkout line, when a suspect pushed the victim to the ground and pepper sprayed them. The business was cooperative and provided video surveillance.

This report was written by PO Nora BURLO, assigned to District Five, Late Power Shift. On 9/19/23, I was assigned to Squad 5468 along with my partner PO James TERRELL. On the listed date, at approximately 8:51PM, PO TERRELL and I were dispatched to a Hold Up Alarm at the address 2029 N Holton St, Pueblo Foods & Liquor, which is a licensed premise in the City of Milwaukee.

Prior to officer arrival the dispatched call read:

*MILWAUKEE ALARM COMPANY*

*CLLR STS THERE IS A HOLDUP ALARM AT THE LOC*

*CLLR STS THE ALARM CAME FROM A HANDHELD DEVICE ON A BELT BUCKLE WHEN UNDER DURESS*

Squad 5463 (PO Stephen ARNOLD and PO Nicholas SANDOVAL), Squad 953 (K9 unit Dereck VERNON), and Supervisor Squad 5413 (Sgt CORNEJO) responded to the location as well.

Upon officer arrival, PO TERRELL and I immediately made contact with a clerk/ employee, later identified as **Sharma ANUSHA (W/F, 4/6/88)** who stated she did not call officers and directed officers to speak with the second clerk/ employee, identified as **Kumar ABHISHEK (W/M, 3/31/91)** about what happened.

### INTERVIEW OF Kumar ABHISHEK:

ABHISHEK stated there had been a male and female subject (not currently on scene) who had been causing a disturbance inside of the store. He stated he thought the male subject might try to rob the store. He stated they ultimately left prior to officer arrival.

ABHISHEK stated a B/M subject and a W/F subject entered the store and asked to use the bathroom. ABHISHEK directed them to the bathroom in the rear of the store. He stated the two subjects entered the bathroom together and remained inside for a long period of time (approximately five minutes). ABHISHEK stated he then knocked on the bathroom door and told the two they needed to come out of the bathroom and leave the store. He stated the two did exit the bathroom but the male subject was agitated when he exited.

ABHISHEK stated the two then walked to the front of the store and the male subject began to yell at customers inside of the store and was making threats. The male subject yelled for the other customers to leave the store. ABHISHEK stated he was worried the male subject was going to try to rob the store, so he pressed the handheld alarm. He stated the female subject was trying to tell the male subject to "stop" and was attempting to get him to calm down and stop yelling. The male subject then walked close to the front door of the location and the female subject walked near him, the male subject then attempted to lock the door. The female subject said "let's go" to the male subject. At that point, ABHISHEK walked close to the two subjects and pushed them out of the store. He then closed the doors and locked them.

ABHISHEK stated the two subjects never demanded any money or approached anyone in a threatening manner. He stated the two appeared drunk but their behavior still concerned ABHISHEK. He stated the two

ultimately left the location in a vehicle (new smaller model white sedan) that he last saw heading S/B on N Holton St.

## INTERVIEW OF Sharma ANUSHA:

ANUSHA stated a male subject and female subject went into the bathroom and remained inside of the bathroom for a long time. She stated ABHISHEK ultimately told the two to leave the bathroom. ANUSHA stated when the two exited the bathroom, the male subject was upset and began yelling at the customers inside of the store to leave. She stated the two subjects appeared drunk. ANUSHA stated the male subject tried locking the door of the store but ABHISHEK pushed the two out of the store and locked the door first.

## \*SUBJECTS DESCRIPTIONS\*

Male: B/M, approximately 40yrs of age, light skinned, tall, fat, short hair. The subject had a gap in his teeth. Wearing a blue and white jacket over a gray shirt w/ "ROGERS" logo, black pants and black shoes.

Female: W/F, approximately 40yrs of age, brown hair in a ponytail style. The subject was wearing glasses, gray long sleeve shirt w/ sleeves rolled up and "ROGERS" logo, black pants

Upon determining the two subject had left the store and had not attempted to rob the store, PO

TERRELL and I relayed the information to the assisting squads. Squad 5463 and Squad 953 then cleared from the assignment.

## LICENSE CHECK:

Upon identifying ABHISHEK and ANUSHA, both stated they are not regular employees at the location. Both stated they merely fill in when needed and are family members of the store owner. The two stated they do not work regular hours and do not have regular shifts.

ANUSHA did not want to provide her identifying information upon several requests from officers. She did ultimately provide her information however she repeatedly stated she did not know why we were requesting it.

PO TERRELL observed the posted licenses-

*Class A Malt & Liquor license (#0200418) which expires on 12/15/23, Food Dealer license (#0013461) which also expires on 12/15/23. Both licenses were observed to reference the Weights & Measures license (#0006885) along with the Cigarette license (#1031410). All licenses are up to date.*

I conducted a walk through of the first floor of the store. All meat and perishable food items were properly stored and the areas of storage were clean and orderly. The overall store was clean and neat. The floors were clean and things were not cluttered in anyway.

Prior to officers' departure, we provided ABHISHEK with a contact card.

the MDVR system which was not activated during this incident. I was in full MPD uniform equipped with my issued body camera, which was activated during this incident.

On Wednesday, June 5, 2024, at approximately 3:47 PM my partner P.O. Terrence PETTY (passenger) and I (driver) were dispatched to a Fight/Battery call at Pueblo Foods & Liquor, 2029 N. Holton St, located in the City and County of Milwaukee.

The original CAD read "911 open line/CLLR STS CUSTOMERS ARE FIGHTING/CLLR STS 6PPL FIGHTING///CLLR STS 1 PARTT IS LEAVING BLK DODGE CHARGER LS NB ON HOLTON///CLLR STS WAS PEPPERSPRAYED/".

On scene, the caller was identified as Viral V. PATEL (w/m, 07/19/1979), who is store employee/manager of Pueblo Foods. PATEL reported to P.O. PETTY calling for police after a fight broke out between customers. PATEL did say in the altercation one subject had pepper spray and he had gotten sprayed. PATEL reported to P.O. PETTY, one party was still on scene and the other party fled northbound from location in a black Dodge Charger prior to officer arrival. PATEL reported there would be video footage which would depict the incident.

I spoke to victim identified as Kyerra I SIMMONS (b/f, 08/25/1997) who was visibly upset reporting she had been peppersprayed. SIMMONS reported being at the same location, Pueblo Foods during the incident timeframe. SIMMONS reported she was at the location with her son identified as Eizsak SIMMONS (b/m, 06/26/2016). Kyerra reported there was a line at the cash register and there was a verbal argument which started with Subject 1. Kyerra described Subject 1 as being a black female, approximately 50 years of age, 5'8" feet tall, with black twists style hair. Kyerra reported Subject 2 became angry and started telling Kyerra was disrespecting her. Kyerra described Subject 2 as being a black female, approximately 30 years of age, 5'8" feet tall, with a medium build. Kyerra reported during the altercation, she was knocked to the ground by Subject 3 and struck to her face. Kyerra described Subject 3 as being a black male, approximately 20 years of age, 6'00 feet tall, with a thin build. Kyerra reported during the altercation, she did throw her keys in the direction of Subject 2. Kyerra reported her keychain did have pepper spray attached. Kyerra reported Subject 2 sprayed her with her pepper spray on her keychain. Kyerra reported all actors involved fled the scene. Kyerra reported she believed Eizak had also been sprayed during the altercation.

## Investigation:

Kyerra and Eizsak were treated by Bell Ambulance who responded to the scene. There was slight redness observed to both Kyerra and Eizsak. I observed no visible injury to either party. While on scene, PATEL was also given solution by Bell Ambulance for his eyes.

PATEL was sent a link via Evidence.com to have video footage depicting the incident uploaded.

Upon reviewing the video footage (exterior & interior), I observed Subject 1 to be a black female, approximately 40-50 years of age, 5'08" feet tall, 170 lbs with a medium build and shoulder length twists style hair. Subject 1 was observed to be wearing a white short sleeve t-shirt, red pants, and white boots. I observed Subject 2 to be a black female, approximately 30 years of age, 5'10" feet tall, 170 lbs. with black hair in a ponytail through a camouflage colored baseball hat. Subject 2 was observed to be wearing a

dark blue short sleeve t-shirt, and blue jeans with holes. Subject 3 was observed to be a black male, approximately 20-30 years of age, 6'00 feet tall, 180lbs to 200 lbs. with a white baseball hat on. Subject 3 was also observed to be wearing a black A-shirt tank, black pants, and black shoes. There was observed to be a fourth subject who was observed to be a black male, approximately 20 to 30 years of age, 5'10", 225 lbs with a heavy set. Subject 4 was observed to be wearing a black short sleeve t-shirt, blue jeans with a backpack.

Video footage depicts the altercation started inside at the west most register. I observed Subject 2 to be pushed back from the west register by Subject 4. Subject 2 is the shown going to the north register inside the business. Kyerra and Eizsak are shown going east through the building towards main entrance and Subject 2. Subject 2 steps towards Kyerra with a fist. Kyerra is shown to set down her items on the store counter. Subject 4 is shown to be holding back Subject 2 who is yelling in the direction of Kyerra. Subject 2 is shown trying to get through the crowd holding her back from Kyerra. Kyerra is shown to spray Kyerra in the face with pepper spray then following is knocked to the ground by Subject 3. Subject 3 is shown to throw Kyerra's keys and pepper spray toward the main entrance and Subject 2. It shows Kyerra attempting to find her keys and talk to Subject 2. Subject 2 is shown to rush towards Kyerra with Kyerra's keys in her hand and spray in her direction. It should be noted when Subject 2 did this spraying, there was numerous people behind Kyerra including Eizsak and PATEL.

All actors involved from the exterior video footage are shown to get into a black Dodge Charger with no plates: Subject 3 is the driver, Subject 2 is the front passenger, Subject 1 is the driver rear passenger, and Subject 4 is the rear passenger side. The vehicle is shown to conduct a U-turn from facing southbound to travel northbound on N. Holton St.

The actors involved are currently unknown.

This case is pending.

## Important details for those wishing to provide information for the Licenses Committee to consider when making its recommendation:

1. The license application is scheduled to be heard at the above time. Due to other hearings running longer than scheduled, you may have to wait some time to provide your testimony.
2. You must appear in person and testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)
3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are present at the committee hearing and willing to testify).
4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.
5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)
6. You may then provide testimony.
  - a. Include only information relating to the above license application.
  - b. Include only information you have personally witnessed or seen.
  - c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.
  - d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.
7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.
8. Business Competition is not a valid basis for denial or non-renewal of a license.


