
This office is in receipt of your claim in the amount of \$764.00, relating to damage sustained to your vehicle on August 21, 2003 that you are alleging occurred when a piece of concrete from a water main break struck your vehicle while you were driving at or near North 34th Street and West Center Street.

Our investigation reveals the Milwaukee Water Works (MWW) responded to water-main break in the subject area on the date in question. The MWW followed standard procedures regarding the response and subsequent repair of the main break. They had no knowledge or reports of your alleged damage. Since the MWW followed normal and customary procedures in this matter, the City cannot accept liability. Accordingly, we are denying your claim.

If you wish to appeal this decision, you may do so by sending a letter within 21 days of the receipt of this letter to the Milwaukee City Clerk, 200 East Wells Street, Room 205, Milwaukee, Wisconsin 53202, requesting a hearing.
