I am the homeowner of 4646/4646A N. 30th street. On May 24th an incident occurred at my property at 4646A N. 30th Street to which former tenant Jared Lanier-Cotton and his brother Kristopher Lanier were unknowingly selling drugs from my upstairs rental unit. On May 24th my property was raided and officers were negligent in telling me about the raid, officers did not inform me before, during, nor after the incident. I came home from work and didn't know how my property had been damaged. Officers busted the side door and ransacked my basement and threw valuable items around in the basement. I had to do my own research to try and figure out what took place at my property. I reached out to neighbors and the neighborhood development program and only then was I able to find out that officers had raided my property. I eventually met a lady at 5th district who runs the safe and sound program and she gave me more details about the raid but this was after doing my own personal research to even find out about her. Furthermore 5th district told prior tenants that I signed off on the warrant for the raid therefore placing my life in danger. I had no idea of illegal activity from prior tenants and did not sign off on a warrant. The former tenants returned to my property on May 29, 2018 to me inform of this and gather some of their items. I live on a fixed income and I found out that my side door is going to be a significant amount to have it replaced. I'm seeking the following reimbursement costs:

Wooden door with paneling and window \$200.00

Installation -\$400.00


New Locks- \$50.00
