



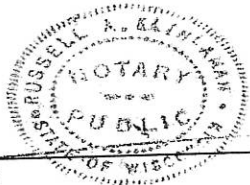

Substitute resolution approving levying of assessments and construction of assessable public improvement projects at various locations and appropriating funds for these purposes with the City cost of these projects approved by this resolution is estimated to be \$1,222,000 for a total estimated cost of \$1,300,800.

Whereas, The Common Council of the City of Milwaukee adopted preliminary resolutions, determining it necessary and in the public interest to construct and levy special assessments for the following improvements:

N. 34th St. - W. Kilbourn Ave. to W. State St. (ST211190147) Install traffic calming speed hump(s). (Assessable Reconstruction Paving Fund - \$6,000; Nonassessable Reconstruction Paving Fund - \$2,000) The total estimated cost for this project including the requested amount is \$8,000. This project is anticipated to be completed during the 2019 construction season.

6th Aldermanic District
N. 2nd St. -- W. North Ave. to W. Center St. (ST211140116) Concrete pavement reconstruction, replace all curb and gutter, sidewalk and driveway approaches, narrow the roadway from 40 feet to 38 feet, sodding (12' width of tree border area), and grading. (Assessable Reconstruction Paving Fund - \$91,200; Nonassessable Reconstruction Paving Fund - \$1,100,000). The total estimated cost for this project including the requested amount is \$1,270,000. This project is anticipated to be completed during the 2020 construction season.

N. 11th St. - W. Abert Pl. to W. Capitol Dr. (ST211190124) Install traffic calming speed hump(s). (Assessable Reconstruction Paving Fund - \$11,300; Nonassessable Reconstruction Paving Fund - \$2,000) The total estimated cost for this project including the requested amount is \$13,300. This project is anticipated to be completed during the 2019 construction season.
