This curriculum is designed for refugee batterers to address the language and cultural challenges that refugee batterers face when referred to a batterers intervention program by the court. This curriculum is based on the belief that to end domestic violence in the Hmong community, one must "dig out the roots instead of chopping off the branches of a tree." We need to zero in on the 1) core value system, 2) one the life experiences that shape the beliefs of the abuser, and 3) provide them with educational tools to help them enhance their ability to be non-abusive toward their children and partner. This curriculum is accompanied by two videos: one with vignettes and Hmong Men.
