Per MCO 85-4-4, unless otherwise specified in the code, probative evidence concerning non-renewal, suspension or revocation may include evidence of the following: failure of the applicant to meet municipal qualifications, pending charges against or the conviction of any felony, misdemeanor, municipal offense or other offense, the circumstances of which substantially relate to the circumstances of the particular licensed or permitted activity, by the applicant or by any employee or other agent of the applicant. If the activities of the applicant involve a licensed premises, whether the premises tends to facilitate a public or private nuisance or has been the source of congregations of persons which have resulted in any of the following: disturbance of the peace; illegal drug activity; public drunkenness; drinking in public; harassment of passers-by; gambling; prostitution; sale of stolen goods; public urination; theft; assaults; battery; acts of vandalism including graffiti, excessive littering, loitering, illegal parking, loud noise at times when the licensed premise is open for business; traffic violations; curfew violations; lewd conduct; display of materials harmful to minors, pursuant to s. 106-9.6; or any other factor which reasonably relates to the public health, safety and welfare, or failure to comply with the approved plan of operation. It is the intention of the Common Council to suspend or non-renew the licenses if objectors provide testimony related to the factors enumerated in MCO 85-4-4 that the Common Council finds to be true by a preponderance of the evidence and/or police reports are found to be true by a preponderance of the evidence. The police reports and other attached documents relating to objections to the license are a part of this notice and expressly incorporated in this

This report is written by Police Officer MONREAL, assigned to the License Investigation Unit, Days.

The Milwaukee Police Department's investigation regarding this application revealed the following:

- 1. On 01/24/22 at 6:54pm, Milwaukee Police were dispatched to 2803 N. 35<sup>th</sup> Street for a ShotSpotter complaint. The manager of the location was cooperative with officers and allowed them to observe and obtain video surveillance which captured the incident.
- 2. On 01/24/22 at 9:16pm, Milwaukee Police were dispatched to 2803 N. 35<sup>th</sup> Street for a shooting complaint. Investigation revealed that a subject had been shot in the middle of the street in front of the business. Officers were able to obtain video surveillance from the establishment which captured the incident. The victim and suspects had been inside the store prior to the shooting.

3. On 10/20/22 at 6:11p.m., Milwaukee Police were dispatched to a ShotSpotter at 2803 N. 35<sup>th</sup> St. Investigation revealed a suspect had been arguing with another customer inside the store earlier in the day. The suspect then returned to the store armed with a handgun and entered the store. Upon exiting the suspect fired his firearm into the air. The employee was very cooperative with the investigation and allowed officers video surveillance of the incident. Three casings were located in front of the store.

#### INITIAL INVESTIGATION

This report is written by P.O. Douglas PAVLIK, assigned to District 7, Early Power Shift.

On 10/20/2022 at approximately 6:11PM, I (Squad 7269) was dispatched to a ShotSpotter Complaint at the address of 2803 N. 35th St. which is in the City and County of Milwaukee. The ShotSpotter was for 3 rounds in the alley Flex ID#81-871608.

Upon arrival Flocated three brass Blazer 9mm Luger casings at 2803 N. 35th St. (Family Foods) on the sidewalk right in front of the store.

The area where the casings was located is a residential area with occupied residences on both sides of the street.

The casings were inventoried and placed on Milwaukee Police Department Inventory#22038737.

P.O. Matthew WIERZCHOWSKI (Squad 7230) took 5 photos of the scene and casing at 6:26PM.

I located one camera in the area of the ShotSpotter. The camera was located on the front of the store 2803 N. 35th St. The owner of the store Ahmed I. SALEM (W/M 4/18/1980) stated the camera on the front of the store was working and caught the suspect shooting. I then viewed the video and it shows the suspect walking westbound on W. Hadley St. towards N. 35th St. The suspect is walking with a female and they are observed walking into the store. The suspect is observed cocking the slide on the handgun and walking inside with the firearm. The suspect and the female then come outside and the suspect then fires the gun in the air and flees eastbound on W. Hadley St. The suspect is described as a B/M, 20-30 years old, 5'10"-6"00, around 160 lbs, dreads, gray hooded sweatshirt with white writing, blue jeans, and white tennis shoes with black trim.

SALEM stated the suspect lives on N. 34th St. between W. Hadley St. and W. Locust St. SALEM stated he didn't know the name of the suspect but stated he didn't know the suspects name. SALEM stated the suspect was arguing with a patron that recently came into the store before the suspect got there.

SALEM was cooperative during the investigation and told me right away when I got on scene that he had video of the incident.

Please make such requests no later than one business day prior to the start of the meeting. You are not required to attend the hearing, but please see the information below if you would like to provide testimony. Once the Licenses Committee makes its recommendation, this recommendation is forwarded to the full Common Council for approval at its next regularly scheduled hearing.

# Important details for those wishing to provide information for the Licenses Committee to consider when making its recommendation:

- The license application is scheduled to be heard at the above time. Due to other hearings running longer than scheduled, you may have to wait some time to provide your testimony.
- 2. You must appear in person and testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)
- 3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are present at the committee hearing and willing to testify).
- 4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.
- 5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)

- 6. You may then provide testimony.
- a. Include only information relating to the above license application.
- b. Include only information you have personally witnessed or seen.
- c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.
- d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.
- 7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.
- 8. Business Competition is not a valid basis for denial or non-renewal of a license.

Please Note: If you have submitted an objection to the above application your objection cannot be considered by the committee unless you personally testify at the hearing.
