
We return the enclosed document which has been filed with the City Clerk and ask that it be introduced and referred to the Committee on Judiciary & Legislation with the following recommendation.

Claimant, Irene D. Taylor, 8216 West Thurston Avenue, Milwaukee, WI 53218, alleges on her own behalf that the Milwaukee Police Department was negligent due to their lack of response to her auto being stolen on June 20, 2001. She claims damages in the amount of \$6,380.27.


Our investigation reveals that the Milwaukee Police Department followed proper procedures in this matter and the allegations are unsupported by specific factual data.
