Per MCO 85-4-4, unless otherwise specified in the code, probative evidence concerning non-renewal, suspension or revocation may include evidence of the following: failure of the applicant to meet municipal qualifications, pending charges against or the conviction of any felony, misdemeanor, municipal offense or other offense, the circumstances of which substantially relate to the circumstances of the particular licensed or permitted activity, by the applicant or by any employee or other agent of the applicant. If the activities of the applicant involve a licensed premises, whether the premises tends to facilitate a public or private nuisance or has been the source of congregations of persons which have resulted in any of the following: disturbance of the peace; illegal drug activity; public drunkenness; drinking in public; harassment of passers-by; gambling; prostitution; sale of stolen goods; public urination; theft; assaults; battery; acts of vandalism including graffiti, excessive littering, loitering, illegal parking, loud noise at times when the licensed premise is open for business; traffic violations; curfew violations; lewd conduct; display of materials harmful to minors, pursuant to s. 106-9.6; or any other factor which reasonably relates to the public health, safety and welfare, or failure to comply with the approved plan of operation. The Milwaukee Police Department's investigation regarding this application revealed the following:

1. On 09/08/2011 Milwaukee police conducted a licensed premise check at Scotty's Bar & Pizza (3921 W. Clement Ave.) based on a citizens complaint that the business had amusement machines on premise that were paying out to customers. Officers spoke to the applicant who denied payouts on his machines. The officers observed no violations.

2. On 01/23/13 at 1:48 am, Milwaukee police were dispatched to 3921 W Clement Avenue for a Trouble With Subject complaint. Police spoke with the bartender Melanie Bush, who stated a patron that was sleeping at a table and seemed to be "out of it". Bush stated the subject came into the bar, asked for a cab and a soda, went outside to the cab, only to return and pass out on the floor. An ambulance was called and the subject was conveyed to a nearby hospital.

4. On 11/02/2018 at 1:25am officers were dispatched to a fight at Scotty's Tavern, 3921 S Clement Av. The officers arrested a subject for an altercation that occurred between patrons of the bar. The employees were cooperative and helped the officer obtain video of the incident. No tavern violations were observed.
  5. On 01/19/2019 at 2:29am officers were dispatched to a fight at Scotty's Bar and Pizza, 3921 S Clement Av. The officers interviewed the victim who stated he got into a verbal argument with two females who then left the location. The females returned with two males who assaulted him. He did not want to prosecute and only stayed to talk with the police because he knows the owner of the bar. The bartender was cooperative but stated only the manager could access the video system.
  6. On 03/15/2019 at 12:24am officers were dispatched to a Trouble with Subject call at Scotty's, 3921 S Clement Av. The bartender stated a male and female were arguing about their bar tab. When the subjects were leaving the bartender observed the male subject was walking out with a bottle of beer and he refused to give it to the bartender. The bartender went outside and told the subject he was no longer welcome at the bar. The subject then got into a physical altercation with his girlfriend in the parking lot. The bartender observed the subject throw the bottle across the parking lot. The bartender called the police and was detained by other customers. Officers arrived on scene and the subject was arrested for Disorderly Conduct.

Upon officers' arrival, the listed business was closed, and all doors were locked. Officers located the caller at 4000 S. Clement Ave., Dominico GOMEZ (W/M 07-10-89) who stated he got into a verbal altercation at Scotty's Bar with an unknown white male patron. The patron left prior to bar closed but GOMEZ feared, he was waiting in the parking lot for him. GOMEZ stated at bar close, two unknown males entered the bar and he believed they were after him.


