expenses incurred due to equipment failure or operator negligence in the performance of street salting. My loss occurred on December 25th 2000 while traveling west on Burleigh Street between 32nd and 30th Street. I drove into what appeared to be snow that had been plowed and scattered over the road. A city bus was ahead of me and traveled over the snow with no apparent problem, however when I followed I heard a rumble and a crash at the underbody of the automobile. After that occurrence I observed a City Salt Truck idle and at the curb attending to the salting apparatus at the rear of the truck. Also, the area I had just passed was muddy indicating that there had been some problem. Assuming the vehicle was okay, I proceeded to Columbia Hospital to visit my father. My daughter, Lavonne Williams was with me.

When I left the hospital, I noticed that the automobile oil light was on. I opened the hood, looked on the ground and observed oi on the ground. Further observation revealed a hole in the oftpan I added oil and drove the vehicle home. The next day, I took the car to Mike's Standard Station at 39th & Capitol Drive and he confirmed that the car had run over some type of large, sharp object and recommended that I take it to a Dodge dealer. I $^{\circ}$ contacted the City of Milwaukee on two occasions reporting the
