Dear Council Members:

Sal Homes LLC, alleges on December 22, 2024, the basement of the property experienced sewage back up shortly after repairs were conducted by the City from a water main break located at 5262 N. 38th Street. Sal Homes LLC submitted a damage claim for costs incurred as a property owner, including but not limited to; tenant accommodation expenses, basement cleaning, plumbing expenses and repairs in the amount of \$7,663.95.

We have completed our investigation into this matter with Milwaukee Water Works (MWW). Our investigation reveals that on December 22, 2024, MWW responded to and repaired a water main break at 5262 N. 38th Street. MWW reported it hired a contractor to repair damage found in the claimant's clay sewer lateral located directly under the water main. While damage reported is consistent with high pressure water that exited a water main blow hole, MWW confirmed staff did not damage or see the claimant's sewer lateral during repairs to the water main.
