We have received your claim in the amount of \$427.58, relating to damage allegedly sustained to your vehicle on July 14, 2011 when it collided with a sunken sewer manhole while you were traveling northbound on Sherman Boulevard at Hadley Street.

Our investigation reveals that the Infrastructure Services Division records indicate that prior to July 14, 2011 the City had no notice of this hazard and because of this lack of notice the City would not be liable. Therefore, we are denying your claim.

If you wish to appeal this decision, you may do so by sending a letter within 21 days of the receipt of this letter to the Milwaukee City Clerk, 200 East Wells Street, Room 205, Milwaukee, Wisconsin 53202, requesting a hearing.
