Dear Ms. Macco:


We have received your claim in the amount of \$2,127.42, relating to your interests and the interests of your insured arising from a February 12, 2008 loss in which your insured allegedly lost control of his vehicle and collided with a staircase and curb because of a City snowplow truck at 2605 East Bennett Street.

Our investigation reveals that a City snowplow truck was attempting to cross the street to continue with his plowing duties. He had stopped because he saw your insured was approaching on the through roadway. The plow driver then saw your insured's vehicle swerve and hit the curb. Since your insured failed to have his vehicle under control he began to slide due to snowy conditions. The direct cause of this accident was caused by your insured's actions, as such, the City cannot accept liability and we are denying your claim.

If you wish to appeal this decision, you may do so by sending a letter within 21 days of the date of this letter to the Milwaukee City Clerk, 200 East Wells Street, Room 205, Milwaukee, Wisconsin 53202, requesting a hearing.
