RE: Revised Municipal Court Non-Traffic and Boating Deposit Schedules

Dear Council Members:

The Milwaukee Municipal Court Judges are forwarding to you the revised 2003 Boating and Non-Traffic Deposit Schedules for approval and adoption. Accompanying the schedules are a resolution, fiscal note, and a list of the ordinances that were added to the schedule in 2003. If approved, the new deposit schedules will be effective immediately.

The 2003 Non-Traffic Deposit Schedule reflects two changes. First, several ordinances and interim deposit amounts were added to the schedule in accordance with the Milwaukee Code of Ordinances. Second, the schedule reflects a \$2.00 increase in the state-mandated Crime Lab Assessment Fee which increased from \$5.00 to \$7.00. The only modification made to the 2003 Boating Deposit Schedule is the addition of the state-mandated \$2.00 increase of the Crime Lab Assessment Fee.

The judges and court administration request that the 2003 Boating and Non-Traffic Deposit Schedules be approved as soon as possible. If you have any questions, feel free to contact me at 286-3820.
