On Monday, October 7th, 2025, at 12:11 AM, my partner P.O. Keng HANG and I were dispatched to an entry to building call located at 7002 W Center St (Z Petro Mart), which is located in the city and county of Milwaukee.

Upon arrival, we spoke to an individual identified as, Mark S. MURPHY, (W/M DOB 01/12/52) who stated he saw someone breaking into the gas station through a window from his camera. MURPHY stated he observed a male wearing dark clothing reaching into the store and states the male left the store with a garbage bag full of items he believes to be cigarettes. MURPHY stated he has video and a still image of the suspect that he sent to an evidence.com link. Video evidence reveals the time of the burglary was 11:42 PM on Monday, October 6th, 2025, at the address of 7002 W Center St, located in the city and county of Milwaukee.

While on scene, we observed a window panel which gave access to the inside of the store. We observed no broken glass and a carboard piece that appeared to be covering the window. Officers also observed from outside of the business, the cashier's front glass panel was damaged as well.

We contacted the owner, Dipak THAPA (W/M DOB 03/30/75), who advised he would be coming to the location to determine what was stolen and if there were any other damages.

Upon arriving to the store, THAPA stated he would have to coordinate with staff to go through inventory to find exact amounts of items taken, but knows cigarette boxes, lottery tickets and vapes were taken from behind the cashier's counter (This is consistent with the video footage). THAPA stated the store is insured by Erie Insurance.

The store video depicts a suspect wearing a black Halloween style mask, a dark colored hoodie over a black ski mask and black rubber gloves, which does not reveal the race or any other identifiers of the individual.

Video evidence was uploaded to evidence.com depicting the suspect entering the store through the cardboard panel, going behind the counter by pulling the cashier's glass off the track, and leaving the store with the items in a clear garbage bag.

63 photos were taken by P.O. Joshua GRAMINSKE at 1:35 AM.

Follow-up was conducted with THAPA on Saturday, October 11th, 2025 at 8:15 PM at the store location and THAPA stated that he was able to report the serial numbers of the lottery tickets to the Wisconsin Lottery Division and the stolen tickets have been cancelled.

Once the Licenses Committee makes its recommendation, this recommendation is forwarded to the full Common Council for approval at its next regularly scheduled hearing.

## Important details for those wishing to provide information for the Licenses Committee to consider when making its recommendation:

1. The license application is scheduled to be heard at the above time. Due to other hearings running longer than scheduled, you may have to wait some time to provide your testimony.
2. You must appear in person and testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)
3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are present at the committee hearing and willing to testify).
4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.
5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)
6. You may then provide testimony.
  - a. Include only information relating to the above license application.
  - b. Include only information you have personally witnessed or seen.
  - c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.
  - d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.
7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.
8. Business Competition is not a valid basis for denial or non-renewal of a license.
