Dear Council Members:

Enclosed please find a proposed resolution. We ask that it be introduced and referred to the Committee on Judiciary & Legislation, with the following recommendation.

Claimant, WE Energies, by its representative Regina Bolden, Claims-Room A145, P.O. Box 1132, Milwaukee, WI 53201-1132, alleges that on November 24, 2014 their gas service at 2862 North 30th Street was damaged when the Milwaukee Water Works excavated. Claimed damages total \$5,432.61.

Milwaukee Water Works records indicate that on November 24, 2014 they were repairing a break in a 6 inch water main at 2862 North 30th Street. During the repair process, their crew hit the claimant's properly marked gas service. Because settlement of this matter is deemed expeditious to the City of Milwaukee, we recommend settlement of this claim for \$5,432.61 and have enclosed an appropriate resolution for your convenience.
