### **CONVEYANCE OF RIGHTS IN LAND**

### **CITY OF MILWAUKEE-SEWER**

CITY OF MILWAUKEE, as GRANTOR ("CITY"), and STATE OF WISCONSIN, DEPARTMENT OF TRANSPORTATION, as GRANTEE ("DOT"), for and in consideration of the sum of one dollar (\$1) and other good and valuable consideration, hereby agree as follows.

- 1. <u>City Easements</u>. CITY states that it acquired certain easement rights by virtue of the following documents recorded in the Milwaukee County Register of Deeds Office:
- A. Sewer Easement 1971 ("SE 1971"). Recorded June 24, 1971 as Document No. 4601345.
- B. Sewer Easement 1970 ("SE 1970"). Recorded August 13, 1971 as Document No. 4614191.
- 2. <u>DOT Project and Plat.</u> The DOT, for purposes of improvement to STH 181 (North 76<sup>th</sup> Street, West Calumet Road to North County Line Road) (Project No. 2140-08-22), wishes to construct, operate, and maintain a public highway and appurtenant facilities on, over, under, or across a portion of the real estate affected by SE 1971 and SE 1970. The legal description of said portion of real estate is shown as PARCEL 301 and PARCEL 302 on TRANSPORTATION PORJECT PLAT NO. 2140-08-22, Page 4.13, which DOT filed with the Milwaukee County Clerk and Milwaukee County Highway Committee as required by Wis. Stat. § 84.09 (1), and recorded in the Milwaukee County Register of Deeds Office as Document No. 09442421. The PLAT is also available for viewing at the DOT Office, North Central Region, located at 1681 South Second Avenue South, Wisconsin Rapids, WI 54495. A Map of such portion (i.e. PARCELS 301 and 302), and a legal description describing those pacels are attached hereto as **EXHIBIT A.**
- 3. <u>Conveyance.</u> DOT has the authority under Wis. Stat. §§ 84.02, 84.09 and Ch. 32 to acquire PARCELS 301 and 302, including CITY's interest therein.

CITY hereby conveys to DOT CITY's right, title and interest in and to PARCELS 301 and 302, providing however, that CITY reserves to itself the right to keep in place its underground storm sewer pipes and facilities currently located subsurface in PARCELS 301 and 302, and the right to enter upon said parcels and to repair, replace, and maintain said pipes and facilities in a manner consistent with the purposes of this conveyance and in a manner that will not unreasonably interfere with normal highway maintenance and operation. DOT shall use care regarding its operations so as not to damage City's facilities.

CITY retains and does not convey any and all other right, title and interest under SE 1971 and SE 1970 (and the real estate subject to those easements) not affected hereby, including its rights under Water Easements WE-295E and WE-295-H (which water easements are, respectively, part of, and described in, the afore-referenced documents recorded at Document Numbers 4601345 and 4614191).
