There is a possibility that your application may be denied for one or more of the following reasons: The recommendation of the committee regarding the application shall be based on evidence presented at the hearing. Per MCO 85-4-4, unless otherwise specified in the code, probative evidence concerning non-renewal, suspension or revocation may include evidence of the following: failure of the applicant to meet municipal qualifications, pending charges against or the conviction of any felony, misdemeanor, municipal offense or other offense, the circumstances of which substantially relate to the circumstances of the particular licensed or permitted activity, by the applicant or by any employee or other agent of the applicant. If the activities of the applicant involve a licensed premises, whether the premises tends to facilitate a public or private nuisance or has been the source of congregations of persons which have resulted in any of the following: disturbance of the peace; illegal drug activity; public drunkenness; drinking in public; harassment of passers-by; gambling; prostitution; sale of stolen goods; public urination; theft; assaults; battery; acts of vandalism including graffiti, excessive littering, loitering, illegal parking, loud noise at times when the licensed premise is open for business; traffic violations; curfew violations; lewd conduct; display of materials harmful to minors, pursuant to s. 106-9.6; or any other factor which reasonably relates to the public health, safety and welfare, or failure to comply with the approved plan of operation. See attached police report or correspondence.

Notice for applicants with warrants or unpaid fines: Proof of warrant satisfaction or payment of fines must be submitted at the hearing on the above date and time. Failure to comply with this requirement may result in a delay of the granting/denial of your application.

Failure to appear at this meeting may result in the denial of your license. Individual applicants must appear only in person or by an attorney. Corporate or Limited Liability applicants must appear only by the agent designated on the application or by an attorney. Partnership applicants must appear by a partner listed on the application or by an attorney. If you wish to do so and at your own expense, you may be accompanied by an attorney of your choosing to represent you at this hearing.

You will be given an opportunity to speak on behalf of the application and to respond and challenge any charges or reasons given for the denial. No petitions can be accepted by the committee, unless the people who signed the petition are present at the committee hearing and willing to testify. You may present witnesses under oath and you may also confront and cross-examine opposing witnesses under oath. If you have difficulty with the English language, you should bring an interpreter with you, at your expense, so that you can answer questions and participate in your hearing.

You may examine the application file at this office during regular business hours prior to the hearing date. Inquiries regarding this matter may be directed to the person whose signature appears below.

Hi Jim and Favi,

Here is timeline of our interactions with Milwaukee Food Market at 2903 W Clybourn in the last year. Please submit below for objection.

May 29, 2025:

We were assigned a complaint for pests at Milwaukee Food Market from a Safety Officer that was patrolling this block, located at 2903 W Clybourn St. Upon arrival, we immediately began to observe rat droppings throughout the back storage area moving into the kitchen/deli area, retail area and throughout the basement of the building. We issued Orders to Cease. Jay(the operator) was made aware that in order to re-open the following day, no evidence of pest could be observed, meaning-droppings, dead bodies, urine, eaten into food and/or single service items.

May 30, 2025, re-inspection #1:

At about 9:45 am we received a call from Jay(the operator) stating he was ready for the re-inspection. He explained that the entire store had been cleaned and that the basement still needed some work. I explained to him that if we found any evidence of pests that the store would remain closed. I advised him to double check the basement prior to us arriving. Once on-site starting 10:10am we again started at the back of the store and worked our way forward. I quickly began to see rat droppings and eaten into food and single service items. We then had the conversation with the Operator to explain that unfortunately the store would have to remain closed over the weekend due to the pest activity since it was a Friday and the store would need to remain closed overnight (pest activity is typically highest overnight, so this gives us the best picture of what is actually going on).

Jay began to become very upset and stated that him and the staff had been working for countless hours throughout the day and night to rectify the issue and that it was unacceptable that the store would remain closed. He stated that it would be unsafe for him, his staff, and the store itself to be closed. He explained that patrons on the neighborhood would attack them and/or break into the store. I told him that if he would like to remain in the store to keep an eye on it, he was perfectly within his rights to do so, but if he felt unsafe that he should contact MPD or even leave the

establishment to avoid harm. He began to get more angry and shouted that I would be "jumped" once I left the store for keeping it closed and that him and the staff would be shot later that night and that it would be on my hands.

At this point, the situation was getting out of hand and we stated that we would leave the report on the counter and leave the store. We also offered to come for the re-inspection first thing Monday morning and that he should reach out to confirm a time.

June 2, 2025, re-inspection #2:

At 9am, we arrived at the establishment for the re-inspection. We started at the back of the store and moved our way forward, things appeared more clean and less cluttered. We then get to the deli coolers and observe rat droppings beneath, we proceed to the retail portion of the store and find more eaten into chip bags and droppings on shelving as well as some droppings in the basement. Due to the pest activity, we notify Jay that the store would need to remain closed for another day and that we could return tomorrow 6/3 for another re-inspection. He began to get very upset and accused us of being racist.

At this point we explained that we were going to leave the store and that they should reach out tomorrow for another re-inspection. We asked that they unlock the door so that we could leave and lock the door behind us. They refused and said if you unlock the door, whatever is going to happen is going to happen and we would be responsible. We waited until we got permission to unlock the door and left. As we were leaving, Jay the operator, appeared to be recording us, shouting the health department is leaving and let themselves out. He shouted down the street to a few patrons, "The health department is keeping us closed."

A referral was then made to DNS concerning foundation issues in the basement as well as the apartments above the store on June 2, 2025. At this point, DNS went in and advised us that there was a good amount of work to be done on the building and that the business would not be able to operate. DNS stated that they would let us know when they lifted their orders.

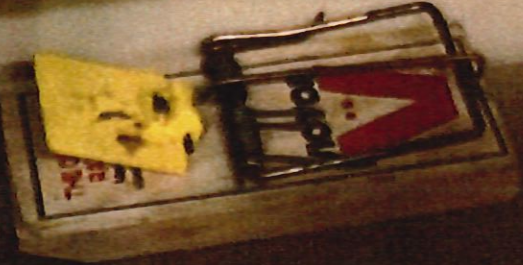

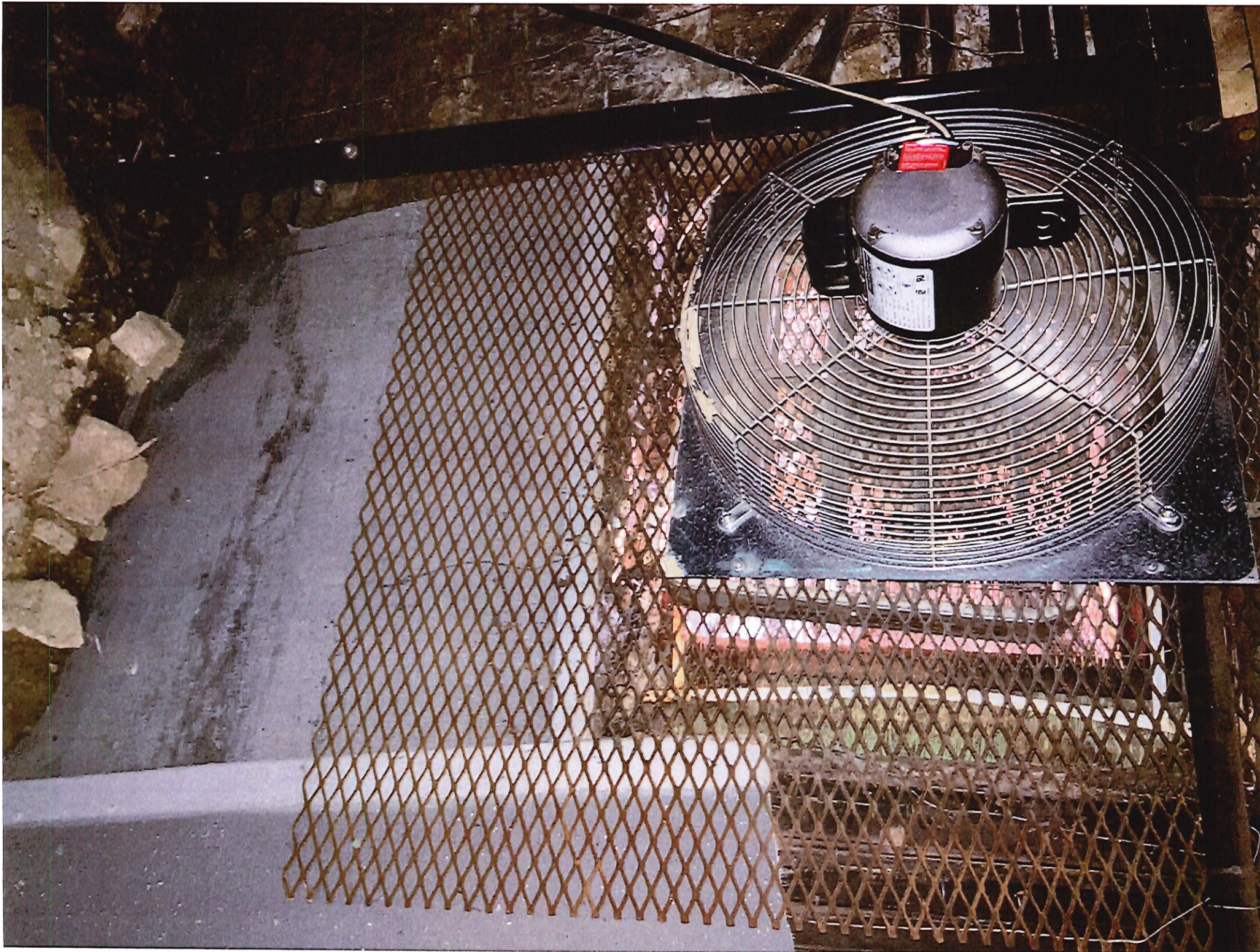

The hearing before the Licenses Committee will take place on 6/30/2026 at 9:15 AM in Room 301-B, Third Floor, City Hall. This is a public hearing. Those wishing to view the proceeding are able to do so via the City Channel – Channel 25 on Spectrum Cable – or on the Internet at <http://city.milwaukee.gov/citychannel>. Those wishing to provide oral testimony via internet are asked to contact the staff assistant, Yadira Melendez at (414) 286-2775 or stasst5@milwaukee.gov for necessary information. Please make such requests no later than one business day prior to the start of the meeting. You are not required to attend the hearing, but please see the information below if you would like to provide testimony. Once the Licenses Committee makes its recommendation, this recommendation is forwarded to the full Common Council for approval at its next regularly scheduled hearing.

Important details for those wishing to provide information for the Licenses Committee to consider when making its recommendation:

1. The license application is scheduled to be heard at the above time. Due to other hearings running longer than scheduled, you may have to wait some time to provide your testimony.
2. You must appear in person and testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)
3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are present at the committee hearing and willing to testify).
4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.
5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)
6. You may then provide testimony.
 - a. Include only information relating to the above license application.
 - b. Include only information you have personally witnessed or seen.
 - c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.
 - d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.
7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.
8. Business Competition is not a valid basis for denial or non-renewal of a license.
Please Note: If you have submitted an objection to the above application your objection cannot be considered by the committee unless you personally testify at the hearing.
