There is a possibility that your application may be denied for one or more of the following reasons: The recommendation of the committee regarding the application shall be based on evidence presented at the hearing. Per MCO 85-4-4, unless otherwise specified in the code, probative evidence concerning non-renewal, suspension or revocation may include evidence of the following: failure of the applicant to meet municipal qualifications, pending charges against or the conviction of any felony, misdemeanor, municipal offense or other offense, the circumstances of which substantially relate to the circumstances of the particular licensed or permitted activity, by the applicant or by any employee or other agent of the applicant. If the activities of the applicant involve a licensed premises, whether the premises tends to facilitate a public or private nuisance or has been the source of congregations of persons which have resulted in any of the following: disturbance of the peace; illegal drug activity; public drunkenness; drinking in public; harassment of passers-by; gambling; prostitution; sale of stolen goods; public urination; theft; assaults; battery; acts of vandalism including graffiti, excessive littering, loitering, illegal parking, loud noise at times when the licensed premise is open for business; traffic violations; curfew violations; lewd conduct; display of materials harmful to minors, pursuant to s. 106-9.6; or any other factor which reasonably relates to the public health, safety and welfare, or failure to comply with the approved plan of operation. It is the intention of the Common Council to suspend or non-renew the licenses if objectors provide testimony related to the factors enumerated in MCO 85-4-4 that the Common Council finds to be true by a preponderance of the evidence and/or police reports are found to be true by a preponderance of the evidence. The police reports and other attached documents relating to objections to the license are a part of this notice and expressly incorporated in this notice. The licensee should be prepared to address these matters at the hearing.

**Proof of warrant satisfaction or payment of fines must be submitted at the hearing on the above date and time. Failure to comply with this requirement may result in a delay of the granting/denial of your application.**

Failure to appear at this meeting may result in the denial of your license. Individual applicants must appear only in person or by an attorney. Corporate or Limited Liability applicants must appear only by the agent designated on the application or by an attorney. Partnership applicants must appear by a partner listed on the application or by an attorney. This report is written by Police Officer Monreal, assigned to the License Investigation Unit, Days.

The Milwaukee Police Department's investigation regarding this application revealed the following:

**1. The applicant has an open warrant with the City of Milwaukee for Vandalism**

2. On 03/26/23 AT 5:05P.M., Milwaukee Police were dispatched to a Subject with Gun at 1505 N. Farwell. On arrival the officer interviewed the victim who stated they were eating at the establishment, when the waiter began to bring them unrequested shots of liquor and consume the shots with the patrons. Once the bill was brought to the table, the patrons observed the shots of liquor were on the bill and began to argue, since they never requested the liquor shots. The waiter then threw a plate of fries and punched them in the face. The victim did provide cell phone video of the incident, which depicts the incident as the victim stated.

Once inside the establishment, the officers observed multiple bottles of liquor displayed behind the counter. The agent was on scene and stated the waiter was a family member, not a paid employee and did not have information on the subject other than a first name and phone number. The agent stated they often have family members work there off the books for free. The licenses posted were expired, however, the agent advised the officer, they just needed to print them out and display them. The officer then advised the agent they would conduct follow up on 03/29, to verify the licenses. A check of License Information Reporting Administration revealed the establishment did not have a valid Food or Class B Tavern License.

On 03/29/23, the agent failed to show up at the previously agreed to scheduled time. Officers contacted the agent via telephone and the meeting was rescheduled for 03/30. On 03/30, the agent failed to show up at the scheduled meeting time and was contacted via phone. The agent stated they were at lunch with a friend and would come in to District 1 to meet with officers. The officer asked how long it would take for them to arrive, and the agent hung up on the officer, and did not show up as agreed. The agent was cited for Food Dealer License Required and Liquor License Required.

## Narrative (1)

### LICENSED PREMISE REPORT

LaCroix II, Joseph A 029803

03/26/2023

This report is being written by P.O. Joseph LACROIX, assigned to District One Early Power Shift Squad 1233.

On Sunday March 26, 2023, while in full duty uniform in a marked squad with AXON body worn camera activated, my partner, P.O. Tanya ROSALES and I were dispatched to a subject with gun call for service at "Twisted Cafe", located at 1505 N Farwell Ave, within the City and County of Milwaukee, State of Wisconsin.

Upon arrival, we observed a disturbance including a large group of people in front of the location, along with multiple vehicles parked in the westernmost lane of Southbound traffic on N Farwell Ave in front of the cafe, which we presumed, and later confirmed, were involved in the disturbance.

P.O. ROSALES and I approached the group and began dispersing the improperly stopped/standing vehicles and made contact with two Milwaukee women who alleged that they had been battered by an employee of the cafe. No guns were observed, and the subjects encountered outside of the bar denied any possession or involvement of firearms in this incident.

After establishing some degree of scene stabilization on the exterior of the building, P.O. ROSALES and I entered the cafe and observed various restaurant/bar supplies, food and beverage and equipment strewn about the dining room and all over the floor. There was no active disturbance inside the location, so P.O. ROSALES remained inside and interviewed the Agent, **Melissa S LATAVONG(F/W, 09-07-1990)**, while I, P.O. LACROIX, returned outside and spoke with **Marqueesha L PEACE(F/B, 06-23-1996)** and **Cierra D WILLS(F/B, 03-23-1997)**, who both remained visibly distraught, angry, and exhibited signs of intoxication.

### INTERVIEW OF MARQUEESHA L PEACE

PEACE stated that she and a group of friends had been patronizing the cafe earlier that afternoon when an argument ensued with their waiter/bartender over the payment of their bill. Specifically, PEACE explained that their waiter repeatedly delivered shots to their table that they never ordered, and their waiter consumed said shots with them on each occasion. PEACE told me that when the bill was delivered, the shots that had been repeatedly delivered appeared on the bill, which was unacceptable to her and her group.

PEACE stated that an argument then began which culminated with their waiter throwing a plate of french fries at her, which struck her on the left side of her face and chest, causing her pain intentionally and without consent and splattering barbecue sauce all over her face and hair. PEACE told me that after

this, the same subject punched WILLS in the face.

PEACE told me that she had video of the incident, and played a video clip for me that corroborated her story. P.O. ROSALES later sent an invitation to PEACE to upload the video to the Evidence.com system, which she did. The video is available for review within that system under ID number **230851029**.

PEACE demanded that the waiter be arrested and "charged" with assault. I explained to PEACE, and the numerous remaining friends and family members, that citations for battery would be issued to the waiter upon his identification.

I also explained to PEACE, that all citizens have the same rights, and that if it was found that they had participated in any property damage or theft they could receive citations as well.

It should be noted that during my interview of PEACE, I was interrupted multiple times by PEACE and WILLS themselves, as well as various other friends and family members who had arrived on scene, to the extent that I was forced to advise the group that if they were unable to bring a higher degree of calmness to the incident, they themselves could be cited for disorderly conduct, due to continuing to participate in a loud disturbance in the neighborhood.

The remaining double parked vehicles dispersed, and the crowd became calmer.

## **INTERVIEW OF CIERRA D WILLS**

WILLS' story was consistent with PEACE's and WILLS demanded that the waiter be arrested and charged. WILLS confirmed that she was struck intentionally and without consent, and experienced pain.

## **PEACE AND WILLS LEAVE THE SCENE**

After I had addressed questions from PEACE and WILLS, and explained how the investigation would move forward, WILLS asked if they could leave, explaining that it was her birthday and she wanted to get going. I told her that I needed them to standby for a moment, as I needed to check with the manager if any allegations of theft or property damage needed to be addressed. I stepped back inside the cafe and briefly spoke with LATAVONG, who stated that there was no unpaid tab, and she was not going to pursue any citations from the group. PEACE and WILLS were then released from the scene.

## **INTERVIEW OF MELISSA S LATAVONG**

I then returned to the bar area of the cafe and observed multiple bottles of alcohol displayed behind the bar, and P.O. ROSALES speaking with LATAVONG. P.O. ROSALES told me that the waiter who had battered PEACE and WILLS had left the scene, and furthermore, LATAVONG did not have his information, beyond his first name, "Corey", and a phone number of 414-232-2235.

I asked LATAVONG if this was true and she confirmed, stating that she didn't have his information because he was a family friend. I advised LATAVONG that she was required to have records on all employees for tax purposes and asked her if she paid payroll taxes. LATAVONG told me that she did, but also had numerous family members and friends who worked there off the books for free.

Before we departed, LATAVONG agreed to meet with us on Wednesday, March 29, 2023 and produce for us the full information of "Corey" for the purpose of citing him for the battery of PEACE and WILLS.

LATAVONG was informed that a licensed premise report would be filed regarding this incident.

## **OBSERVATION OF POSTED LIQUOR AND FOOD LICENSES**

Displayed on the wall just after the entrance of the cafe were the Twisted Cafe's food and class B Liquor licenses, showing LATAVONG as the listed agent. We observed that both licenses were invalid, having expired in December of 2022. LATAVONG told us that she had a valid license for each, but she "just had to print them off" and hang them up.

We gave LATAVONG the benefit of the doubt and did not cite her under City of Milwaukee Municipal ordinances **90-3-1** (liquor license required) and **68-23-1** (food dealers license required) at that time, instead advising her that we would return on Wednesday March 29, 2023, and we expected to see her valid licenses displayed, and "Corey" available to be cited. LATAVONG agreed to this arrangement.

## **CHECK OF THE LIRA SYSTEM**

On Wednesday, March 29, 2023, P.O. ROSALES and I visited the Milwaukee Police Department License Investigation Unit located at the Milwaukee Police Administration building and checked the LIRA system as to the status of LATAVONG's liquor and food licenses. The LIRA system revealed that LATAVONG did not have valid liquor or food licenses during her operation of the Twisted Cafe on Sunday March 26, 2023 during which both intoxicating beverages and food products were prepared and served to customers.

Having discovered that LATAVONG had lied to P.O. ROSALES and I regarding the status of her liquor and food licenses, the decision was made to cite her under 90-3-1 as well as 68-23-1.

We briefed acting District One LT SGT SIMONSON on this incident, who approved issuance of these citations.

## **INVOLVMENT OF MPD D1 COMMUNITY LIASON OFFICER**

P.O. Jordan EMMONS, D1 CLO, was advised as to the details of this matter, and accompanied us to our arranged meeting with LATAVONG at Twisted Cafe on 03-29-2023.

## **LATAVONG EVADES POLICE CONTACT #1**

Upon our arrival at Twisted Cafe on 03-29-2023, we found the business closed, the curtains drawn, and the front door locked despite our agreement to meet. P.O. ROSALES and I, along with P.O. EMMONS changed location to LATAVONG's listed address of 222 S 3rd St apartment 515 to attempt to make contact with her there.

There was no answer at the door to LATAVONG's apartment, and a community contact card was slid under the door, advising her to contact us asap.

We contacted LATAVONG by cell phone, and asked her why she didn't open up on 03-29-2023.

LATAVONG told us that she still had a few things to work out before she opened, but again agreed to

meet with us at Twisted Cafe, this time at 12:00pm on Thursday, March 30-2023.

## NOTIFICATION OF WISCONSIN DEPARTMENT OF REVENUE AGENT

D1 CLO Officer Molly PLUMLEY was briefed on this investigation, and she notified Ashley SCHNERING of the Wisconsin Department of Revenue Criminal Investigation Alcohol and Tobacco Enforcement Unit.

## REVIEW OF VIDEO OF INCIDENT

P.O. ROSALES and I reviewed the video that PEACE uploaded to the Evidence.com system.

Video clip one shows a number of patrons inside Twisted Cafe holding up small plastic glasses containing a liquid substance. Also, one can observe a plate of food in front of one of the patrons. With our body cameras activated, P.O. ROSALES and I contacted PEACE by cellphone to ask a few questions about the video.

PEACE confirmed that the video was captured by her cellphone, that the food was ordered from the Twisted Cafe, and the liquid contained in the small plastic glasses was indeed an intoxicating beverage, likely either "Crown Apple" or Hennesey.

Video clip two shows "Corey" throwing the plate at PEACE and punching WILLS in the face. It should be noted that the punch was a glancing blow, and does not appear to make full contact with WILLS's face. However, the punch itself does appear quite ferocious, and if full contact had been made with WILLS' face, it is likely that serious injuries could have occurred.

PEACE told us that video clip tow was captured by her friend's phone and sent to her.

## LATAVONG EVADES POLICE CONTACT #2

On Thursday March 30, 2023, P.O. ROSALES and I, along with P.O. Plumley and P.O. EMMONS and Agent SCHNERING, arrived at Twisted Cafe to meet with LATAVONG at approximately 12:30pm. Once again, we found the business closed, the curtains drawn, and the front door locked despite our agreement to meet.

LATAVONG was again contacted by cell phone, and this time she stated that she was "at lunch with an investor" and would be opening Twisted Cafe on Friday, March 31, 2023.

I told LATAVONG that this was the second time that she had avoided us and that she needed to come to Twisted Cafe and meet with us immediately, or we would have to go looking for her, which would result in her arrest.

LATAVONG stated that she felt she was being treated unfairly, and refused to meet with us at Twisted Cafe, or tell us where she was, and instead agreed to meet us at District One. I asked her how long it would take her to get to D1, and she hung the phone up on me.

Agent SCHNERING stated that she would like to make a compliance inspection of the Twisted Cafe on Friday March 31, 2023, based on LATAVONG's statement that she would open on that date.

2. You must appear in person and testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)
3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are present at the committee hearing and willing to testify).
4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.
5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)
6. You may then provide testimony.
  - a. Include only information relating to the above license application.
  - b. Include only information you have personally witnessed or seen.
  - c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.
  - d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.
7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.
