
The City of Milwaukee is in receipt of your claim for vehicle damages in the amount of \$2,653.39, allegedly resulting when your parked car was struck by a City of Milwaukee garbage truck on December 20, 2022.


Our investigation into this matter revealed that the City's Sanitation Division was engaged in garbage pick-up at 1633 North Arlington Place on December 20, 2022, however, the City's driver has indicated that he did not make contact with your car. The driver's supervisor viewed your damages and does not believe they are consistent with being struck by the City truck. In addition, he viewed video from your building's maintenance worker, and it did not confirm your car being hit by the City truck.

There is no evidence that the City is responsible for your vehicle damages in this case. As such, we cannot accept liability and we are denying your claim.

If you wish to appeal this decision, you may do so by sending a written statement requesting a hearing within 21 days of the postmarked date of this letter to the Milwaukee City Clerk, 200 East Wells Street, Room 205, Milwaukee, Wisconsin 53202. Please include a photocopy of this letter's envelope, showing the postmark, and retain the original in the event further proof is needed.
