MVP was open years ago and the previous owners had an age limit of 31 to enter. The new owners don't care as long as they get business.

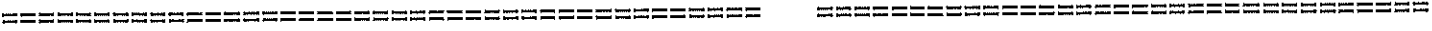

4. On 08/06/2020 officers, on routine patrol, observed a large group of people outside of Court MVP Sports Bar, arguing. As the officers approached on foot they heard 6 gunshots and observed people running. No one stopped to talk with the officers and no damage was found. The officers located 6 shell casings on the sidewalk by the corner of the tavern. The officers spoke with the applicant, who stated there was no fight inside and he did not think the shots were related to his patrons. He has cameras but could not access them at this time.



5. On 05/29/21 at 10:17pm, Milwaukee Police were dispatched to 5700 W. Fond Du Lac Avenue for a shots fired complaint. Investigation revealed that a subject who was not allowed into the tavern went to his vehicle, retrieved a handgun, and fired multiple shots into the air. the surveillance system, which might have captured the incident, was not functioning properly and the employees and applicant were cooperative with the investigation.

This License Premise Report is written by P.O. Daryal GOSS, assigned to District 7, Late Power Shift.

On Saturday May 29th, 2021, I was assigned to Squad 7469 with P.O. Tiara SHEETS WALKER. We were wearing a full Milwaukee Police Officer Uniform which included our department issued badges and body worn cameras.

At approximately 10:17pm we were dispatched to the address of 5700 W. Fond Du Lac Ave which is located in the City and County of Milwaukee, WI for a Shots Fired complaint. (It should be noted that this location is the Court MVP Bar and Grill, which is a licensed City of Milwaukee establishment).

Brief description of incident

Upon arrival I spoke with a security officer who stated that their was a male subject who was denied entry into the establishment prior to our arrival. The security officer stated that the male subject after being denied entry, returned to his vehicle and fired multiple shots into the air in front of the establishment and then fled the scene. The security officer identified himself verbally as Romaine JACKSON (B/M, 12/08/96). It should be noted that JACKSON was an armed security officer and stated that he worked for a private security company. JACKSON did have a valid State of Wisconsin Concealed and Carry Permit (License #386043). JACKSON was cooperative and did provide a description of the suspect and the suspect vehicle.

I later spoke with the single 911 caller of this incident. The caller stated that she was driving Eastbound on W. Fond Du lac Ave when she observed 2 people kicking another person who was on the ground. The caller was unable to describe the individuals involved. The caller stated that it appeared that these three individuals were physically fighting in front of the Court MVP Bar and Grill. The caller did not see nor hear see any shots fired.

Contact with Employees

Bartenders

1. Contact was made with a male subject employee who was identified verbally as Yuhl PATTERSON (B/M, 02/02/93). PATTERSON stated that he was the acting "Manager" of the establishment at the current time. When asked questions about how to get into contact with the owner PATTERSON stated that he was unable to get into contact with the owner directly and that his manager was En route to the

location to speak with us. The manager later arrived on-scene and asked PATTERSON to turn the music off in which he complied. The manager stated that he asked PATTERSON to do this so he could hear clearly while speaking with me.

Yuhl PATTERSON did have a Class D Bartenders License, Bart #0228341, EFF Date 01/01/2019 Exp Date 12/31/2020 ***Expired***. This license was posted on the wall behind the bar.

2. Contact was made with a female subject who was behind the bar who identified herself verbally as Ilesha U. ASHFORD (B/F, 06/05/89). ASHFORD stated that she was bartending during the incident and did not see nor hear anything due to the loud music. ASHFORD was cooperative and provided a copy of her license upon request.

ASHFORD did have a Class D Bartenders License #0235093, EFF Date 01/01/21 Exp Date 12/31/21. ASHFORD's license was not posted on the wall however she did have it on her person and was able to provide it without issue.

3. Contact was made with a second female subject who was behind the bar who identified herself verbally as Asia S. MOUTRY-DIXON (B/F, 08/03/96). DIXON also stated that she was bartending at the time of the incident and did not hear nor see anything due to loud music. DIXON was cooperative. When asked for her bartenders license she stated that her license was in the mail. Since DIXON was bartending under the supervision of ASHFORD who is a licensed bartender she did not need to have a license.

Manager

I also spoke with manager of the location who identified himself verbally as Thomas J. MCNEAL (B/M, 03/07/57). MCNEAL who was not present during the incident stated that he would pass along all information regarding the incident to the owner and would have him contact me as soon as possible. MCNEAL was able to provide me with the owners phone number. MCNEAL was very cooperative and stated that he was willing to help with the investigation in any way possible. MCNEAL stated that the camera system in which they had installed did not record the incident due to DVR issues.

MCNEAL did have a Class B Managers License EFF Date 07/01/20 Exp Date 06/30/21

Owner

I spoke with Otis D. MOORE (B/M, 02/26/78) on Sunday May 30th, 2021 at approximately 7:50pm via telephone. MOORE stated that he was aware of the incident and had received the PV-17 and community contact card from MCNEAL. MOORE stated that he was aware of the DVR issues and had placed an order for a replacement. MOORE stated that he was pro police and was willing to work with law enforcement to help keep his establishment and surrounding area safe. MOORE stated that if there were any issues with his bar that officers could call his personal number at any time and he would answer. MOORE stated that officers were welcome to walk into his establishment at any time as well to show presence and that he would appreciate more patrol if possible. MOORE was cooperative.

The hearing before the Licenses Committee will take place virtually on 4/26/2022 at 11:20 AM. This is a public hearing. Those wishing to view the proceeding are able to do so via the City Channel – Channel 25 on Spectrum Cable – or on the Internet at <http://city.milwaukee.gov/citychannel>. Those wishing to provide oral testimony will be asked to do so by phone or internet and are asked to contact the staff assistant, Yadira Melendez at (414) 286-2775 or stasst5@milwaukee.gov for necessary information. Please make such requests no later than one business day prior to the start of the meeting. You are not required to attend the hearing, but please see the information below if you would like to provide testimony. Once the Licenses Committee makes its recommendation, this recommendation is forwarded to the full Common Council for approval at its next regularly scheduled hearing.

Important details for those wishing to provide information for the Licenses Committee to consider when making its recommendation:

1. The license application is scheduled to be heard at the above time. Due to other hearings running longer than scheduled, you may have to wait some time to provide your testimony.
2. You must testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)
3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are willing to testify).
4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.
5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)
6. You may then provide testimony.
 - a. Include only information relating to the above license application.
 - b. Include only information you have personally witnessed or seen.
 - c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.
 - d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.
7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.
8. Business Competition is not a valid basis for denial or non-renewal of a license.

Please Note: If you have submitted an objection to the above application your objection cannot be considered by the committee unless you personally testify at the hearing.
