The Milwaukee Police Department's investigation regarding this application revealed the following:

1. On 03/18/16, applicant was cited for Building Code Violations at 2424 N Fratney Street.

- 2. On 06/26/16, Milwaukee police were dispatched to a 4th Degree Sexual Assault complaint at District #6 front desk. Investigation found the incident took place between 06/18/16 11:00 pm and 06/19/16 5:00 am at the Milwaukee Airport Inn at 1716 W Layton Avenue. The victim, who is an employee of the motel, stated a co-worker touched her body approximately 10 times during her shift at the front desk while she worked. The victim stated 5 out of 10 times the suspect intentionally and without consent, touched her vagina on the outside of her clothes. The owner of the motel, Prabhu Kasthurirangaian, cooperated with the investigation and made a copy of the security footage of the listed dates and information regarding the suspect. The case was no processed at the DA's office due to lack of evidence.
- 3. On 10/18/16 at 9:02 pm, Milwaukee police were dispatched to 1716 W Layton Avenue for an armed robbery complaint. Officers spoke with an employee of the motel who stated an unknown male subject handed her a note and demanded money from the cash register and

implied he had a weapon. The owner, Prabhu Kasthurirangaian, was notified of the robbery. Police were able to view surveillance of the incident.

- 4. On 08/30/19 at 10:52pm, Milwaukee Police were dispatched to 1716 W. Layton Avenue (Room 146) for a fight complaint. Officer's interviewed an injured citizen who stated that he did not get into a physical altercation but "fell" in the hallway. A person in a neighboring room stated that the injured subject was in a physical fight with two unknown actors. While interviewing the suspected victim, officers observed that the sliding glass door to room 146 had a large piece of plywood on it and had exposed glass facing the exterior of the room. The clerk at the hotel said the glass had been broken for about a month and does not know when it will be repaired. A check of the "calls for service" showed that multiple calls regarding the tenants in rooms 146 and 148 because they often "fight" each other.
- 5. On 09/22/19 at 11:26pm, Milwaukee Police were dispatched to 1716 W. Layton Avenue (Room 127) for a property damage complaint. Investigation revealed that an ex-boyfriend broke into room 127 through the patio window. The tenant in the room called the front desk who, in turn called the police. Police found the subject in room 146, told him he was not allowed at the hotel, and escorted him off the property. While police were still on scene, the subject returned to the location twice and was subsequently arrested. The manager worked well with officers and was able to provide them with information to help locate and identify the suspect.
- 6. On 10/18/19 at 8:30am, Milwaukee Police were dispatched to 1716 W. Layton Avenue for an armed robbery complaint. Investigation revealed that the alleged victim met a subject at the hotel for the purpose of prostitution. The manager was informed of the situation and he stated that he would not rent any more rooms to the subject.
- 7. On 10/18/19 at 11:27pm, Milwaukee Police conducted an underage alcohol procurement at the address of 1716 W. Layton Avenue. During the "sting" and underage Police Aide was able to buy a bottle of beer from the bartender inside the tavern at that location. The bartender, Chanhsamay BOUNKET was cited.

8. On 11/02/19 at 1:37am, Milwaukee Police were dispatched to 1716 W. Layton Avenue for a threat complaint. Upon arrival, officers interviewed the caller who stated that he was assaulted by two males who told him that he was stalking the bartender inside the tavern of the establishment. Officers interviewed the bartender who stated that the caller frequents the tavern while she is working and tonight, he was parked in his vehicle, with his high beams shining through the window, staring at her. The bartender says that she told other patrons inside the tavern that she does not feel comfortable when the caller is around but denies that she told the two males to confront the caller. The caller was told that he was not welcome at the tavern, so he checked into the hotel for the next two days.

- 9. On 03/18/20 at 08:26pm, Milwaukee Police conducted a license premise check at 1716 W. Layton Avenue to see if the tavern at the establishment was in compliance with Emergency Order #5 (inside Executive Order #72). Upon entering the tavern, officers observed two patrons sitting at the bar and one of the subjects had a drink. Officers informed the bartender that per the Governor, people were not allowed to be inside any establishment that serves food or drink. The bartender was under the impression that people could have a drink at the bar when they were waiting for their food. The officers went over Executive Order #72 (Emergency Order #5) and the bartender understood the order and made sure they are immediately followed by asking both patrons to leave. The bartender was extremely cooperative in the past and was again during this encounter. The bartender was given a copy of Emergency Order #5 and the premise check was ended.
- 10. On 06/25/20 at 9:01pm Milwaukee Police were dispatched to a reckless use of a weapon complaint at Travel Lodge, located at 1716 W. Layton Av. Investigation determined that the assignment was a sick/injured complaint, that occurred in the parking lot of the business. Officer spoke with victim who stated that she was leaning on her boyfriend's vehicle and lost her balance after the car was in motion. When the boyfriend left the location he unintentionally ran over her arm causing the victim pain. The victim was conveyed to St Luke's hospital for medical treatment. Officers spoke with the on duty manager at the hotel who stated that he just started his shift and did not see the incident. The manger was advised by the prior manger about the incident. The business was cooperative with the investigation.
- 11. On 07/20/20 at 12:12am Milwaukee Police were dispatched to a trouble with subject complaint at Travel Lodge, located at 1716 W. Layton Av. Upon arrival officers spoke with the caller, a juvenile who stated that the issue was resolved. The caller did state that he did not agree with the way he was treated by the security, because he said a racial slur. Officers spoke with the on duty manager who stated that the hotel resolved the issue with juvenile and his mother, and that security did not use a racial slur. The manager stated that he was going to allow both subjects to stay the night but then have both subjects leave in the morning.
- 12. On 07/21/20 at 1:58am Milwaukee Police were dispatched to a theft complaint at Travel Lodge located at, 1716 W. Layton Av. The caller stated that an unknown female that he has invited to his room on serval occasions stole his phone and disappeared. The caller could not give officers any relevant information on the female. Officers spoke with the front desk employee who stated that the caller has been inviting the female over most of his 30 day stay at the hotel. The employee believes that the caller has been doing drugs in his room, and that he will be evicted after today's events. Officers were not allowed in the room by the caller. The business was cooperative with officers regarding the investigation.
- 13. On 08/27/20 at 5:56pm Milwaukee Police were dispatched to an injured/sick complaint at Travel Lodge, located at 1716 W. Layton Av. Officers met bell #445 with the caller in room #232 regarding. The caller stated that he was intoxicated and feeling depressed. The caller stated that he wanted to go to the hospital. The caller was conveyed by bell ambulance and police services were not needed.

- 14. On 09/08/20 at 1:00pm community officers from District 6 conducted a Safety and Security meeting at Travel Lodge, located at 1716 W. Layton Av. The officers were met by two mangers of the business that did a walkthrough of the location. Discussed at the meeting were the hours of the onsite restaurant, the amount of security cameras, and the use of private security. Concerns covered were the amount of sick/ injured calls regarding over dose complaints. The management stated that any information regarding drug or prostitute use would get a renter band from the hotel. The renter would be placed on a do not rent list. Management told officers the hotel policy is to check ids, and vehicles associated with the renter. Officers were showed the current renter form with the required information. The management expressed that a main issue has been from long term stay renters. To help resolve those issues the hotel has only rented rooms on a day to day basis. Officers observed that some of the connecting buildings of the hotel are still under construction. This concluded the meeting.
- 15. On 10/09/20 at 3:24pm community officers from District 6 conducted a meeting at Travel Lodge, located at 1716 W. Layton Av., regarding an incident that occurred on 10/07/20. Officers spoke with the onsite mangers regarding the indent in which drugs were located in the rented room. The mangers were then given a Notice of Public Nuisance Drug Letter, and explained the contents of the letter. Management explained that the subject related to the complaint appeared to be under the influence of a drug when using the in lobby ATM. The manger on duty that day then put the renter on the Do Not Rent List. The management then showed officers the computer with the renter's information. Next to the information there was the letters DNR, and a brief comment regarding. This allows staff to be aware if a customer is on the Do Not Rent List, and not to rent any rooms to said person.
- 16. On 12/01/20 at 9:15pm Milwaukee Police were dispatched to a fight complaint at Travel Lodge, located at 1716 W. Layton Av. Officers spoke to the front desk who stated that renters in room 103 have been arguing all day and staff could not make contact with the renters. Officers spoke with subjects, they were advised to keep the noise down or they would be asked to leave the location. The hotel staff was cooperative and no violations were observed.
- 17. On 12/11/20 at 8:08 pm Milwaukee Police were dispatched to a threat complaint at Travel Lodge, located at 1716 W. Layton Av. Officers spoke with the caller who stated that he wanted to turn himself in on his warrant. The subject did have a valid warrant, a search incident to arrest revealed that the subject had items that appeared to be narcotics. The items were tested positive for methamphetamine and fentanyl. The subject was conveyed to District #6 to be processed.
- 18. On 12/13/20 at 4:03pm Milwaukee Police were dispatched to a child neglect complaint at Travel Lodge, located at 1716 W. Layton Av. Officers spoke with the manger on scene who stated that a 6 year old child came to the front desk and stated that she got locked out of the room. The manger asked the child where are your parents the child replied that they were not there. The manger then called the police regarding. Investigation revealed that the child was left in the care of a 16 year old and that the parent now at the location did not neglect the child.

- 19. On 12/16/ 20 at approximately 9:51pm Milwaukee Police were dispatched to a battery complaint at Travel Lodge, located at 1716 W. Layton Av. Officers spoke with the caller who stated that she met the suspect through Facebook, and had been talking to him for a while. The suspect took the caller to the outside of location and wanted to pay her for intercourse. The victim refused to go to the room and the suspect became angry striking the suspect in her arm pushing her out of his vehicle. The suspect left the location with some items belonging to the victim. Officers spoke with the front desk and were able to obtain the suspects information. The victim had minor pain and injures from the incident. The victim was then was conveyed home and given officers information along with a PV-17 form.
- 20. On 01/04/21 at 8:45pm Milwaukee Police were dispatched to a sick/injured complaint at Travel Lodge, located at 1716 W. Layton Av. Officers located a subject lying on the floor of the lobby of the hotel. Investigation determined that the subject is staying in room # 116 and became intoxicated at the bar attached to the hotel. Officers located the subject's live in friend with same address and phone, in the room. The friend stated that he would care for the subject's wellbeing. The hotel staff was cooperative and no violations were observed.
- 21. On 01/12/21 at 9:01pm Milwaukee Police were dispatched to a trouble with subject complaint at Travel Lodge, located at 1716 W. Layton Av. The caller indicated that the subject was in room #106, causing a disturbance and stealing items. The subjects inside the room refused police services. The business was cooperative with the investigation, no violations were observed.
- 22. On 01/19/21 at 5:02pm community officers from District 6 conducted a meeting at Travel Lodge, located at 1716 W. Layton Av. Officers spoke with the manager, James Perry and conducted a walkthrough of the hotel. Officers observed multiple exit/entrance doors, which were not secured due to faulty door brackets on the first floor. Mr. Perry stated to officers that new door brackets were ordered and hoped to have the brackets installed within the week or so. Mr. Perry stated that the hotel does have security at the location Monday-Thursday 10pm-6am, and are looking for a coverage Friday-Sunday for the same time frame. The third building of the location is still currently being renovated and should be completed within approximately two weeks. The third building is intended to be used for extended stay customers. Officers discussed dispatched calls from 10/22/20 to 01/19/21. The dispatched calls were 48 calls for service with 28 of those calls being dispatched assignments. Mr. Perry stated to officers that the business tries to handle all matters in house before altering the police. Mr. Perry stated to officers that the business had had serval issues of domestic violence, and changed policy that both parties of the room have to leave the establishment. This policy is to deter a return of potential problems. Officers observed security cameras operational at the time of the meeting. Mr. Perry was advised, officers would have quarterly meetings with business and discuss any issues regarding.
- 23. On 01/20/21 at 5:50pm Milwaukee Police were dispatched to a threat complaint at Travel Lodge, located at 1716 W. Layton Av. Officers responded to room 107, and could not make contact with the complainant. There was no answer at the door or answer on multiple call backs to the caller. No Violations were observed by officers while they were on scene.
- 24. On 02/09/21 at 8:57pm Milwaukee Police were dispatched to Travel Lodge, located at 1716 W. Layton Av., for a Trouble with Subject. The caller stated they were in room #106 and an unknown subject was pounding on the door. On arrival no one was located in the hall near Room 106, and the occupants stated they did not call police. Management was notified and cooperative.

- 25.On 02/19/21 at 10:06pm, Milwaukee Police were dispatched to Travel Lodge, located at 1716 W. Layton Av., for a Welfare Check. The caller stated a friend of his that was staying at the hotel contacted him and was having a mental health crisis. On arrival police made contact with the subject, who was intoxicated and denied needing any assistance. The subject did not have any injuries and appeared to be in good health.
- 26. On 02/21/12, at 2:40pm Milwaukee Police were dispatched to Travel Lodge, located at 1716 W. Layton Av., for a Burglary Investigation. On arrival it was determined a suspect grabbed a key card from the neck of a housekeeper, entered the victim's room and stole items worth approximately \$3100. Management and employees were cooperative with the investigation.
- 27. On 03/03/21 at 5:23am, Milwaukee Police were dispatched to Travel Lodge, located at 1716 W. Layton Av., for a Sick and Injured Call. On arrival the caller declined any medical attention or police service and stated they had called for private transportation. The security officer at the hotel was cooperative and stated they would check on the guest periodically until the private transportation came.
- 28. On 03/04/21 at 8:26pm, Milwaukee Police were dispatched to Travel Lodge, located at 1716 W. Layton Av., for a Trouble with Subject in Room 218. On arrival officers did not hear any movement in the room, or signs of any guests in the room. Officers knocked several times; however, there was no answer at the door. The hotel clerk was notified and cooperative with police.
- 29. On 03/13/21 at 12:55am, Milwaukee Police were dispatched to Travel Lodge, located at 1716 W. Layton Av., for a Trouble with Subject. Investigation revealed there were two guests that were loitering on the property after checking out. The guests were gone on Police arrival. Management was cooperative with Police.
- 30. On 03/15/21 at 6:05pm, Milwaukee Police were dispatched to Travel Lodge, located at 1716 W. Layton Av., for a Missing Check. On arrival it was determined the missing was not at the hotel. Later in the day officers conducted follow up at the hotel and were able to locate the missing in a hotel room. Management cooperated with the investigation.
- 31. On 03/19/21 at 3:16am, Milwaukee Police were dispatched to Travel Lodge, located at 1716 W. Layton Av., for a Battery complaint. Officers were advised there was an individual bleeding from the nose, kicking the door to a room and blood all over the hallway. The employee stated the individual was yelling and threatening guests, causing them to fear for their safety. The individual was located and arrested.
- 32. On 03/19/21 at 5:12am, Milwaukee Police were dispatched to Travel Lodge, located at 1716 W. Layton Av., for a Battery complaint. The employee/caller stated a known suspect came to the location and cut both rear tires of her vehicle two days ago, and again on 03/19/21. Investigation revealed the employees' statements were contradictory to the previous report filed and the video surveillance. She was provided with information on a restraining order.

- 33. On 03/23/21 at 11:16pm, Milwaukee Police were dispatched to Travel Lodge, located at 1716 W. Layton Av., for a Trouble with Subject. On arrival the caller stated the subject left and police were no longer needed.
- 34.On 03/28/21 at 1:53pm, Milwaukee Police were dispatched to Travel Lodge, located at 1716 W. Layton Av., for a Dead on Entry. Officers were met by MFD and investigation did not indicate any foul play was involved. It was determined this was a probable drug overdose.
- 35. On 03/28/21 at 8:43pm, Milwaukee Police were dispatched to Travel Lodge, located at 1716 W. Layton Av., for a Threat complaint. On arrival officers were advised by the manager they wanted a hotel guest removed from the premise due to being loud and using profanities. The guest was located and removed from the establishment.
- 36. On 04/19/21 at 8:12pm, Milwaukee Police were dispatched to Travel Lodge, located at 1716 W. Layton Av., for a threat complaint. Officer spoke with on duty manager who refused to give two ex-employees their paychecks. The manger stated that the ex-employees were terminated for stealing from the business. The ex-employees were informed that the incident was a civil matter. The two ex-employees agreed to leave the location after being advised.
- 37. On 04/20/21 at 12:06am, Milwaukee Police were dispatched to Travel Lodge, located at 1716 W. Layton Av., for a threat complaint. Officers spoke with the manger on duty who stated that a subject was in the lobby screaming. Prior to officers arrival the manger can be heard on a recorded 911 line making threats to the subject. The manager was uncooperative with officers initially refusing to provide pertain information. The manger did provide her information and was informed that she could be cited for disorderly conduct do to the threats she made to the subject on a recorded 911 line. The subject was not on scene upon police arrival.

INITIAL INVESTIGATION

This report is written by P.O. Joshua YANG, assigned to District Six, Late Power Shift. On Thursday, June 25, 2020, I was assigned to Squad 6468 with P.O. Joel BUNKELMAN. P.O. BUNKELMAN and I were operating a marked black and white Milwaukee Police Department squad car, equipped with red/blue emergency lights and audible siren. P.O. BUNKELMAN and I were in full MPD uniform, with badges and nameplates affixed to our outermost garments. P.O. BUNKELMAN and I were equipped with body worn cameras, which were activated and captured this incident.

At approximately 9:01 pm, P.O. BUNKELMAN and I were dispatched to a reckless use of weapon complaint at 1716 W. Layton Ave. (Travelodge Hotel, *License# 0000560*), located in the City and County of Milwaukee. It was later determined that this incident is a sick/injured.

Upon arrival, P.O. BUNKELMAN spoke with the injured female subject and I spoke with the caller, who was later identified as *Damian S. SCHMIDT (W/M, 8/21/90)*. SCHMIDT stated that the female, later identified as *Brettnie J. MIERKEY (W/F, 11/19/85)*, is his close friend. SCHMIDT stated he is currently homeless and is temporarily staying at the hotel. SCHMIDT stated MIERKEY came over to the hotel so they could hang out and he was going to buy her something to eat. SCHMIDT stated that MIERKEY's exboyfriend came over to the hotel and was in a 2017 Hyundai four door, unknown color. SCHMIDT stated he knows MIERKEY's boyfriend as a Brian ROSS, black male, approximately 42 years old and was last seen wearing a neon green t-shirt and black pants. BUNKELMAN and I later spoke with MIERKEY who stated she is not intoxicated or under the influence of any narcotics. MIERKEY stated that she was leaning up against ROSS's vehicle and when he put the vehicle into reverse, she lost her balance due to her sandals and because she was not expecting the vehicle to be in motion. MIERKEY stated she believes she fell onto her right side of her body and ROSS's drove the vehicle over her right arm. MIERKEY stated she was upset about the situation and was in pain but stated she does not believe ROSS intentionally drove over her arm. On Tuesday, September 8, 2020 at approximately 1:00 pm, we conducted at Safety and Security meeting at 1716 W. Layton Ave. (Travelodge), located in the City and County of Milwaukee.

Upon arrival, we met with Mangers, Pabina KHADGI and James R. Perry, to discuss the Calls for Service at the location and conduct a walk-through of the property.

The scene is described as a hotel property with a restaurant (MAI) located on the west end attached to the hotel. Parking is located on the north, south, east, and west end of the property. The property consist of three building, with each building containing approximately 32 units for occupation. All buildings are attached to one another with adjoining interior hallways.

The Front Lobby is located on the south east side of the building with the main entrance facing south. The hotel has 5 other exterior public entrance and exit points labeled A-E. All public and exit points are accessed with key cards. All doors were secured at the time of walk-through. The hotel has an additional 5 doors along the exterior of the buildings labeled Emergency Exit and for Laundry use.

The hours of the restaurant (MAI) varies from night to night depending on customer volume. Currently the restaurant is open from 7 am to 9 pm.

KHADGI advised us that the hotel has approximately 6 exterior cameras and 21 Interior Cameras. Entrance and Exit points A, B, C are included in coverage. D and E are under construction and will have coverage in the future. The cameras store footage for approximately 3 weeks. KHADGI and PERRY have access to security footage.

The restaurant (MAI) has an additional 9 cameras in the interior and 3 cameras located on the exterior, we requested to observe the system and was advised the computer was not working and only can be accessed through the restaurant's manager's phone. We were also advised the exterior cameras are not working at this time.

KHADGI was advised that one of our main concern with the hotel was the amount of Injured/Sick complaints and confirmed Overdose complaints. KHADGI stated any information regarding drug use or prostitution would get a renter added to the DO Not Rent list. KHADGI showed us an extensive list of people who are on that list. KHADGI stated their policy is check ID's for all customers renting from them and take down vehicle information. KHADGI showed us a copy of their current check in form with required information.

KHADGI stated that staff will also advise management of observation of what they see regarding customers and will add them to the Do Not List when needed. KHADGI stated housekeeping keeps management advised of what is located in rooms and conditions customers leave them.

KHADGI stated they have security onsite 7 days a week. Security starts at 10 pm and work until 6 am. Security conducts a perimeter check approximately every 45 minutes. KHADGI stated that security is hired in house and not through a private company.

KHADGI stated Long Term Stay usually cause their biggest issues. KHADGI stated this is why they are cancelling Long Term Stay and renting rooms on a day by day basis. KHADGI stated they are currently renovating the rooms where Long Term stays were placed. We observed the ongoing construction of the north building.

We did not observe lighting at the property due to the time the check was conducted.

The parking lot was clean and the construction debris located in the rear of the north building we previously observed, was picked up and placed in the dumpster.

KHADGI was informed this report would be written and filed.

On Monday, February 22, 2021 my partner (P.O. HEEG) and I were dispatched to the Travel Lodge Hotel (1716 W Layton Ave) room 116 for a Burglary complaint.

When we arrived on scene I spoke with the victim, Darnell L. MILLER (b/m 02/28/80). MILLER stated that he rented the hotel room for the nights of 02/20/21 and 02/21/21. MILLER stated he lives in Milwaukee but often rents a hotel room for the weekend in order to "get away from all the bullshit." MILLER stated that he rented the room in his name but had a friend with him. MILLER only knows this person as "EL." MILLER did not know his address or phone number. EL was given a key to the rented room.

INTERVIEW WITH VICTIM

MILLER stated that on 02/21/21 at 2:59 p.m. he received a call from the front desk who told him that someone had broken into his room. MILLER stated that he was visiting his grandmother and was unable to leave to go back to the hotel. MILLER stated he did call police but was told that he had to call back when he was at the location. MILLER stated that he came to the hotel today, 02/22/21 to check out and report the incident to police.

After reviewing the camera footage of the incident, MILLER stated he has seen the suspect "hanging around the hotel" in the past but did not know who she was. After more aggressive interviewing techniques, MILLER stated that he knows the suspect is a prostitute known as "Mo:" MILLER's friend EL had been with her in the room earlier while MILLER was out. MILLER stated that he doesn't know how to get in contact with her but she can be found hanging out on W. National Ave. in Milwaukee.

MILLER stated that approximately \$3100 worth of clothing, jewelry, and electronics were taken.

INTERVIEW WITH WITNESSES

While on scene, Yvette PLACENSIA (w/f 09/03/92) and Maria MERCADO (02/02/66) arrived for work and agreed to talk to me. MERCADO and PLACENSIA are employed as housekeeping for the hotel. On 02/21/21 they were working together in the room next to 116. They were approached by a black female who insisted she had left her belongings in room 116. At first, MERCADO told the female that she could not open the door for her but the female insisted so they followed her over to room 116. While standing outside room 116, MERCADO insisted she could not open the door for the female. The female then reached over, grabbing the key card hanging from MERCADO's neck and quickly unlocking the door with it. MERCADO and PLACENSIA stated that the female reached into the room and quickly scooped up several pairs of shoes and clothes into a bag. She then rushed out of the hotel and entered a small four door grey car as the passenger and drove away.
